**E. New Business**

1. Requesting two board members to step down to review two complaints alleging violations of RCSA Sec. 22a-133v-6 (c) professional competence and (d) professional conduct.
  - a. Ground water quality samples may have been altered and submitted to DEEP.
  - b. Data relating to consumptive water diversion general permit may have been altered and submitted to DEEP.
2. 9 CECs possible (offering 23.5) requested for conference titled, “2024 South Atlantic Jubilee” to be held by the South Atlantic Well Drillers in Myrtle Beach, SC from July 27-29, 2024.
3. Conversion of CTLEP–522 a 2 CECs webinar to a distance learning on-demand course titled, “Perimeter Air Monitoring Webinar” originally approved by the board on March 11, 2021. This conversion is being requested by Pacelabs that acquired Alpha Analytical. Alpha Analytical was approved for distance learning on-demand courses on July 14, 2022.
