# **Regular Meeting – September 8, 2022**

## A. <u>Call to Order and Sign-In</u>

A regular meeting of the State Board of Examiners of Environmental Professionals ("the Board") was called to order on Thursday, September 8, 2022 at 9:30 via a Zoom conference call, by Acting Chair and Board Administrator Liz McAuliffe. Board members J. Adams, M. Gamache, L. Muratore, R. Dirienzo, D. Fiereck, D. Wolfram and C. Violette were present via Zoom. Selena Thornhill-Moody from DEEP, Lori Dibella representing the Attorney General's Office, and Nelson Walter representing EPOC were also present on the Zoom call for the meeting.
