PERMIT OVERVIEW

Why we are here:

- To continue the property's cleanup progress and
- Set a path for redevelopment of the property

Why is a Stewardship Permit Required?

- Regulatory basis:
 - Federal and state laws require that this type of facility has an enforceable cleanup schedule in place to advance site cleanup and ensure remedies remain effective into the future.

PERMIT OVERVIEW

What is a Stewardship Permit?

- Cleanups at some sites require long-term monitoring and care to ensure that the remedy remains protective of human health and the environment.
- There is a need to keep our promise to the future by having a transparent process that tracks those obligations.
- A Stewardship Permit issued by the State of Connecticut is an enforceable mechanism to help keep that promise






FACILITY HISTORY - LANDFILL

- Landfill Operated from 1940s to ~ 1982 for Disposal of Municipal ~ 500,000 CYs of Solid Waste (MSW)
- Metal Hydroxide Waste Cell Operated from 1977 to 1982 ~ 4,350 CYs of Sludge
- •MSW Landfill Closed in ~ 1981 Two-Foot Thick Earthen Cap
- •Hydroxide Cell Closure in 1996 Geomembrane Cap
- Transfer Station Operated on Former MSW Landfill Two 10,000 gal double-walled USTs (gasoline and diesel)

TIMELINE OF INVESTIGATIONS

- Closure/Post Closure Investigations GZA 1980s
- Comprehensive Groundwater Monitoring Plan Marin Environmental – 1992
- Groundwater Impact Evaluation and Water Supply Alternatives Analysis – F&O 2006
- Initial DEP Stewardship Signed July 2010
- Quarterly Groundwater Monitoring ACT , 2005 to Present

ENVIRONMENTAL CONCERNS



WATERTOWN LANDFIL

MONITORING PROGRAM

- > 20 Years of Groundwater Monitoring From Extensive Well Network
- Sampling of up to 25 Monitoring Wells and 5 Surface Water Locations - ACT
- Sampling of 16 Domestic Wells, Includes 12 Wells with Treatment Systems - ACT
- Prepare Quarterly Monitoring Reports and Detailed Annual Summary Report – ACT
- Zone of Influence of Groundwater Plume Extends from Landfill Southward Towards Lake Winnemaug – Leachate Constituents (Iron, Mn, chloride, sodium etc.)

ACTIONS REQUIRED IN STEWARDSHIP PERMIT

- Continue Quarterly Groundwater Sampling and Reporting 2021 Monitoring Plan
- Monitor and Maintain Domestic Well Treatment Systems
- •Follow Revised 2021 Post-Closure Plan for Inspection and Maintenance of Landfill Cover
- Prepare and Implement PFAS Groundwater Monitoring Plan for Initial Assessment – 90 days for Plan, 365 days to Complete
- Update Cost Estimates for Monitoring and Maintenance 90 days
- Update and Maintain Financial Assurance 150 days
- Prepare Revised Quality Assurance Project Plan (QAPP) 270 days

SUMMARY OF STEWARDSHIP PERMITS

Ensures public participation in ongoing maintenance and monitoring

Documents the completion of cleanup

Memorializes phases of completed remediation

Addresses financial assurance obligations

Spells out long-term obligations of permit holder

STEWARDSHIP PERMIT PUBLIC COMMENT PERIOD

Opportunity to Comment on Draft Permit

- August 8, 2024 Draft permit available for public review
 - Notice of tentative determination to issue a permit renewal was published, beginning the Public Comment period
 - Information published in Waterbury Republican-American
 - Radio announcements on WATR 1320 AM
- September 10, 2024 Public Informational Meeting held in virtual format
- September 22, 2024 End of Public Comment period
- Next: CT DEEP will review comments, consider if changes are needed, then issue final decision
