I. Call to Order and Announcements

Meeting started at 9:00am.

Co-chairs Katie Dykes, DEEP Commissioner and Ronald McDaniel, Mayor of Montville provided welcoming remarks, introductions, housekeeping rules and an overview of the Food Scraps / Organics Collection & Diversion Working Group as part of the CCSMM initiative process. Responses to the Public Engagement Questions- Request for Comment and Solutions located on the CCSMM webpage were encouraged.

II. Committee Reports

Ashley Muspratt, Center for EcoTechnology presented on the Technical assistance resources and success of CET programs and provided an overview of "why"/ benefits diverting organics from the waste stream is beneficial; additionally the CT municipal solid waste composition was discussed

Bob Spencer, Director, of the VT Windham Solid Waste Management District presented about the success, challenges and opportunities of the VT Organics Diversion Program/ law.

Brian Paganini, Vice President, Quantum Biopower provided an overview of how Anaerobic Digestion works and the products created through the process.

Samuel King, President, Blue Earth Compost discussed how Blue Earth Compost collects residential food scraps and presented an overview of Curbside collection in CT and a variety of organics collection systems and provided an evaluation of the systems and an overview of organics collection trends.

Debra Darby, Manager, Tetra Tech presented on Co-collection programs and discussed compostable bags.

III. Roundtable

There was opportunity for Q&A of the panelists. Working group members asked about technical assistance from CET and asked about the logistics and scope of the Vermont program. Discussion of the costs, environmental impacts and products from the AD process also occurred. Comments to Sam King included which of the collection systems might work in CT and further discussion of the residential

processes Blue Earth Compost is able to capture. Discussion of compostable bags and contamination occurred in the "chat" function of the zoom meeting.

Other discussion included next steps, including upcoming meeting dates and a reiterated request for members of the working group and the public to submit comments and solutions via the CCSMM webpage

IV. Public Comment

Members of the public were asked to use the "chat" feature or the "raise hand" feature to indicate if they wanted to make a comment.

Public comments included questions and comments on school composting and share tables for excess food, questions and food donation and liability, and costs associated with Anerobic digestion. Additional topics of discussion during the public comment section of this meeting included co-collection, compostable bags and contamination. Ag-grid was introduced as an additional option for food waste.
