I. Call to Order and Announcements

Meeting began at 1:03 pm.

Katie Dykes, DEEP Commissioner, provided welcoming remarks and an overview of the CCSMM initiative process to date. Commissioner Dykes also introduced CCSMM working group chairs Denise Rapp, Litchfield's First Selectperson, Ben Florsheim, Middletown's Mayor, and Matt Knickerbocker, Wilton's Town Administrator.

Chris Nelson, Supervising Environmental Analyst, CT DEEP, provided housekeeping rules.

II. Committee Reports

James Albis, Office Director, CT DEEP, presented an update on the following topics while responding to attendees' questions:

- Draft 2023 Comprehensive Materials Management Strategy (CMMS) amendment and Connecticut's waste disposal capacity landscape. The document is available on DEEP's webpage for public review, and written comments can be filed via email at DEEP.MMCAPlanning@ct.gov no later than 5:00 pm on March 10, 2023.
- Sustainable Materials Management Regional Waste Authority (RWA) Grant Program Opportunity
 for CT municipalities and regions. DEEP is inviting grant proposals seeking funds to help
 municipalities and regional waste authorities to form new or expand existing RWAs. Proposals
 must be submitted to <u>DEEP.MMCAPlanning@ct.gov</u> by March 31, 2023, at 5:00 pm.
- Materials Management Infrastructure Request for Information (RFI) goals and important dates and deadlines for interested stakeholders, municipalities, council of governments, solid waste management industry representatives, facility developers, and others to submit written comments regarding the opportunities and needs associated with waste infrastructure development to help address Connecticut's solid waste management challenges.
- Overview of Governor's Bill HB 6664 An Act Managing Waste and Creating a Waste Authority.
 Director Albis clarified some provisions of the bill, how the act would work, and how municipalities wouldn't lose control of their recycling operations. Additionally, he addressed some misleading information presented during the legislative session concerning the Extended Producer

- Responsibility (EPR) for packaging programs, municipal recycling operations control, multinational producers, and Connecticut's recycling infrastructure.
- Relevant legislation being discussed in the Environment Committee during the legislative session was also discussed.

Co-chair Denise Raap introduced Coryanne Mansell, Client Services Strategist, Center for Ecotechnology (CET), provided an update on Connecticut's Business Recycling Assistance Program.

Co-chair Ben Florsheim introduced Jennifer Weymouth, Environmental Analyst, CT DEEP, to provide an update on the Sustainable Materials Management (SSM) grant programs. Weymouth gave a high-level overview of the current programs and successful remarks.

A panel composed of the following municipal representatives presented their SMM grant programs updates:

Kim O'Rourke, Middletown's Recycling Coordinator: Middletown Food Scrap to Clean Energy Pilot Program.

Jill Senior, Stonington's Director of Solid Waste: Stonington Curbside Food Scrap Collection Pilot Program.

Angus MacDonald, Deep River's First Selectman, shared some remarks regarding Deep River's Transfer Station Waste Reduction Pilot Program via chat.

Co-chair Knickerbocker called the following participants in the call to provide municipal and regional updates:

Tammy Thornton, Wilton Go Green President, provided a quick update on a few events happening with Wilton Go Green.

Pam Roach, South Central Regional Council of Governments (SCRCOG), Consultant, provided an update on the upcoming Repair Café event in Cheshire, School Food Scrap Collection Programs, and an update on West Haven's food scrap program and educational outreach.

III. Roundtable

Attendees were interested to learn about the Regional Waste Authority proposal HB 6664, the solid waste assessment fee, economic implications for municipalities associated with the inclusion of EPR in the bill, the export solid waste assessment fee in the bill, and DEEP's plan to divert waste not transported out of the state.

Co-chair Matt Knickerbocker shared with municipal leaders that DEEP's webpage has studies regarding EPR for packaging applications and refutes some misinformation disseminated during the legislative session regarding EPR.

The discussion then focused on EPR for packaging and the HB 6664 opt-in-opt-out mechanism offered for municipalities. Commissioner Dykes discussed the savings benefits for municipalities that the opt-in for packaging EPR program allows and how it will offset the increase in the Solid Waste Assessment fee in the bill. Further, she discussed the Solid Waste Assessments fund and how the Agency would allocate it to increase waste diversion in the State.

When discussing the packaging EPR program and the Solid Waste Assessment fund, attendees noted that the potential benefits of the EPR program go beyond municipalities to the infrastructure of material management at the local level. The group continued discussing where the revenue from the EPR program would go and where the assessment fee would get levied.

Gabrielle Frigon, Director of Waste Engineering and Enforcement Division/Bureau of Materials Management and Compliance Assurance, CT DEEP, provided a permitting clarification regarding chemical recycling.

Members pointed out concerns with the timeline to implement infrastructure to handle municipal solid waste in the State and its associated costs. Additionally, questions regarding regional solutions for waste management in the State and United-Based-Pricing programs (UBP) were asked.

Ms. Coryanne Mansell, Client Services Strategist (CET), responded to questions regarding CET programs and outreach efforts to reach out to the Regional Chamber of Commerce.

Jennifer Weymouth responded to questions regarding West Haven's Food Scraps Co-Collection program and feedback from town residents.

IV. Public Comment

Members of the public were asked to use the "chat" or "raise hand" feature to indicate if they wanted to make a comment.

Jean Speck, First Selectman, Town of Kent, shared that Kent is launching a food scrap program soon.

Mary Hogue, Sustainable Fairfield, shared about Fairfield's Food Rescue Team and is seeking advice regarding liability protection. Ms. Hogue also addressed chemical recycling concerns in the Governor's bill.

Lynne Bonnett, a New Haven resident, asked the group for updates on sustainability actions happening at the municipal level in New Haven while sharing her frustration with the city.

Julie DesChamps, Waste Free Greenwich, recommended other municipalities to work with CET.

Lori Martin, Executive Director Haven's Harvest, commented on the organization's work in New Haven and asked interested participants in food recovery to contact her.

V. Adjournment

The meeting closed with thanks from Co-Chairs Denise Raap and Matt Knickerbocker.
