#### I. Call to Order and Announcements

Meeting began at 1:00pm.

Co-chairs Laura Francis, First Selectman, Town of Durham and Ben Florsheim, Mayor, City of Middletown provided welcoming remarks, introductions, housekeeping rules and an overview of the Increase Recycling Working Group as part of the CCSMM initiative process.

#### **II.** Committee Reports

The co-chairs provided an update and overview of topics discussed at the mid-point full CCSMM meeting on November 16, 2020.

A panel composed of the following representatives presented on opportunities to increase recycling and reuse efforts:

Miriam Gordon, Policy Director, UPSTREAM presented on UPSTREAM's Government Reuse Forum

Jonathan Black, Senior Policy Advisor, Senator Udall's Office presented on the Break Free from Plastic Pollution Act

Gabrielle Frigon, Assistant Director, Waste Engineering and Enforcement Division presented on the Municipal Transfer Station General Permit

#### III. Roundtable

There was opportunity for Q&A of the panelists. Members were interested in redesign options for common products, restaurant accessories and reuse options available for takeout. PFAS considerations were also noted. Other questions involved the effectiveness of policies on plastic pollution thus far, extended producer responsibility for plastics as well as how municipalities can support the federal Break Free from Plastic Pollution Act. Other discussion included opportunities for increased processing for recycling and markets for plastic materials.

Following the presentation on the Municipal Transfer Station General Permit, members discussed regional and shared facility options, materials accepted under the permit, inspections, permit requirements

and location options for satellite sites. Members also asked about food waste processing options for municipalities.

Other discussion included next steps, including upcoming meeting dates, an overview of the intent of the menu of options and a reiteration of a request for members to submit additional recycling and reuse topics to be included in the final report.

#### **IV.** Public Comment

Krishna Winston, Middletown asked about recovering from the COVID-related proliferation of disposable PPE and medical devices as well as how often inspections of Municipal Transfer Stations occur and what's likely to result in a Notice of Violation.
