Presenter Bios

Robert L. Moylan, Jr., was the Commissioner of the Department of Public Works and Parks for the City of Worcester Massachusetts for twenty-two years and retired in 2014. As Commissioner, he was responsible for Worcester's water, sewer and street systems, traffic signals, parking lots and garages, solid waste collection and disposal, fleet maintenance, street lighting, municipal engineering, parks, recreation and cemetery, and all vertical public construction including public schools, fire stations and parking garages. He has held a wide variety of technical and managerial positions with the Department during his forty-two year career. Mr. Moylan was recently appointed by Governor Baker to the Massachusetts DOT Board of Directors, which oversees all transportation related issues including highways, mass transit, aeronautics and registry of motor vehicles. Mr. Moylan is now a consultant to both industry and government in matters involving public works.

Presenter Bios

Kristen Brown is a recognized national expert on solid waste reduction and recycling incentive programs and leads WasteZero's strategic partnership activities. She has three decades of experience working for manufacturers of recycled packaging in both the United States and Europe. Previously, Brown was a residential solid waste reduction consultant under contract with the U.S. Environmental Protection Agency, where she led the American Big Cities SMART campaign and designed the EPA SMART Benefit Evaluation Tool. Previously, Brown served as Vice President of Municipal Market Development at Waste Zero, with responsibility for municipal partnerships across the U.S., focusing on Massachusetts. She has served as consultant to other state and municipal governments and in 2009, the South Carolina Governor appointed Brown to that state's Recycling Market Development Advisory Council. A holder of two U.S. patents, Brown has authored many trade journal articles based on her research into the critical link between financial incentives and sustainable recycling behavior change.
