

Update: EPA Solvent-Contaminated Wipes Rule



- EPA Final Rule issued July 31, 2013.
- Provides reduced requirements for:
 - Wipes that are sent for laundering & reuse.
 - Wipes that are sent for disposal.
- As a less-stringent rule, it is not yet in effect in Connecticut.

EPA Solvent-Contaminated Wipes Rule

- DEEP needs to evaluate the rule.
- Provisions in DEEP's Industrial Rag Handling fact sheet remain in place for now (copy on DEEP website).
