


ReCommunity

- ReCommunity is singularly focused on viewing waste streams as valuable convertible resource assets that represent profitable revenue streams
 - Focus includes recovered commodities, low carbon energy, bio-fuels, engineered feedstock (for energy recovery and hydrocarbon fuel substitution), value-added recycled finished goods
 - Significant resources remain in the discarded waste stream, as only 34% of waste generated is recycled
 - Landfills pose economic and environmental challenges due to escalating financial costs and increasing methane emissions and leachate releases
- Opportunity to address an underserved market with a branded suite of solutions
 - "7ero waste" in landfills
 - Improved carbon footprint
 - Job creation
- Effective positioning with communities as a community partner enables significant economic advantages
 - Preferred provider status
 - Shortened sales cycle times

Multi-Material Processing



- Investing in resource recovery solutions can dramatically reduce volumes sent to landfills and harness those resources for clean energy generation
- Single-stream recycling processes a source separated stream to create valuable commodities (recycled paper, plastic, metals and glass)
- Multi-material processing allows for resource recovery from MSW (recovered materials can be sold into the commodity market or converted into downstream products such as energy and fuel)
- Reegineered fuel is a product of molecular recycling, enabling greater than 80% recovery of chemical building blocks from the waste stream and enabling engineering for specific downstream energy conversion applications, further decreasing waste sent to landfills
