What is Recycling Market Development?

Generally, recycling market development includes:

- Stimulating demand for recyclable materials and recycled content products.
- Taking action to create new markets or expand existing markets.
- Fostering businesses that manufacture and market recycled-content products.



Recycling Market Development Programs

- Recycling market development programs exist in many states and may consist of:
 - Recycling market directories to track recycling market participants. Often sorted by commodity and can contain a mix of collectors, processors, and end users.
 - Grants awarded to businesses to encourage recycling market expansion.
 - Technical assistance, marketing services, and attractive loans for businesses that use recycled-content products in their manufacturing processes.



Known Benefits

- Recycling market development is directly correlated to:
 - Job Creation.
 - Reusing 10,000 tons of waste creates 44-216 jobs
 - Recycling 10,000 tons of waste creates 61-213 jobs;
 - Incinerating or landfilling 10,000 tons of waste creates 6
 jobs. (Source: More Jobs Less Pollution, Tellus Institute, 2011)
 - An increase in demand for recycled materials.

A strong market for recycled materials creates incentive to collect recyclables and manufacture recycled-content products.



How Efforts Coordinated

 Some states have recycling market development programs coordinated through state organizations.

 Usually, these programs are run through state departments of environmental protection, economic development, or a combination thereof.



Coordination Efforts Continued...

- In some states, non-profit organizations are the primary means to facilitate recycling market development.
- Having an independent organization may offer more stability and long-term sustainability if funding is not directly tied to government budgets.



Key Considerations

- Sustainability is a key factor to consider when establishing a recycling market development program.
- In the past, some successful state-run programs have experienced funding shortages and have been forced to shut down as a result.
 - Arizona and Massachusetts both previously had "model" programs that have since dissipated due to lack of funding.



Recycling Market Development Defined

Actions to enhance the economic vitality of the reuse/recycling industries.

- **Supply**: Activities to increase volume, dependability, & quality of recovered feedstock.
- Demand: Stimulating demand for recyclable materials & recycled content products.
 - Taking action to create new markets or expand existing markets.
 - Fostering businesses that manufacture & market recycled-content products.
- Innovation: R&D to increase recycling opportunities & efficiencies

Summary of Coordination

- State Run programs can be susceptible to funding shortages and sustainability issues.
- While non-profit organizations attempt to overcome funding issues by partnering with industry leaders to become self-sustaining, the organization's relationship with the state needs to remain a priority to achieve results.
 - For example, when Louisiana was contacted about their involvement with the SERDC, the response stated that the Louisiana Department of Environmental Quality 'has not been actively involved with SERDC or any other recycling market development programs.'
- Further in-depth research on past and current recycling market development programs is necessary to provide a thorough recommendation on the appropriate structure for a future program in Connecticut.
