EPA's lead regs

Ross Bunnell, CT DEP and Sherill both attended a program presented by CT DPH about EPA's new lead regulations and how they will effect contractors.

Basics:

-If you stir up/disturb anything that could have lead paint – requires that you have attended a training program

- -All contractors required to provide pamphlet to owners "Renovate Right" (can be downloaded for free but you have to print them)
- -Should create receipt that customer (owner and/or tenants) should sign stating they received the pamphlet copy can be found on the EPA website (new example will be posted April 22)
- -Info signs need to be posted for visitors
- -retain records for 3 yrs

How impact deconstruction activities?

-A lot of this won't apply if no one is living in the building you are deconstructing (ie pamphlet/receipt protecting owners health)

Where does it apply?

Renovation/Demo/Decon firms and lead contractors need to be certified (see list of training providers).

- -Training required if disturbing painted (incl. varnish/stained) surface (walls/floors/windows)
 - < 6ft2 of surface (interior) per room
 - > 20ft2 of surface (exterior) per side

ANY window replacement

- -Est. to be about \$185, 8 hr training (by EPA accredited trainer)
- -good in other states
- -refresher every 5 years (not annual)
- -employees/laborers don't need training but will need on job training provided by you (the certified renovator)

Lead test kits (not recognized by CT legally) – but renovators can use if they want to determine if lead present
