#### To subscribe to the Listsery:

- Compose an email to <u>listserv@list.ct.gov</u> from the email address you wish to have added.
- Leave the subject line blank and in the body of the message type: Subscribe DEEP\_SWAC YourFirstName YourLastName (Substitute your first and last name)
  - **Note:** If you have an e-mail signature, header, and/or footer set up to be automatically included in emails, you will need to delete these before sending the subscribe request.
- You will receive an e-mail confirmation request. Follow the directions to confirm your email address.
- You will then receive an e-mail that you have successfully subscribed to the listsery.

## When you participate remotely via webinar (and/or phone):

- 1. Register for the webinar using ZOOM link above.

  Once successfully registered, you will receive a confirmation email with a unique webinar connection link to be used on the meeting day. Be sure to register ahead of time!
  - 2. On the day of the meeting, the first step is to connect to the webinar using your unique link. If using the audio through your computer, you are all set. If you dial in via a separate phone line, be sure to input the provided 9-digit **Meeting ID #**. Also, please be sure to enter your unique **Participant ID #** (which you can find online) when prompted, as this links your phone presence with your online presence.
- 3. Remote participants can submit questions via the **CHAT** window. To view a video feed of the presenters and/or the meeting room, open the **PARTICIPANTS** window.
