

Instructions for Completing an Application for Groundwater Classification Change

Use these instructions to complete the application form DEEP-WQSC-APP-001, and prepare supporting documentation. These instructions are not a substitute for the requirements of the relevant statutes and any regulations thereunder. You should review all applicable laws prior to completing this application. Remember, it is your responsibility to comply with all applicable laws.

Introduction

The Water Quality Standards Regulations (WQS), Sections 22a-426-1 to 22a-426-9, inclusive of the Regulations of Connecticut State Agencies (RSCA) set the overall policy for management of water resources for the State of Connecticut. Essentially, the goals of these policies are to:

- Protect surface and ground waters from degradation.
- Segregate waters used for drinking from those that play a role in waste assimilation.
- Restore surface waters that have been used for waste assimilation to conditions suitable for fishing and swimming.
- Restore degraded ground water to protect existing and designated uses.
- Provide a framework for establishing priorities for pollution abatement and State funding for clean up.
- Adopt standards that promote the State's economy in harmony with the environment.

Three elements make up the WQS: (1) The Standards, which are the policy statements; (2) The Criteria, which are the descriptive and numerical standards that describe the classifications; and (3) The Classification Maps that show the classifications assigned to each surface and groundwater resource throughout the state.

CGS Section 22a-426(f) sets out a procedure for requesting changes to the classification maps.

RSCA Section 22a-426-7(k) sets out the circumstances under which the Commissioner may consider an application to lower the groundwater quality classification and the minimum demonstration that must be made by the applicant. Changes to the classifications are at the discretion of the Commissioner. Applicants are therefore encouraged to review the following guidance document which discusses the CTDEEP's approach to reclassifications:

How To Apply

Your application for a groundwater reclassification must include the following:

- Application for Groundwater Classification Change (DEEP-WQSC -APP-001); and
- Supporting documentation.

You must submit the above materials together as a package to:

Refer to the Available Resources Section at the end of these instructions to obtain all required documents related to the subject application.

When submitting your application, label your supporting documentation as directed on your application form and always include, on each document, the applicant's name as indicated on the *Application Form*. When additional space is necessary to answer a question stated in the application, please insert additional sheets by the appropriate question. Label each sheet with the applicant's name as indicated on the *Application Form*, along with the corresponding part number and question number. You should retain a copy of all documents for your files.

Application Instructions

(DEEP-WQSC-APP-001)

Please read the application form and instructions carefully. They have been designed to obtain specific information and any information that is missing or unclear will cause delays in the review process. If any questions are not applicable to your specific activity, please enter "N/A" in the space provided. If a question or supporting document is only required for specific activities it will be noted on the application form and in the instructions.

Please be advised that these instructions are not a substitute for any state or federal statutes or regulations. Be sure to refer to the applicable statutes and regulations while completing your application.

Check the "Available Resources" section at the end of these instructions for assistance in obtaining guidelines, maps, etc. which are referenced in these instructions.

Part I: Application Type and Description

Check the box to confirm that you are requesting to lower the groundwater quality classification for your site from Class GA to GB. If the reclassification request is associated with a request for a Technical Impracticability (TI) variance under the Remediation Standards Regulations, RSCA Section 22a-133k-3(e), please

check the appropriate box. Note that a request for a TI variance is a separate process from the reclassification application and checking this box does not initiate the TI process. Contact Site Remediation at 860.424.3705 for further information on a TI variance.

Provide the town location of the subject activity and a brief description of the area proposed for reclassification. The proposed area must extend from the site to the downgradient discharge point (river), or a downgradient Class GB area. For the description, please include a clear, "plain language" description of the proposed reclassification area to be used for public notice which includes the size of the area in acres. For example, "35 acres located on the west bank of the Connecticut River, bounded on the north by Frump Street, on the south by Industrial Avenue, and on the west by Smith Street."

Part II: Fee Information

There is no application fee at this time. However, if the request meets the criteria of WQS, RSCA Section 22a-426-7(k), and the Commissioner finds this to be an appropriate reclassification, the Commissioner shall publish notice of the tentative determination and the public hearing on the subject classification change in the local newspaper. The applicant will be billed for the cost of publishing the public notice. Final decision on the proposed change in classification will not be issued until the notice publication costs are paid by the applicant.

Part III: Applicant Information

When completing this part, please use the following standards:

 Name - Provide the full, legal company/firm name. (If identifying an entity registered with the Secretary of the State, fill in the name exactly as it is shown on the registration. Please note, for those entities registered with the Secretary of State, the registered name will be the name used by CTDEEP. This information can be accessed at <u>CONCORD</u>). If identifying an *individual*, provide the legal name (include suffix) in the following format: First Name; Middle Initial; Last Name; Suffix (Jr, Sr., II, III, etc.). If the applicant is a governmental body, identify the city or town of such body followed by the relevant department, board or division.

- Phone Unless otherwise indicated, the phone number provided should be the number where the corresponding individual can be contacted during daytime business hours.
- Contact Person Provide the name of the specific individual within the company whom CTDEEP may contact.
- E-Mail Applicants must provide an accurate e-mail address when completing their application form. The e-mail address may be used for future correspondence from CTDEEP to your business.
- 1. *Applicant* Complete the information concerning the applicant.
- 2. *Billing Contact* Complete the information concerning the applicant's billing contact, if different than the applicant.
- 3. *Primary Contact* If you have authorized a consultant, engineer, attorney or other individual to act *for you* during the processing of the permit application, complete this section. CTDEEP will direct copies of all correspondence and inquiries to this primary contact. Please be aware that for legal reasons there will be circumstances when CTDEEP will notify the applicant instead of the primary contact.
- 4. *Attorney* It is not required that an applicant be represented by an *attorney* or any other agent. If you do have an attorney to represent you on this matter, complete this section.
- 5. *Site Owner* Complete the information concerning the site owner, if different than the

applicant.

6. *Consultant* – Complete the information concerning the consultant, if a consultant was retained to prepare the application.

Part IV: Site Information

1. Site Location

The site name, if applicable, should be the name by which the site is commonly known and/or uniquely identified.

The information given as the location address should be the address of the property which is the subject of the reclassification. Include the street address and municipality. If the property does not have a street number, describe the location in terms of the distance and direction from an obvious landmark such as an intersection with another roadway, a bridge, or a river. For example, "... on River Street, approximately 1000 feet north of its intersection with Bear Swamp Road."

2. Aquifer Protection Areas

If your site is within a Level A or Level B Aquifer Protection Area, it will not be considered for reclassification and any submitted requests will be denied.

Aquifer protection areas are defined in CGS section 22a-354a through cc and are the areas that contribute water to public water supply wells. Many towns within the state are required to establish Aquifer Protection Areas. Level A areas are final, regulated areas under the aquifer protection program. Level B areas are preliminary approximations of aquifer protection areas that have not yet been mapped to final standards, so the shape of the area may change when final mapping is completed.

Please review the list of towns, available on the CTDEEP website,

www.ct.gov/deep/aquiferprotection, to

determine if your site location is within one of these towns and, if yes, check the appropriate map, also available on the above-referenced website, to see if the site is within an area identified on a Level A (final) or Level B (preliminary) map.

Part V: Status of CTDEEP Regulatory Programs

If the site is undergoing a property transfer, voluntary remediation, or other remediation-related regulatory program, please provide a brief status of the site with respect to that program and a contact person from that program, if applicable, so they can receive a copy of the final decision on the reclassification.

Part VI: Supporting Documentation

Each application for a ground water reclassification must include as Attachment A supporting documentation which demonstrates that the site meets the criteria of the WQS, RSCA Section 22a-426-7(k). Check the box for Attachment A to confirm that such documentation is attached. Please label all supporting documentation-and be sure to include the name of the applicant as indicated on the *application form*.

Detailed guidance, titled *Revised Guidance for the Submission of Applications to Lower Groundwater Quality Classifications to GB*, can be found online at www.ct.gov/deep/wqsc. Note that at a minimum, the application must include the requirements listed in the WQS, which are as follows:

- (i) Describe the nature, extent, and date of commencement of pollution of the ground water proposed to be reclassified;
- (ii) Identify all sources of drinking water in the area whose ground water is proposed to be reclassified, and identify all existing uses of ground water within and down gradient of such area:
- (iii) Assess the potential of the subject area to produce ground water in an amount suitable

- for a public water supply; and
- (iv) Describe all past and present land uses in the subject area, with dates.

In addition, the following information is needed:

- (v) A table showing recent levels of ground water contamination at each observation well, with the appropriate ground-water protection, surface-water protection and volatilization criteria listed;
- (vi) A table listing all properties within the area proposed to be reclassified and all properties within 500 feet of the area proposed to be reclassified and confirmation that each property is connected to public water (or is undeveloped);
- (vii) A map, at 1:24,000 scale or greater showing:
 - a. The location of any test wells or borings, sampling points, water table elevations and contours;
 - b. The location of any identified sources of pollution; and
 - c. The location of any properties within the area proposed for reclassification which have not been demonstrated to have an adequate public water supply. (These are the properties proposed to be connected to public water by the applicant);
- (viii) An 8 1/2" x 11" copy of the relevant portion of a USGS topographic quadrangle map, at a scale of 1:24,000 indicating the exact location of the proposed area for reclassification.

 CTDEEP will use this map to enter your project location into its Geographic Information System (GIS). It is important that you accurately locate the project site and proposed activities because the GIS generates natural resource information relevant to your

- site, and it will be utilized to modify the classification maps. An inaccurate description of the project location will delay processing of your application; and
- (ix) A copy of the notification letter to municipal officials.

Part VII: Applicant Certification

After the application has been completed it must be reviewed and signed by both the applicant(s) and the individual(s) who actually prepared the application. By their signature, they certify that to the best of their knowledge and belief, the information contained in the application, including all attachments, is true, accurate and complete.

The certification of the application package must be signed as follows:

- 1. For an individual(s) or sole proprietorship: by the individual(s) or proprietor, respectively;
- 2. For a corporation: by a principal executive officer of at least the level of vice president;
- 3. For a limited liability company (LLC): a manager, if management of the LLC is vested in a manager(s) in accordance with the company's "Articles of Organization", or a member of the LLC if no authority is vested in a manager(s);
- 4. For a partnership: by a general partner;
- For a municipal, state, or federal agency or department: by either a principal executive officer, a ranking elected official, or by other representatives of such applicant authorized by law.

An application will be considered insufficient unless all required signatures are provided.
