EPPI 2014: Information package #5,

Dear participant,

This is the fifth exercise notification in a series of pre-exercise notifications. Each notification has an attachment giving weather reports of the coming storm along with pertinent exercise information. These messages are part of our communications testing efforts so you should expect to receive messages though the Everbridge system, Listsrv and email systems concerning this year's exercise. We are now at 2 days out from storm landfall and the imminent danger of Hurricane Axel making impact on the Connecticut Coast line. The Following actions need to occur along with your own preparedness planning and preparations:

- The DOC will check on Tactical Teams and their availability, ensure facilities have accommodations for staff to sleep if held overnight including meals. Move inmates from York CI low lying buildings which flood to Gates CI in heavy rain conditions.
- Should conduct communications contingency planning and testing; communicate deviations from SOP to all stakeholders.
- Initiate planning for shelter activation and mass feeding capabilities. Coordinate prestaging of POD locations for commodities and food and plan to deploy shelter management assets and teams to (Shelter Locations) pre-landfall. Be prepared to provide availability of the building, location, capacity, # of cots on hand and generator capabilities/capacity via WebEOC.
- Utility companies need to check status of electric utilities town and state liaisons.
- Statewide news media is reporting that gas stations claim they need help protecting
 their facilities from the public. The combination of long lines and the fear of running
 out of supplies is making people horde as much gas as they can. People are getting
 nervous that they are not going to get any, so they are trying to cut in the line, which
