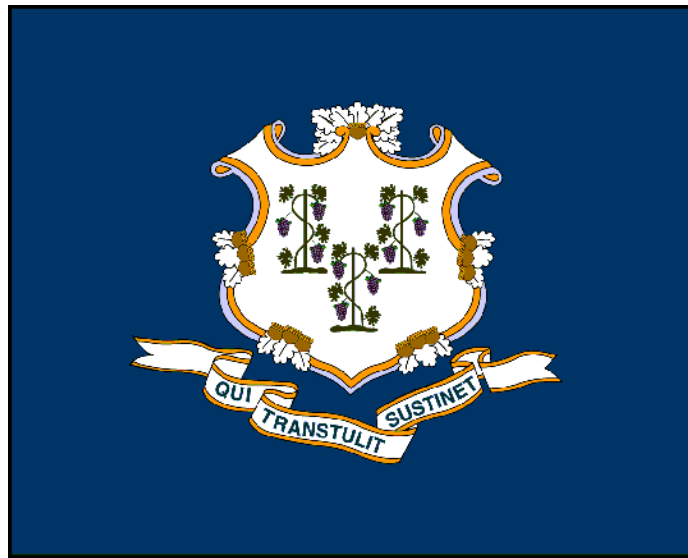





Purpose

The State of Connecticut, Department of Emergency Services and Public Protection/Division of Emergency Management and Homeland Security (DESPP/DEMHS) Multi-Year Training and Exercise Plan (MYTEP) was developed as part of Governor Lamont's Emergency Planning and Preparedness Initiative (EPPI).

The purpose of the MYTEP 2019-2021 is to provide information about training opportunities and exercises currently scheduled within the State of Connecticut as well as to identify training and exercise needs. The MYTEP provides a roadmap for entities involved in emergency management to follow, in order to accomplish their training and exercise priorities over the next three years.

Included in the MYTEP is the training and exercise schedule, which illustrates the proposed activities, currently planned for the years 2019-2021. The schedule represents the natural progression of training and exercises that should take place in accordance with the guidance included in the Homeland Security Exercise and Evaluation Program (HSEEP), building-block approach.

Methodology

Training & Exercise Planning Workshops (T&EPWs) were conducted with regional partners from all five CT DEMHS Planning Regions from June to July 2019. DEMHS Regions are groups of municipalities and tribal nations organized for emergency planning and preparedness purposes. The Regions are further organized into Regional Emergency Planning Teams (REPTs) which are multi-jurisdictional and multi-disciplinary, with each REPT governed through bylaws. Local agencies were asked to provide two areas of information; currently scheduled training and exercises and needed or desired training and exercises through 2021. The results of the T&EPWs and the input received from the Regions and other stakeholders were used to develop the State of Connecticut Multi-Year Training and Exercise Plan.

Corrective Action Process

State Exercise After Action Report / Improvement Plan (AAR/IP) and Corrective Action Process (CAP) (methodology based up HSEEP 2013, Instructor Guide, Version 13.1, Unit 6).

1. Exercise Conclusion:

- Hot wash is conducted and recorded.
- Evaluation forms are collected.

2. Draft AAR/IP/ document:

- Collected information from hot wash and evaluation forms are analyzed.
- Draft AAR/IP document created and distributed.

3. AAR/IP Meeting:

- Draft AAR/IP document discussed.
- Specific AAR/IP items chosen.
- Within the IP, the Capability Element(s): Planning, Organization, Equipment, Training, or Exercise are identified for each IP item which then determine the CAP.
- IP items are updated with to include CAP, owning manager, and due date.

4. Post AAR/IP Meeting:

- Updated Draft AAR/IP/CAP document is sent to all participants at the AAP/IP meeting for review.
- When accepted by all participants, the AAR/IP/CAP is finalized and redistributed as 'Final'.
- The IP contains the following fields:

5. Tracking of the progress of the IP/CAP:
- Utilizing a spreadsheet, the implementation steps for prioritized corrective actions are documented and tracked.
 - The status of open corrective actions is reviewed at each DEMHS Manager’s and Supervisor’s meeting as a regular item under the Training Unit report.
 - The final resolution of the IP is documented in the spreadsheet and results are shared with partners. (also see the DEMHS Administration Plan)

Training and Exercise Schedule

The Training and Exercise Plan uses the Homeland Security Exercise and Evaluation Program (HSEEP) building-block approach to plan training courses and exercises based on state and local priorities. The building-block approach ensures progression in exercise complexity, allows for sensible preparation (e.g., equipment purchases or training courses), and outlines a training and exercise regimen that maximizes mutual reinforcement.

For example, DEMHS has established a training plan that outlines training requirements for DEMHS employees based on responsibility in accordance with Governor Lamont's Executive Order 34 – NIMS Implementation, originally released by Governor Malloy and adopted by Governor Lamont. This plan is updated on an as needed basis or at a minimum, bi-annually.

With regard to exercises, DEMHS has the lead responsibility for the organization, design and facilitation of the annual Governor's Statewide EPPI exercise. DEMHS also supports, when requested and as available, other State Agency exercises outlined in the Multi-Year Training and Exercise calendar below.

In addition, DEMHS assigns a trainer to each DEMHS region, who can provide guidance and assistance in the planning and implementation of local or regional exercises, within available resources.

As always, HSEEP is helpful to ensure consistency in exercise design, facilitation and evaluation.

Training and Exercise Calendar

The final section of this document is the Training and Exercise Calendar for 2019-2021. The first set of calendars outline the Emergency Management-focused training and exercises scheduled by state agencies. The second set of calendars are a compilation of data received from all five DEMHS Regions related to training and exercises scheduled or requested for 2019-2021. All calendars are evolving, ever-changing documents, which will be updated by DEMHS as new information becomes available.

- Lessons learned on accommodating mass care needs of residents with functional needs; and,
- Incorporating lessons learned into State Plans, future training and exercises.

Power Generation/Critical Infrastructure

(Either stand-alone or incorporated into larger exercise objectives)

- Utility Restoration – Make Safe Protocol;
- Recommendations outlined in the Two-Storm Panel Report (Tropical Storm Irene and the October Nor'easter); and,
- After Action Reports (AAR)/Improvement Plans (IP) from real-world events, exercises, & training.

Specialized Team Training: Urban Search and Rescue Team (USAR)

- Provide specialized training to the state volunteer USAR team which consists of 70 active sworn, deployable members; and,
- The team can be requested by Incident Commanders to assist in building searches, swift water rescue, and wilderness searches.
- Deployment of the team is approved by DEMHS.

Radiological Emergency Preparedness

- Provide training to emergency responders on radiological emergency preparedness equipment;
- Conduct exercises such as Plume and Host Community Reception, Transportation Staging Area;
- Provide REP program overview and training to municipalities and other organizations located within the Emergency Planning Zone (EPZ);
- Coordinate with the State Department of Public Health to develop and train Professional Radiation Response Volunteers to assist with operations at Host Community Centers;
- Conduct tabletops and drills throughout the EPZ; and,
- Participate in quarterly drills with Millstone Station.

Increase Resiliency through Training that supports Community Lifelines

- Life Lines provide indispensable services critical to human health and safety, economic security continued operation of government and business functions.
- Conduct Community Emergency Response Team (CERT) Train the Trainer program to support the development of new CERT Teams state-wide.
- Continue to support FEMA's Student Tools for Emergency Planning (STEP) Program in schools across the state.
