EXECUTIVE ORDER NO. 12

WHEREAS, a declaration of civil preparedness emergency was issued by the Governor on October 29, 2011 due to a severe snow storm and unprecedented power outages experienced throughout the state;

WHEREAS, Connecticut General Statutes section 28-9(b) authorizes and empowers the Governor to take such steps as are reasonably necessary in light of such emergency to protect the health, safety and welfare of the people of the state, and to modify and suspend in whole or in part, any statute, regulation or requirement or part thereof, whenever the Governor is of the opinion that it is in conflict with the efficient and expeditious execution of civil preparedness functions;

WHEREAS, severe weather conditions and fallen trees have resulted in continuing widespread power outages in the state, forced numerous town halls to close and limited transportation within the state;

WHEREAS, municipal elections are scheduled to take place on November 8, 2011;

WHEREAS, with limited exceptions, the voter registration deadline to register in person to cast a ballot in the upcoming municipal elections is November 1, 2011;

WHEREAS, conditions resulting from the storm pose a danger to persons who may attempt to travel to town hall to register to vote in person;

WHEREAS, many potential voters will be unable to register due to town hall closures and travel difficulties;

WHEREAS, in light of the emergency conditions it is appropriate to extend the voter registration deadline to give the most voters the opportunity to register and vote, even in towns where power may be restored close to election time;

NOW, THEREFORE, I, Dannel P. Malloy, Governor of the State of Connecticut, by virtue of the authority vested in me, do hereby **ORDER** and **DIRECT** the suspension or modification of the following statutes, regulations or requirements under the following conditions for the reasons stated above:

1. Except as otherwise stated in this Order, Section 9-17(a) of the General Statutes is modified to the extent that the deadline for all electors to register in person to vote shall be November 7, 2011 at 12:00 noon. Notwithstanding the foregoing, the deadline for those persons identified in Section 9-17(b) of the General Statutes to register in person to vote shall be November 7, 2011 at 5:00 p.m. The provisions of Section 9-17(a) requiring municipal registrars of voters to hold sessions to examine the qualifications of electors and admit those found qualified is hereby suspended, except that each municipal registrar of voters may, at his or her discretion, choose to hold such session at any time between the date of this Order and November 7, 2011 at 12:00 noon.
2. Section 9-19b of the General Statutes is hereby suspended.
3. Section 9-19g of the General Statutes is hereby suspended.
4. Section 9-38 of the General Statutes, as amended by Section 4 of Public Act 11-173, is hereby modified to the extent that the final registry list and an updated list that contains the names and addresses of electors to be transferred, restored or added to such list, as required by such section as amended, shall be made available in the municipal clerk's office not later than November 7, 2011 at 5:00 p.m.



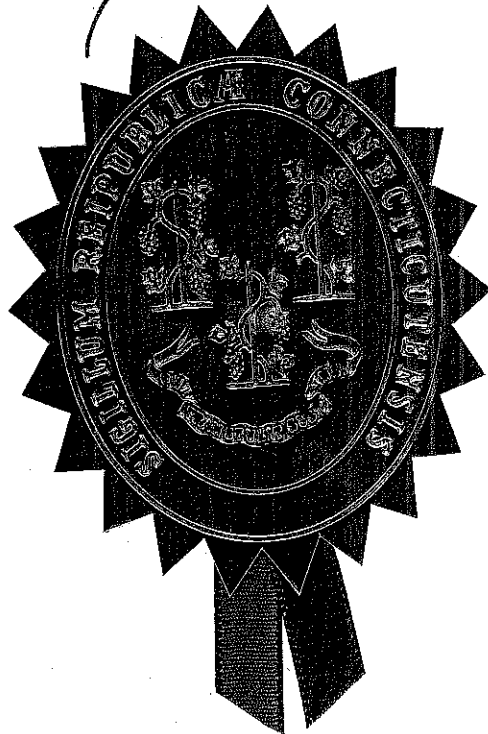



Due to the severe weather conditions affecting the State, specifically heavy snowfall on top of leaf-covered trees resulting in widespread damage and power outages, I am hereby proclaiming a state of civil preparedness emergency, pursuant to Connecticut General Statutes Section 28-9.

ORDER

Pursuant to Connecticut General Statutes Section 3-1 and 3-6a, I have determined that an emergency situation exists in the State of Connecticut because of extreme weather conditions, which requires the restriction of movement of persons and vehicles upon the streets and highways of the state. I therefore issue the following order:

- A ban on all non-emergency traffic on the Wilbur Cross/Merritt Parkways due to the severe winter storm conditions. This ban shall take effect immediately, Saturday, October 29, 2011 and shall continue until further notice.
