Please see the attached Exclusive Service Area (ESA) Declaration Forms for the Western, Central and Eastern WUCCs representing the Department of Energy and Environmental Protection's (DEEP) claims for ESAs throughout the state as an owner and operator of more than 50 public water systems. In the interest of time and available resources, as well as the sheer size and scope of our claims, the three forms are completed in a similar fashion covering our statewide issues and perspectives rather than honing in on the specific geography of the three WUCCs. Adjoining the declaration forms and also attached are GIS shape files and maps identifying all of DEEP state conservation lands, not already served by other public water systems, as our proposed ESAs.

We do recognize that a portion of DEEP state conservation lands fall within areas already with assigned ESAs and that these proposed DEEP ESAs will be addressed at a later date as boundary changes. To that end, we acknowledge the uniqueness of DEEPs expansive holdings, land use and our status as an owner of many small public water systems throughout the state may require additional information and communications between the WUCCs and agency representatives. We would welcome such a discourse.
