SUBJECT: Important Information for Community PWS Serving Less Than 1000 People

During the COVID-19 Crisis and Follow Up to Phone Calls made by Drinking

Water Section between March 27 and April 3, 2020

Between March 27 and April 3, 2020, the Department of Public Health (DPH) Drinking Water Section staff called all small community public water systems (systems serving less than 1000 people) to assess current operational status and had an approximately 70% response rate with such calls. The DPH Drinking Water Section asked the following questions on those calls:

- Is your public water system operating normally?
- Is your public water system having any problems meeting system demands with more people working and schooling from home?
- Are there any problems with your certified water operator continuing to provide public water system operation services at this time?
- Are you experiencing any problems obtaining supplies necessary to operate your public water system such as treatment chemicals, pumps or pump parts?
- Are there any other questions you have for the DPH?

Thank you to those small community public water systems who have already responded. If you have not yet responded, you are requested to please call the DPH Drinking Water Section Staff who contacted you as soon as possible or respond via email to that individual's email address or to DWDcompliance@ct.gov. While the DPH Drinking Water Section understands that much of the day-to-day operations of your public water system are performed by your certified operator, the DPH would like to emphasize how important the role of the public water system owner/administrator is during times such as these. Please communicate often with your certified operator and consumers regarding the operation of your public water system, and reassure your consumers that the system's water test results continue to be collected according to the set schedule.
