


Connecticut Children's Healthy Homes Program

- Develop scope of work & coordinate bid FREE Service
- Resident engagement, relocation coordination FREE Service
- All services available in Spanish!

- Grant Program with 3-Year Forgiveness
- Program Covers Costs from Inspection Clearance
- Bi-Lingual Client Education and Relocation Planning
- Significant Funding Available!
 - Single Family Home Up to \$22,000!
 - Three Family Home Up to \$60,000!
