Meeting called to order at 1:33 p.m. Update on TWIAGE (Mobile App for EMS to Hospital Communications)	Presented Minutes of the February 9, 2022 and March 9, 2022 meetings. Guests: Mike Zacchera, DPH/OEMS Region 3 Coordinator and Bill Schietinger Chair, CT EMS Advisory Board joined the meeting. B. Morris reported that the TWIAGE Mobile App went live today for the Hartford Healthcare Hospitals and Services statewide. The App is intended to provide pre-hospital "early alerts on the patient status" and enhance the communications flow from EMS to hospital emergency departments and other departments (i.e., Cath Lab, Trauma, etc.) within the facilities. TWIAGE is providing training statewide for pre-hospital personnel. B. Morris asked the members to speak on their knowledge of the TWIAGE App and share information from their areas. The RCCs/CMEDs shared similar concerns and acknowledged some benefits. The biggest concern is the use and coordination of multiple apps by other hospitals/health care systems. North Central and Southwest met with TWIAGE to explain CMED's role and responsibilities. B.
