CMED 9-1-1 subsidy Funding	V. Dumas reported that he met with the Co-Chair of the Legislative Fire & EMS Caucus regarding an initiative to raise the CMED subsidy. This method could result in statewide savings for municipalities. <i>Following Items to consider</i> method of charging for CMED service; legislative change requiring CMEDs to continue to provide service without charging when there is a conflict with the cost. V. Dumas reported on his experience with a municipality.	
CMED Work Group Report	Information Sharing on Talk Group Effectiveness No Update.	
Develop CMED Fact Sheet and Education Component for CMED Directory	B. Morris reminded the group that we need to put together a CMED fact sheet and education component for the CMED directory. This initiative becomes more important as new technologies are introduced to provide prehospital to hospital communications (particularly without coordination). V. Dumas reported that the Yale Healthcare System was investigating Twiage. Potentially there could be four different platforms being used by the hospitals. This could adversely affect the EMS services.

Impact of Hospital Diversion on EMS Services	B. Morris reported that three hospitals in CT were impacted by the Prospect Health cybersecurity issue (ECHN –Manchester and Rockville, as well as Waterbury Hospital). This caused a prolonged diversion situation in the Hartford area. Northwest and North Central reported on their experiences. Overall, the decision rested with EMS services to determine what destination hospital was best for the patient.
