
SWORD Statewide Reporting November 2020

In the month of November 2020, there were 377 calls in to the CT Poison Control Center (CPCC) for SWORD. Of these calls, 347 were non-fatal and 30 resulted in fatalities. There were 278 total naloxone administrations: 153 non-fatal multiple doses of naloxone administered, 114 non-fatal single dose naloxone, and 75 non-fatal with no naloxone administered. There were three (3) non-fatal with "unknown" naloxone administered. Of the 30 fatalities, five (5) received multiple doses of naloxone, six (6) received single dose, and nineteen (19) with no naloxone administered. The gender breakdown for the state is: Male (271); Female (103) and (3) unknown.

The 377 cases involved suspected overdoses from all of our counties: Fairfield (59), Hartford (150), Litchfield (16), Middlesex (18), New Haven (72), New London (44), Tolland (7), and Windham (11). The age breakdown of the patients is as follows: 0 to 18 years of age (2); 19 to 24 years of age (25); 25 to 34 years of age (90); 35 to 44 years of age (96); 45 to 54 years of age (72); 55 to 64 years of age (71); 65 years of age and older (15); age unknown (6).




ODMAP Suspected Overdose Submissions - In the Last Month

The description of paraphernalia found on scene can be very important in determining whether reported overdoses are due to a bad batch, that poses a continuing threat to others, or are random events. In many areas of the state, particularly surrounding Hartford, and Waterbury, most heroin is packed in small glassine envelopes, many of which are stamped with a brand or come in a preprinted envelope with a brand design. Recently in Hartford, a brand known as Dark Magic was linked to overdoses due to dealers allegedly improperly mixing their ingredients. When on scene have one of your crew members scan the premises for paraphernalia in the same manner in which you look for medications. Note syringes, pipes and wrappings of any kind. Heroin bags can often look like small crumpled up pieces of paper. Sometimes the scene has been cleaned prior to your arrival by the victims' friends or acquaintances. Other times, the patient will be forthcoming, answering manner in which he used and the name of any branded heroin bag. We appreciate your efforts.

Glassine Bags

The following is an example of a bag stamp encountered in November: Dark Magic. If present, and safe to do so, responders are urged to take a photo of the identified heroin bag at the scene and email to poisoncontrol@uchc.edu with the Connecticut Poison Control Center case number given when the reported overdose is called in.
