

**GUIDELINES FOR DEVELOPING TRAINING REGARDING SCREENING FOR POST-TRAUMATIC STRESS DISORDER, RISK OF  
SUICIDE, DEPRESSION AND GRIEF, AND SUICIDE PREVENTION**

**INTRODUCTION**

---

Pursuant to [Public Act 21-46](#), effective **January 1, 2022**, all applicants for **renewal** of certification as an emergency medical responder (**EMR**), emergency medical technician (**EMT**) must demonstrate to the Department that they have completed one of the following training programs:

1. Question, Persuade and Refer (QPR) Institute Gatekeeper Training as provided by the Youth Suicide Advisory Board in conjunction with the Office of the Child Advocate, or
2. Not less than two (2) hours of training or education, approved by the Department of Public Health on screening for post-traumatic stress disorder, risk of suicide, depression and grief and suicide prevention.

Many local health districts and community health agencies offer QPR at no cost. See listing on p. 2.

**PROGRAM DEVELOPMENT**

---

EMS instructors and other qualified persons may obtain training from the Office of the Child Advocate when that program is made available. A commercially available program called “QPR Institute” may be used, however no instructor is required to invest in that program.

EMS instructors and other subject matter experts (social workers, licensed counselors, APRN with psychiatric training, etc.) wishing to develop their own curriculum shall submit a request for approval through the online EMS Education Approval System at <https://dphsubmissions.ct.gov/EMSSystems> .

The submission shall include the following:

- Minimum learning objectives
  - screening for post-traumatic stress disorder
  - screening for risk of suicide
  - screening for depression
  - screening for grief
  - suicide prevention
- Method(s) of education
- Method(s) of assessment
- List of clinically sound references used to develop
- Minimum time frame of 2 hours
