I. Key Findings

- Based on data collected through the Connecticut Department of Public Health (DPH) School-Based Asthma Surveillance System (SBASS), the 2022 overall asthma prevalence among students in the Connecticut public school system is 12.3%, a decrease of 0.6 percentage points compared to the 2020-2021 overall asthma prevalence. Approximately one of every eight students (12.3%) in the Connecticut public school system is affected with asthma.
- Asthma affects high school and middle school students at roughly the same prevalence, 13.2% and 13.0%, respectively. Students in elementary school have a lower asthma prevalence of 10.6%.
- Male students (14.1%) are affected more by asthma and have a higher asthma prevalence than female students (11.5%).
- Non-Hispanic students of other races (18.8%) and non-Hispanic Black students (17.2%) are the groups with the highest prevalence of asthma when compared to Hispanic students (14.9%) and non-Hispanic White students (9.3%).
- The Connecticut State Department of Education's (SDE) free and reduced-price meal (FRM) data give the percentage of students, per district, that qualify for free or reduced-priced meals. When FRM percentage data were grouped into quartiles, with Quartile 4 representing the highest percentage of students qualifying for FRM, asthma prevalence rose with each increasing FRM quartile. Asthma prevalence ranged from 8.5% for Quartile 1, to 15.7% for Quartile 4.
- SDE provides data on chronic absenteeism for each public school district as a percentage of students who are chronically absent. When chronic absenteeism data were grouped into quartiles, with Quartile 4 representing the highest percentage of students chronically absent, asthma prevalence was noted to increase as the percentage of students chronically absent increased. Asthma prevalence ranged from 8.5% for Quartile 1, to 16.0% for Quartile 4.
- Moderate and severe persistent are the most severe forms of asthma. Overall, 8.9% of students are affected with the moderate or severe persistent form of asthma. Students in middle school (9.6%) are affected the most with this level of asthma severity, followed by students in high school (8.7%) and elementary school (8.5%). Hispanic students (10.0%) show the highest percentage of moderate or severe persistent asthma, followed by non-Hispanic Black students (9.7%), non-Hispanic students of other races (9.4%), and non-Hispanic White students (7.8%). Students in school districts with the highest levels of chronic absenteeism are also the most affected by moderate or severe persistent asthma, with a prevalence of 10.3%.

- Overall, 23.7% of students with asthma have an Asthma Action Plan (AAP), which represents an increase of seven percentage points compared to findings of the 2020-21 analysis. Students from private schools, compared to public schools, show a higher percentage of AAPs in place, 42.3% versus 22.1%, respectively. A higher proportion of non-Hispanic students of other races (33.1%) have an AAP, followed by non-Hispanic Black students (26.8%), Hispanic students (22.4%) and non-Hispanic White students (21.4%). A higher proportion of students affected with moderate or severe persistent asthma have an AAP (44.0%), compared to those with mild persistent (34.1%) or intermittent (23.7%) forms of asthma.

II. Introduction

Connecticut General Statute (CGS) [Sec. 10-206](#) requires that each local or regional board of education request a health assessment from each student prior to public school enrollment (in either pre-kindergarten or kindergarten), in either grade six or seven, and in either grade nine or ten. The health assessment includes a physical examination, laboratory tests, screening results, and documentation of a chronic disease assessment, including asthma. The form is filled out by both a clinician and the student's parent/legal guardian.

Since 2004, the Connecticut Department of Public Health (DPH) Asthma Program has managed the statewide School-based Asthma Surveillance System (SBASS), which includes collecting, analyzing, and publishing a report based on the asthma section of the School Health Assessment Record¹ (HAR). The current publication summarizes the information collected during school calendar year 2022-2023.

School-based Asthma Surveillance System

CGS §10-206 requires that each local or regional board of education report to DPH on a tri-annual basis the total number of enrolled students per school and per school district with a diagnosis of asthma at the time of public-school enrollment, in grade six or seven, and in grade nine or ten, while CGS § 19a-62 requires DPH to maintain a system of monitoring asthma screening information reported pursuant to CGS §10-206. During 2019 and 2020, DPH deployed the SBASS online reporting system, a web-based application within the architecture of the DPH Submissions System. Data for the 2022-2023 school year were collected using the SBASS online system. The Connecticut Asthma Program staff conducted a total of 5 training sessions, with 105 registrants to prepare school nurse supervisors and school nurses to report, submit, and approve records for their school asthma submission.

For the purpose of asthma reporting, a student is considered to have asthma if any of the following conditions are met: the student 1) has a provider's diagnosis of asthma indicated on the HAR, 2) has a provider Asthma Action Plan (AAP) on file, 3) has a provider medication order for asthma medication on file, 4) has a self-carry medication approval, 5) has asthma medication

in school, 6) has a parental note on file indicating the child has asthma, 7) shows symptoms of asthma, or 8) any other indications that the child is suffering from asthma.

For the school calendar year 2022-2023, SBASS was conducted exclusively online by school nurses/supervisors or other assignees. The SBASS electronic reporting form collects the same information as the paper reporting form used in data collection periods prior to 2020.

School and district information as well as enrollment data were collected from the State Department of Education (SDE). The SBASS asthma electronic form collects the following information on students with asthma: school name, grade, race, ethnicity, documentation of asthma diagnosis based on criteria listed above, asthma severity, and health history. The asthma form is accessible to any SBASS account user who has been vetted by a DPH staff or registered by a school district nurse supervisor. There are two types of accounts for SBASS users: 1) supervisor accounts with permission to manage users in their corresponding district, add/delete asthma records, update school reporting status, and approve school data submission; and 2) nurse accounts that can only add/delete asthma records and update school reporting status. The SBASS online reporting system was open from October 4, 2022, to December 1, 2023.

Asthma Prevalence – Rate Calculation Method

Following the statutorily mandated asthma reporting requirement, the SBASS collects asthma data on students in grades that the HAR is required for as a condition of school enrollment, or at the time of student enrollment in a new district at any grade. Therefore, asthma reporting is not collected systematically from all grades at the elementary, middle, and high school level. However, the SBASS system is designed to accept reports from all grades; prekindergarten (PK) through grade 12 as well as from all school types; public, private, or other.

The approach to reporting taken by schools varied, thus creating situations that had to be accounted for in the analysis design. For the 2022-2023 school year data collection, most reporting schools submitted reports for HAR-required grades, though some also submitted reports for non-HAR required grades (e.g., second, third, eighth grade, etc.); these comprised about 30% of all records submitted. The reporting of non-HAR required grade records could be due to schools reporting new student enrollments outside of HAR-required grades or schools voluntarily choosing to report more than just the HAR-required grades.

Some schools reported only new students upon entry and attending for the first time in the public school system. One example of this situation is when a newly enrolled student (with asthma) who starts attending a public school in first grade, and the school's HAR-required grade is PK or kindergarten (K). The 'new' asthma student in first grade is reported by the school, but none of the other first grade students with asthma are reported by the school. Under this scenario the student from first grade would not be used for asthma rate calculation. Another circumstance is when school districts include different grades by school level. For example, the Cheshire School District's elementary school level includes grades K-6, while middle school includes grades 7-8, and high school includes grades 9-12. In comparison, Hartford School District's elementary schools include grades PK-5, with middle school including grades 6-8, and high school including grades 9-12. Canterbury Public Schools offer PK-4 grades for elementary school, 5-8 for middle

school, and have no high school grades under their school district; rather the district covers their residents' high school tuition and transportation for attending other designated high schools.

These variations across school districts may affect rates when they are analyzed overall by school education level. To address grade arrangement variations among school districts, or discrepancies in required HAR-grades in the presence of other grades, this report grouped the following grades to represent their respective education levels: PK-fifth grade for elementary school level, sixth through eighth grade for middle school level, and ninth through twelfth grade for high school level. The enrollment data, as provided by SDE, included all grade levels, and were arranged to match each school education level. The methodology to calculate asthma prevalence included using the grade with the highest number of students with asthma reported, as the representative grade for asthma reporting across all grades in the same education level. This representative grade, the numerator, was compared against the total number of students enrolled for the corresponding grade, the denominator.

This methodology was considered the best approach to prevent data exclusion of schools reporting non-HAR-grades, capture the same likelihood for all grades to be included in the construction of rate calculation, increase the likelihood of selecting a representative value of asthma cases within an education level, and lastly, achieve standardization of education level when grouping and including all grade levels. Overall, 25,226 students with asthma records were reported; of these, 95.8% (n=24,159) were matched to the corresponding enrollment information, based on SDE unique identification for each given school. Records not matched with corresponding enrollment information were excluded from asthma rate calculation. Asthma prevalence was calculated by dividing the number of total students reported with asthma by the number of total students enrolled at the corresponding grade level.

III. Results

This report is based on data submitted by schools for the school calendar year Fall 2022 – Spring 2023. One hundred ninety-six out of two hundred school districts in Connecticut submitted asthma reports. Generally, the Connecticut school system arranges for students to attend schools located in their town, and all schools within a town form a school district. In some instances, when the town population is small, several towns will combine resources and form a regional school district, and the students from those towns attend school in the regional district. The Connecticut school system also has other school districts (e.g., charter schools or regional education service centers) that were formed for accountability, performance, or financial benefit reasons; these school districts co-exist with the town or regional school districts and may have overlapping geographic coverage. This report considered the different variations of school groups as school districts, such as school districts for the towns, regional school districts, charter schools, and regional education service centers. This report utilizes the classification of school districts and their respective schools defined by SDE. A total of 1,169 schools reported 25,226 students with asthma. Appendix 1 lists school districts and schools that reported for school calendar year 2022-2023.

Table 1 describes the distribution of records submitted by grade level and HAR-requirement classification for public schools.

Overall, 22,592 records were submitted from public schools; of those, 15,816 (70.0%) were from HAR-required grades and about one-third, 6,776 (30.0%), from non-HAR required grades.

A. Data Completeness

Asthma reports were assessed for data completeness for gender, ethnicity and race, and asthma severity. Gender was specified for all records; 100% completion. A total of 2,884 records (12.8%) of students with asthma did not specify race. A total of 3,187 (14.1%) records of students with asthma were reported with unknown ethnicity. A total of 7,025 (31.1%) records did not specify the level of asthma severity.

The enrollment dataset for public schools contained 518 (0.4%) records with an unknown gender value. All records had an ethnicity designation other than 'Other' or 'Unknown'. All enrollment records had a race designation other than 'Other' or 'Unknown'. There were no records with missing values.

Of the records of students with asthma that were matched to enrollment data, 40.0% were accounted for from PK (7.8%) and K (32.3%) grades among elementary school level; for middle school level 82.7% were from sixth (37.3%) and seventh (45.4%) grade, and 78.2% of high school level were from ninth (32.7%) and tenth (45.5%) grade.

Table 2 shows the frequency distribution of responding schools as classified by SDE organization type, by reporting status. A total of 1,169 educational institutions provided a response to the

SBASS; of these 1,138 ‘Completed’ the report, while 31 submitted incomplete data. The latter schools were excluded from the analysis. When SDE’s organization type were re-categorized to group schools as either a public facility, private, or other, it was found that 909 (95.1%) of public schools responded and completed their report.

B. Asthma Prevalence by Demographics

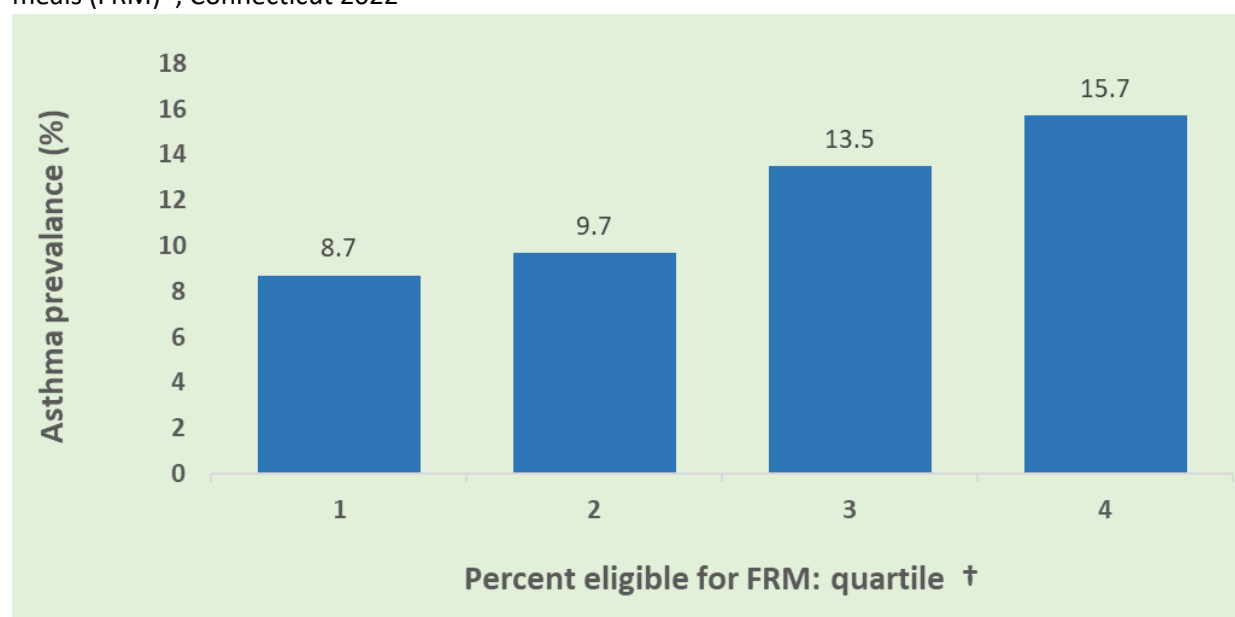
Figure 1 shows asthma prevalence by percent eligible for free and reduced-priced meals² (FRM). FRM data are collected by SDE for local public-school districts and are used here as an indicator of student socioeconomic status. Students eligible for FRM include those who reside in households receiving Supplemental Nutrition Assistance Program (SNAP) or Temporary Family Assistance (TFA) benefits, those whose household income falls within the defined limits of the Federal Income Eligibility Guidelines, and others deemed categorically eligible. FRM quartiles replace the District Reference Group (DRG) categories used in prior reports. Historically, SDE maintained DRG data to measure the overall socioeconomic status of school districts based on such factors as family income, parental education, parental occupation, percentage of public-school children in single parent families, percentage of students eligible to receive free/reduced-price meals, percent of students that speak a language other than English at home, and enrollment data. The current report uses FRM as a proxy for DRG, as SDE no longer maintains DRG classification data.

A previous report based on school calendar years 2012-2014 showed an overall rate of 14.3%, with generally steady yearly asthma prevalence; 14.4% for 2012 and 14.3% for 2013 and 2014. A subsequent report based on the school year 2020-2021 showed a decreased overall asthma prevalence of 12.9%. The overall asthma prevalence of 12.3% for 2022 represents a continued decrease in prevalence from 2012. See Figure 1. Note that data collection occurred annually during 2006-2014, paused during 2015-2019, and resumed in 2020 on a triennial basis.

Analysis for the 2022-2023 school calendar year has been tabulated into different categories. Table 3 displays the information for the year, by school level, by gender, and by race/ethnicity. The data are also shown in Figure 2.

At the school level, asthma prevalence was statistically significantly higher among middle school (13.0%) and high school (13.2%) students, compared to elementary school (10.6%) students. The trend in prevalence by school level is consistent with the 2020-2021 report but a shift from the 2012-2014 report, which indicated elementary school students had the highest asthma prevalence.

The prevalence among male students (14.1%) is statistically significantly higher than it is among female students (11.5%). The gender specific prevalence follows the same trend as previous

reports, although prevalence among males shows a slight decrease compared to the 2020-2021 report (14.7%). Asthma prevalence is statistically significantly higher among other-race non-Hispanic (18.8%) and non-Hispanic Black (17.2%) students, compared to Hispanic (14.9%), and non-Hispanic White (9.3%) students. Prevalence has increased among non-Hispanic students of other races compared to that observed with the 2020-21 report (12.1%). Of note, the proportion

of students considered as 'other' race increased during 2022-23 compared to 2020-21, due to the larger volume of students reporting as multiple races. Multiple race students are classified as 'other' for analysis purposes.

Figure 2. Asthma prevalence by school level, sex, and race/ethnicity, 2022

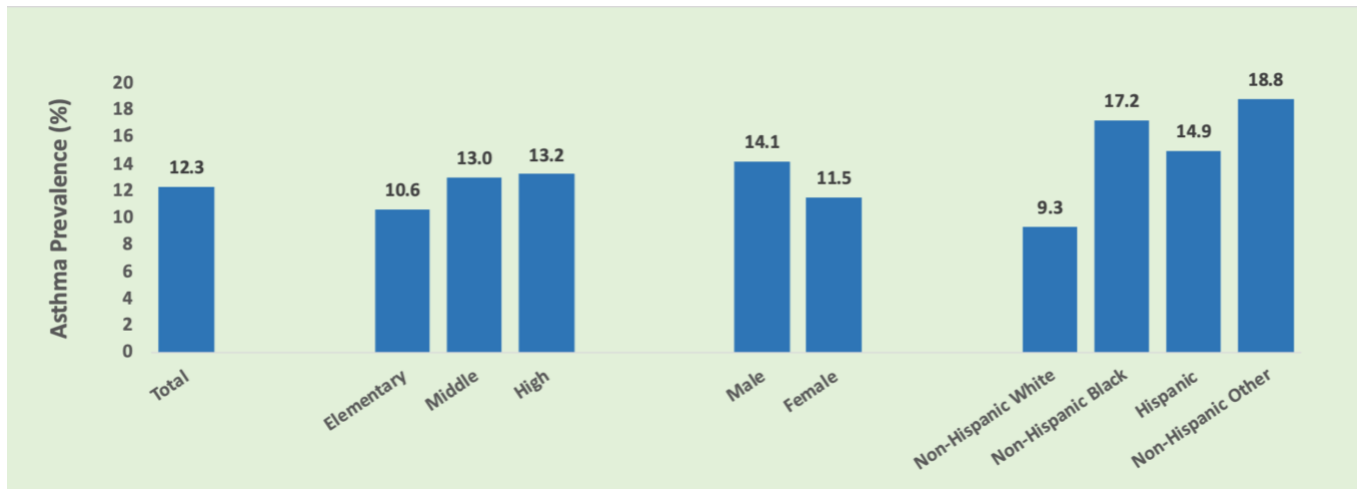


Table 4 presents the breakdown of school level asthma prevalence by demographic characteristics. Accordingly, middle school and high school students have higher asthma prevalence than elementary school students. By gender, males have a higher prevalence than females at each educational level. Additionally, females in middle school (11.9%) and high school (12.6%) have a higher prevalence than females in elementary school (9.9%).

Considering race and ethnicity, non-Hispanic white students in middle school (9.7%) and high school (10.0%) have a statistically higher prevalence than those in elementary school (8.3%). Non-Hispanic black students in elementary school (18.3%) and middle school (18.0%) have a statistically higher prevalence than those in high school (15.6%). Hispanic students in middle school (16.5%) have a statistically higher prevalence than those in high school (14.2%) and elementary school (14.2%). Non-Hispanic students of other races had a statistically higher prevalence in elementary school (21.1%) and high school (20.2%) than in middle school (15.8%).

C. Asthma Prevalence by Percent Eligible for Free and Reduced-Price Meals

During 2022-2023, for public school districts statewide, 42.4% of students were eligible for FRM. Percent FRM data were available for all districts and ranged from 0% to 100%. For analysis purposes, districts were grouped into four quartiles based on percentage of students eligible for FRM, with Quartile 1 representing districts with the lowest percent eligible for FRM, generally more affluent and low-need districts, and Quartile 4 representing districts with the highest percentage of students eligible for FRM, generally high-need districts. School districts in five of the ten largest cities (Bridgeport, Hartford, New Britain, New Haven, and Waterbury) in Connecticut, along with New London and Windham fell within the highest FRM quartile. The range of percent eligibility for FRM within each quartile are as follows, with each quartile representing an even number of districts: Quartile 1: 0-19% eligible; Quartile 2: 19.1-32.5% eligible; Quartile 3: 32.6-50.7% eligible; Quartile 4: 50.8-100.0% eligible.

As shown in Figure 3, school districts within Quartile 1 have the lowest asthma prevalence and school districts Quartile 4 have the highest asthma prevalence. Overall, at each increasing FRM quartile, the asthma prevalence increases. Asthma prevalence by FRM quartile ranged from 8.5% for Quartile 1, to 15.7% for Quartile 4.

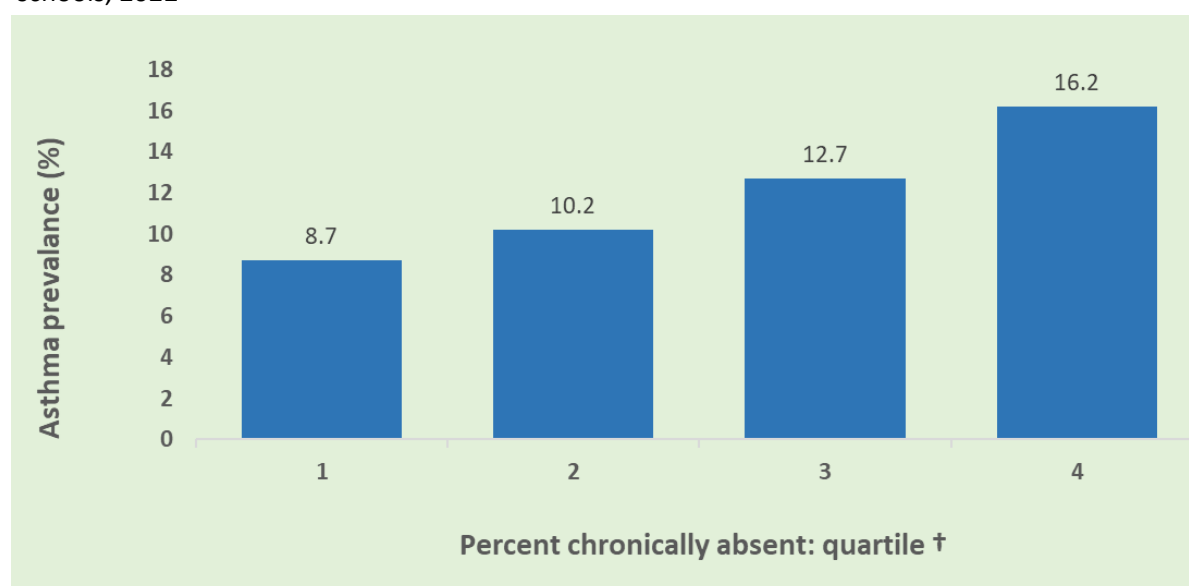

D. Asthma Prevalence by Percent Chronically Absent

Figure 2 shows asthma prevalence by percent of students chronically absent from school. Chronic absenteeism³ data are collected by SDE for local public-school districts, with chronically absent defined as missing ten percent or greater of the total number of days enrolled in the school year for any reason. For instance, students missing at least 18 days per 180-day school year would be considered chronically absent. Per SDE policy, students must attend school, either in-person or virtually, for at least half of the regular school day to be counted as attending. Pre-Kindergarten students are excluded from the calculation of percent chronic absenteeism.

As shown in Figure 4, school districts within Quartile 1 have the lowest asthma prevalence and school districts within Quartile 4 have the highest asthma prevalence. Overall, at each increasing level of chronic absenteeism, the asthma prevalence increases. Asthma prevalence by chronic absenteeism category ranged from 8.5 % for Quartile 1, to 16.0% for Quartile 4.

Five of the ten largest cities (Bridgeport, Hartford, New Britain, New Haven, and Waterbury) in Connecticut, along with New London and Windham were included in the highest chronic absenteeism quartile.

Table 6 shows the average asthma prevalence for each of the chronic absenteeism quartiles, by specific demographic characteristics.

E. Asthma Severity

The framework used to classify asthma severity is based on the Expert Panel Report (EPR) 3 Guidelines for the Diagnosis and Management of Asthma⁴. Accordingly, clinicians use the current impairment (nighttime awakenings, short-acting Beta2-agonist use, missed work/school days, normal daily activities engagement, quality-of-life assessments, and spirometry) domain and future risk (adverse effects, exacerbations, and progressive worsening of symptoms) domain as criteria for asthma severity classification. Asthma severity classification is important as it helps to guide the type, amount, and scheduling of medication therapy.

Table 7 shows asthma severity classification for the following categories: overall, school type, school level, gender, race, ethnicity, FRM quartile and chronic absenteeism quartile. Due to the small number of reported students classified as having moderate persistent or severe persistent, this report groups them together, thus the asthma severity is reported in the following groups: Intermittent, mild persistent, and moderate/severe persistent. Of note, nearly one-third of reports were categorized as unclassified severity. Reports categorized as unclassified may not represent students missing a medical categorization of asthma severity, rather it is likely that

level of severity was not noted in those students' HAR. The high percentage of unclassified severity may limit our understanding of the true asthma severity among students with asthma. These records were excluded from severity-specific analyses.

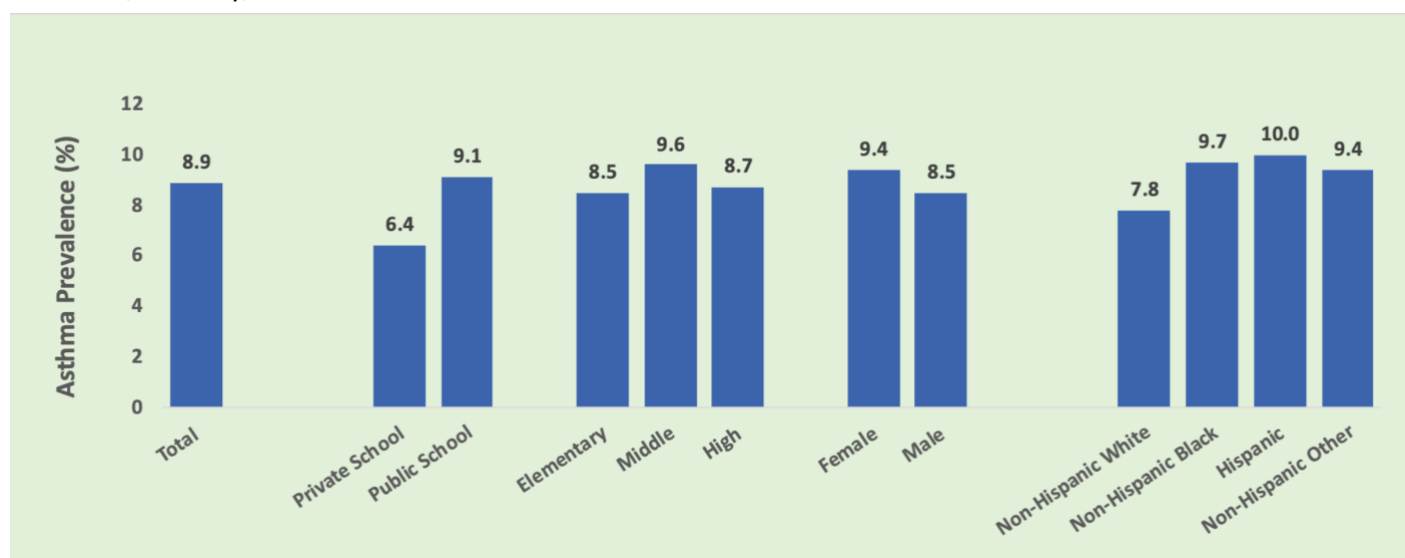

For each of the categories presented in Table 7, the proportion of asthma severity level is greatest among those classified as having intermittent (67.6%) asthma, followed by mild persistent (23.5%), and moderate or severe persistent (8.9%) asthma. This trend is consistent with that observed in the previous report.

Moderate or severe persistent asthma has been linked to increased likelihood for hospitalization or emergency department visit. Overall, 8.9% of students are affected with the moderate or severe persistent form of asthma. Figure 5 displays the percent classified as moderate or severe persistent among students with asthma by school type, school level, sex, and race/ethnicity. Students from public schools, compared to private schools, show a higher percentage of moderate or severe persistent form of asthma, 9.1% versus 6.4%, respectively. Students in middle school (9.6%) are affected the most with this form of asthma severity, followed by students at the high school (8.7%) and elementary school (8.5%) level, representing a shift from the previous report which found elementary school students to be the most affected. Hispanic students (10.0%) have the highest percentage of moderate or severe persistent asthma, followed by non-Hispanic Black students (9.7%), non-Hispanic students of other races (9.4%), and non-Hispanic White students (7.8%). The previous report found that non-Hispanic Black students had the highest percentage with moderate or severe persistent form of asthma. Students whose school districts fall within the 3rd highest category of FRM status (10.5%) are the most affected compared to any other FRM category. Those students in districts having the highest level of chronic absenteeism were also most affected by this form of asthma (10.3%).

Figure 5. Percent moderate or severe persistent asthma by school type, school level, sex, and race/ethnicity, 2022



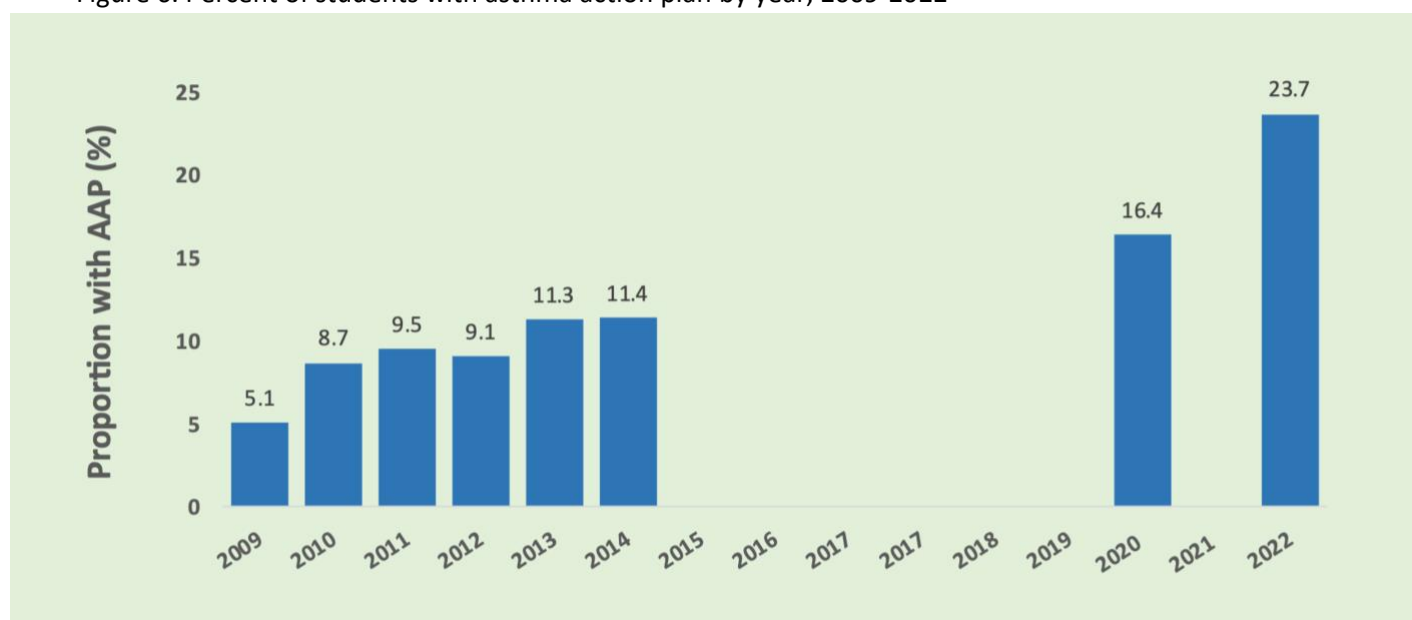
The number of students impacted by each level of asthma severity may be estimated based on the overall asthma prevalence among public school students. Based on the 2022-23 public school enrollment count of 124,465, an asthma prevalence of 12.3% (Table 3) roughly equates to 15,300 students with asthma. Applying the public-school specific prevalence per severity classification shown in Table 7 to 15,300 students gives the following estimates: 10,300 students with intermittent asthma; 3,600 students with mild persistent asthma, and 1,400 students with moderate or severe persistent asthma. Caution should be taken when interpreting these estimates as approximately one-third of records are missing severity classification.

F. Asthma Action Plan

The Centers for Disease Control and Prevention (CDC), recommends that each patient with asthma have their own written Asthma Action Plan (AAP)⁵. The AAP is designed based on signs and symptoms and/or spirometry results. The AAP is a written plan that is mutually developed by the clinician and the patient to control asthma episodes and/or exacerbations. The plan lists all the patient's medications with instructions on how and when to administer them to prevent episodes or during an exacerbation.

For the 2022-23 school year, 23.7% of students with asthma have an AAP, as reported by the HAR. This finding represents an increase of seven percentage points compared to the 2020-21 report (16.4%), and thirteen percentage points compared to the 2012-2014 report (10.6%). Figure 6 shows that the proportion of students with asthma who have an asthma action plan has generally increased since 2009.

Table 8 presents the percentage of students with asthma with an AAP by demographic characteristics. The proportion of students with asthma with an AAP was higher among those in private school (42.3%), about two-fold, than those in the public school system (22.1%). This finding also represents an increase from the previous report, by approximately 10 percentage points for private schools and seven percentage points for public schools. Considering school level, the higher the school level, the lower the proportion of students with an AAP. Elementary school (33.1%) had the highest proportion of students with an AAP, followed by middle school

(19.8%) and high school (16.3%). The proportion of students with an AAP among males (24.0%) was very similar to females (23.2%).

A higher proportion of non-Hispanic students of other races (33.1%) have an AAP, followed by non-Hispanic Black students (26.8%), Hispanic students (22.4%) and non-Hispanic white students

(21.4%). A higher proportion of students affected with moderate or severe persistent asthma have an AAP (44.0%), compared to those with mild persistent (34.1%) or intermittent (23.7%) forms of asthma.

When AAP prevalence was analyzed based on students' FRM category, it showed that Quartile 2 (23.3%) had the greatest proportion of students with an AAP, followed by Quartile 4 (22.4%), Quartile 1 (21.5%) and Quartile 3 (21.5%). An implicit relationship between a school's FRM classification and the proportion of students having an AAP could not be observed.

When considering level of chronic absenteeism, results show that students in districts with the highest level of absenteeism, Quartile 4, had the greatest proportion with an AAP (23.6%), followed those in Quartile 1 (22.6%), Quartile 2 (21.6%) and Quartile 3 (19.6%). No relationship between chronic absenteeism and the proportion of students having an AAP was observed.

G. Asthma Documentation and Health History

The SBASS survey requests asthma documentation information as submitted in the HAR or as evidenced by the school nurse. The HAR form is filled out by both the child's parent/guardian and the clinician performing the physical examination, in their corresponding sections.

Table 9 shows the percentage of students with various types of asthma documentation and asthma-related health history as provided in their HAR to a school nurse. Slightly more than four out of five students (85.3%) with asthma had a diagnosis documented in their HAR; less than half (42.1%) had a medication order in their HAR; 11.8% had a self-carry medication approval; 33.6% had asthma medication in school; 20.0% had an asthma-related parental note; and 11.2% had asthma symptoms observed.

HAR Part I is a section that is filled out by the student's parent/guardian. Approximately one out of every six students with asthma (17.9%) have been identified as having problems with breathing or coughing by their parents/guardian, and 34.4% of

students with asthma have had an asthma treatment in the past 3 years. HAR Part II is a medical evaluation including chronic disease indicators and is completed by the health care provider. As recorded in Part II, about 7.5% of students have exercise-induced asthma.

H. School District Profile on Asthma

Table 10 displays the top 10 school districts having the highest overall asthma prevalence, the highest percent of moderate or severe persistent type of asthma, and the highest percent of students having an asthma action plan.
