Carlie Shurtliff (UT) opened the meeting and led the introductions.

Karen Donoghue introduced Carolyn Bridges, CDC, the new lead for adult immunization at CDC, who presented an overview of adult immunization efforts and asked for comments and suggestions.

Suggestions and comments included:

- Having an award for adult immunizations at the NIC.
- Making it a requirement of the grant that the adult immunization coordinator attend the NIC.
- Include questions about adult vaccines other than flu and pneumo on the BRFSS.
- Consider including some requirements for adult immunization in the Immunization Program Operations Manual.

Ray Strikas (CDC) gave a brief overview of Program Area 5: Plan and Implement adult Immunization Programs, of the federal funding opportunity Prevention and Public Health Fund: Capacity Building to Strengthen Public Health Immunization Infrastructure and Performance.

Debby Rosen (CT) broke the participants into three small groups discuss 1) Community Partners and Collaborators; 2) Status of Adult Immunization Assessment Activities; and 3) Adult Immunization Coalition Activities and Projects. The results of these small group discussions are being summarized and will be distributed to all adult immunization coordinators.

Jean-Robert Jeoffroy (AZ) wrapped up the meeting and encouraged folks interested in serving on the NAICP executive committee to let Debbye Rosen know.
