Dear Connecticut COVID-19 Vaccine Providers,

This bulletin is sent to key contacts at provider organizations administering COVID-19 vaccine. Please share it with others in your organization who may benefit from the update. Note that all of our communications are archived on our [web site](#).

This bulletin contains several important updates and reminders.

### **16+ starts April 1**

A communication was sent out yesterday with important information for CoVP Providers to be ready for April 1. Click [here](#) to review this information.

- Beginning April 1, all individuals 16 years of age and older who live, work, or attend school in Connecticut are eligible to receive vaccine. Students attending school remotely and employees working remotely who reside outside of Connecticut should receive vaccine in their home states.
- Schedulers should be updated between 12:01am and 8am on April 1 to align to new eligibility – Pfizer providers should allow for scheduling for all individuals 16+ and Moderna and J&J providers should allow for scheduling for all individuals 18+.
- Parents or guardians of minors must consent to vaccination following your usual legal process—successful scheduling of an appointment does not serve as a proxy for consent.
- Providers should extend schedules through Sunday, May 2. No first doses should be offered after that date. Schedules should be extended based on current baseline allocations.

## Reminders

- If you want to see the latest Connecticut data on vaccine distribution and administration, visit the [CT Data Portal](#). COVID-19 vaccination data is updated weekly on Thursdays.
- Orders are due at noon on Tuesdays. Order requests should be based on Moderna and/or Pfizer doses needed, and assume J&J doses will NOT be provided. We have very little J&J vaccine available currently, so these orders can still be requested, but are unlikely to be fulfilled. Please provide information how you intend to use any J&J doses requested.
- Please hang the "[What to expect poster after COVID-19 vaccination](#)" poster at your clinics—we removed the patient specific section—to better serve mass vaccination clinic settings. Please encourage vaccine recipients to register for [V-safe](#) (now available in [multiple languages](#)). V-safe participants will receive text messages and web surveys in the language chosen when they sign up. Please maintain a wait list of eligible individuals in case vaccine becomes available that must be used within a narrow timeframe.
- Ensure that your clinic is protecting your vaccine against temperature excursions: Always store Moderna vaccines frozen (in the freezer) until the date of clinic.
- Report temperature excursions to the [Helpdesk](#) by submitting a ticket. Staff will be notified in real time of the excursion and will assist you. Please store vaccines in the storage unit in a paper bag marked "do not use" until a determination about the viability of the vaccine has been made, in consultation with the manufacturer and the Immunization Program.
- You should expect your second dose shipments of Moderna and Pfizer vaccines to arrive approximately 25 days after your first doses were received.

### **VAMS Clinics Quick Tip!**

- Clinics using VAMS can indicate which vaccine product / dose your clinic is offering.
- Use the options on the Clinic Setup screen to let recipients know your clinic's [vaccine product & dose #](#).
- This will be especially helpful for 16 and 17 years olds who should only schedule at clinics offering Pfizer vaccine.
