National Adult Immunization Summit Working Group Activities

Goals of the NAIS:

The goals of the NAIS are to:

- 1. Convene adult immunization stakeholders to represent all facets of the adult immunization process, from manufacturers to vaccinators to advocacy groups, public health and policy.
- 2. Facilitate identification of specific actions that can be taken by Summit members that will lead to improvements in vaccine uptake, such as through reducing barriers for payment, increasing access to vaccines and vaccinators, and increasing awareness of adult immunization recommendations.
- 3. Develop and sustain working groups within the Summit whose goals is implementation of specific actions identified.

Charge of the Working groups:

The charge of the NAIS working groups is to accomplish two or more actionable items by the time of next year's NAIS. The choice of the actionable items is up to each working group. Working groups should plan on reporting on their actions to the NAIS Steering Committee prior to the 2013 NAIS and at the 2013 NAIS.

To use the language of the NAIS goals, working groups should take specific actions that will lead to improvements in vaccine uptake, such as through reducing barriers for payment, increasing access to vaccines and vaccinators, and increasing awareness of adult immunization recommendations.

NAIS working groups will all include at least one federal employee who serves on the HHS Interagency Task Force on Adult Immunizations in order to provide the NAIS working group with updates on Task Force priority actions and vice versa.
