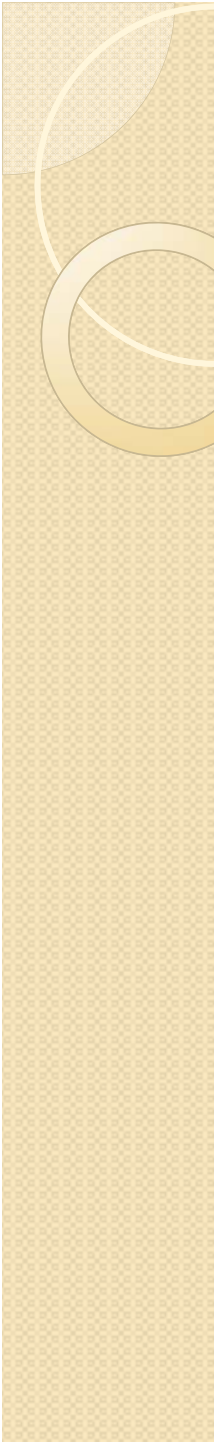




# Uninsured and Underinsured Adult Vaccine Program (UUAV)

- 116 participating clinics
- 3 year program (January 2011-December 2013)
  - Requested applications from any clinic or organization that regularly sees uninsured or underinsured adults
  - Vaccine (not money) awarded to selected facilities
- ~\$1.5 million of vaccine available each year (paid for with federal discretionary vaccine funding)
- Received over 160 applications requesting a total of \$10 million worth of vaccine over the three year period



**Objective: fill gaps in access to affordable immunizations for adults 19 years of age and older who are uninsured or underinsured in the state of Minnesota**



# Eligibility

Adults 19 years of age and older

- Uninsured
- Underinsured:
  - Patients with insurance that either does not cover vaccines, or that covers only selected vaccines (eligible for non-covered vaccines only)
  - Patients with insurance that caps prevention services (eligible after cap is reached)



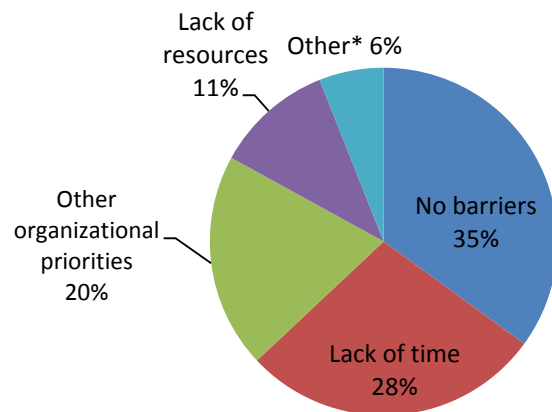

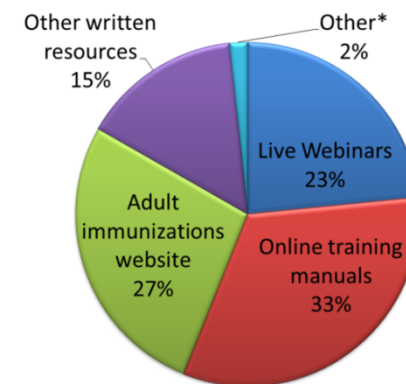
## Barriers to adult immunization administration

## Needs Assessment, cont.

- 99% use state registry--MIIC
- 49% send reminders when patients overdue
- Of those, only 46% send reminders to adult patients (n=23)



# UUAV Enhancements

## Providers:

- New webpage with specific provider information about adult immunizations
- Electronic waiting room messaging—adult immunizations and UUAV program
- Social media messaging for clinic websites

## Patients:

- New webpage with patient-centered information about adult immunizations
- UUAV clinic locator and general program information



## Enhancements, cont.

- Entering historical records into state registry (MIIC) for clinics requesting need
- Key informant interviews
- Creating guidance for 5-10 clinics to implement reminder/recall systems
