#### I. <u>MINUTES</u>

#### II. OLD BUSINESS

Declaratory Ruling – FAA BasicMed Examination

Dr. Carroccia mentioned that the time period for an appeal of the Declaratory Ruling to be filed in superior Court has been extended.

This decision was issued on February 27, 2020. The 45 day appeal period is scheduled to end on April 12, 2020.

Assistant Attorney General Daniel Shapiro confirmed that due to the current COVID-19 pandemic, certain filing time frames have been modified. The Board will be informed if an appeal is filed.
