Dr. Strathearn made a motion, seconded by Dr. Birmingham, to approve the Consent Order. The motion passed unanimously. Dr. Rutt signed the Order.

D. Peter Munk, D.D.S. - Petition No. 2004-0810-0020-058

David Tilles, Staff Attorney, Department of Public Health, presented a Consent Order in the matter of Peter Munk, D.D.S. Dr. <u>Munk</u> was not present or represented.

Dr. Strathearn made a motion, seconded by Dr. Friedman, to approve the Consent Order. The motion passed with all in favor except Dr. Birmingham who abstained. Dr. Rutt signed the Order.

E. William Sherman, D.M.D. - Petition No. 2005-0104-002-004

David Tilles, Staff Attorney, Department of Public Health, presented a Consent Order in the matter of William Sherman, D.M.D. Dr. Sherman was not present or represented. Dr. Strathearn made a motion, seconded by Dr. Friedman, to approve the Consent Order. The motion passed unanimously. Dr. Rutt signed the Order.

# IV. <u>New Business</u>

A. <u>Regional Clinical Skills Examinations / American Board of Dental Examiners</u> Roger Ostrander, DMD former Chairman of the Connecticut State Dental Commission addressed the Commission regarding American Board of Dental Examiners (ADEX) and the development of a uniform national dental examination. Jennifer Filippone, Section Chief, Practitioner Licensing and Investigation was present for this discussion.

Dr. Ostrander explained that the purpose of the examination is to determine the minimum competency of the examinee. Dr. Ostrander also reported that the regional examination agencies will administer the examination but will no longer be involved in examination development. ADEX will be developing the examination.

Dr. Strathearn made a motion, seconded by Dr. Birmingham, that the Department of Public Health apply for membership with ADEX so that the examination can be utilized for Connecticut dental licensure applicants. The motion passed unanimously. Ms. Filippone indicated she would speak with the Assistant Attorney General regarding a membership agreement that ADEX requires.

Dr. Strathearn made a motion, seconded by Dr. Katz, recommending that the Department of Public Health pursue a technical legislative change that would allow clinical examinations to be approved by the Commission with the consent of the Commissioner of the Department of Public Health. The motion passed unanimously.

# B. <u>Meeting Dates 2006</u>

Stephen Carragher, Health Program Supervisor, Office of Practitioner Licensing and Certification was present for this discussion.

The Commission recommends that the form that will be used for the verification of dental residency training, as required by Public Act 05-213, include a place for notarization. Dr. Katz made a motion, seconded by Dr. Rutt, to approve the verification form as modified. The motion passed unanimously.

# V. <u>Adjourn</u>

Dr. Birmingham made motion, seconded by Mr. Marks, to adjourn the meeting. The motion passed unanimously, and the meeting adjourned at 2:40 p.m.
