The meeting was called to order at by Dr. Ostrander at 1:00 p.m.

#### I. Minutes

The minutes of the August 30, 2004 meeting were reviewed. Dr. Friedman made a motion seconded by Dr. Malon, to approve the minutes with corrections. The motion passed unanimously.

#### **II.** Executive Session

Dr. Rutt made a motion, seconded by Dr. Malon, to enter executive session to discuss pending litigation with Assistant Attorney General Linsley Barbato regarding Marc Breiner, DDS. The motion passed unanimously and the Commission entered executive session from 1:01 p.m. to 1:15 p.m.

# III. Old Business

# A. Wendy Mendlinger, Petition No. 2001-0608-000-058

The Commission noted that the State Appellate Court upheld the appeal of respondent Wendy Mendlinger, thereby reversing the decision of the Superior in dismissing respondent's appeal of the Commission's August 26, 2002 Memorandum of Decision.

The Commission by way of these minutes requests the Department of Public Health pursue legislation that would re-enact §20-122 of the General Statutes, which had imposed a time limit upon on an executor operating a dental practice of a deceased dentist.

# B. Frederick Hamilton, DDS

Dr. Hamilton addressed the Commission concerning his difficulty in fulfilling the Commission's recommendation from June 7, 2004 regarding the reinstatement of his dental license.

Dr. Ostrander will call the UCONN dental school in an effort to help Dr. Hamilton set up an evaluation. The Commission will not modify its June 2004 recommendations.

# IV. New Business

# A. Foreign Trained Dentists

The commission reviewed proposed legislation that would establish a residency training requirement for foreign trained dentists. The commission is not opposed to the concept of

PGY-1 but feels that there must also be a clinical qualifying licensing examination to determine an applicants competency.

#### B. Amalgam Filings

Assistant Attorney General Daniel Shapiro informed the Commission that the Department of Environmental Protection received a declaratory ruling request asking if the use of dental amalgams violates Connecticut law. Mr. Shapiro stated that the request has been rejected because of filing technicalities.

Dr. Strathearn made a motion, seconded by Dr. Friedman, that the Assistant Attorney General, on behalf of the Commission, file a request for intervenor status if the request for declaratory ruling is renewed. The motion passed unanimously.

# C. Scope of Practice Inquiry – Whitening Trays

Kathleen Boulware, Supervising Nurse Consultant, Department of Public Health was present to inquire as to the use of whitening trays by dental hygienists.

Connecticut General Statute § 20-161 sates in part that a licensed dental hygienist shall in no event perform the following dental services . . . the taking of any impression of the teeth or jaws or the relationship of the teeth or jaws for the purpose of fabricating any appliance or prosthesis . . .

During its discussion, it was the consensus of the Commission that anything applied or worn in the mouth is an appliance.

# IV. Old Business

# A. <u>Licensure /Examination</u>

At its December 2003 meeting, the Dental Commission requested the Department to consider revising the examination requirements for licensure. Jennifer Filippone, Public Health Services Manager, Office of Practitioner Licensing and Certification notified the Commission today that Commissioner Galvin consents to the following changes in the examination requirements for dental licensure.

- Candidates for dental licensure in Connecticut must successfully complete all components of a regional board examination. An overall passing score is not sufficient.
- Candidates who pass the clinical performance tests offered by the Central Regional Testing Service, the Southern Regional Testing Agency or the Western Regional Examining Board must also pass the diagnostics component of the clinical performance test offered by the North East Regional Board These changes are to become effective October 1, 2004.

# B. <u>Declaratory Ruling - Oral and Maxillofacial Surgeons</u>

Assistant Attorney General, Peter Brown was present to counsel to the Commission.

Dr. Strathearn made a motion, seconded by Dr. Friedman, to enter executive session to obtain legal advice from the Assistant Attorney General. The motion passed unanimously and the Commission entered executive session from 2:05 p.m. until 2:20 p.m.

Following executive session Dr. Malon made a motion, seconded by Dr. Strathearn to amend the proposed declaratory ruling by adding language that the ruling is consistent with current statutes and recommending that the current statutes be revised. The motion passed with all in favor except Dr. Friedman who was opposed.

Dr. Strathearn made a motion, seconded by Dr. Rutt, to adopt the declaratory ruling with the recommended amendment and to authorize Dr. Ostrander to sign the ruling when the amendment has been added.

The motion passed with Dr. Strathearn, Dr. Rutt, Ms. Sadler and Dr. Ostrander voting in favor. Dr. Friedman, Dr. Malon and Dr. Birmingham were opposed.

#### V. Additional Item

Nancy Nicolescu, Office of Government Relations, Department of Public Health informed the Commission as to Special Act # 04-07 which establishes an ad hoc committee for the purpose of assisting the Commissioner of the Department of Public Health in examining and evaluating possible statutory changes pertaining to the practice of dentistry, including changes to the dental practice act. Also discussed is the possibility of hearing officers conduct disciplinary hearings and make proposed findings to the Dental Commission.
