B. Daniel Shapiro, reported on declaratory ruling from the Medical Board concerning electrologist working on Nevi (mole). In summary, the possibility that a mole's composition might change if a hair is removed from it does not mean that the procedures to do so are outside the scope of the practice of electrology. The medical board has decided to have the electrolysis board conduct their own ruling. After general discussion, the board has recommended any person that requests Electrolysis in a Nevi seeks medical clearance through their Dermatologist or Primary Care Physician. Dr. Alicea Zalka made motion to withdraw medical declaratory ruling and approve recommendation, seconded by Jan O'Neil. Unanimously approved.
