The Board heard argument from Attorney Antonetti and Attorney Dinnan regarding the proposed Memorandum of Decision as well as a Department of Public Health motion to modify the proposed decision.

Dr. Bridburg, Ms. Warner and Ms. Doremus provided a synopsis of the hearing panel's findings and recommendations.

Dr. Manohar made a motion seconded by Dr. Fuller to modify the proposed decision by adding a requirement for no solo practice; that respondent provide a copy of the decision to any and all employers and that respondent's employer provide reports to the Department of Public Health. The motion passed with all in favor except Ms. Stankaitis who abstained and Mr. Hebb who recused himself.

Dr. Bridburg made a motion, seconded by Dr. Manohar, to adopt the decision as modified and to authorize Dr. O'Neill to sign the Order when revised. The motion passed with Dr. O'Neill, Dr. Manohar, Dr. Bridburg, Ms. Warner and Ms. Doremus voting in favor of the motion. Dr. Fuller, Dr. Wolf and Ms. Stankaitis were opposed and, Mr. Hebb recused himself.

B. Oral Argument Proposed Memorandum of Decision

Sushil Gupta. MD - Petition No. 2005-0502-001-115

Assistant Attorney General Daniel Shapiro was present to provide counsel to the Board. Staff Attorney David Tilles was present for the Department of Public Health. Attorney Hugh Keefe was present with Dr. Gupta.

The Board heard argument from Attorney Tilles and Attorney Keefe regarding the proposed Memorandum of Decision as well as requests to modify the proposed decision filed by the Department and respondent.

Dr. Bridburg and Mr. Hebb provided a synopsis of the hearing panel's findings and recommendations. During discussion Dr. Wolf and Dr. O'Neill spoke in opposition to the proposed decision that would suspend respondent's license and impose a civil penalty.

Dr. Wolf made a motion seconded by Dr. Fuller to reject the decision as written. The motion passed with all in favor except Mr. Hebb who was opposed and Ms. Warner who recused herself.

Dr. Wolf made a motion, seconded by Dr. Bridburg, to modify the proposed decision by ordering the revocation of respondent's license and to authorize Dr. O'Neill to sign the Order when revised. The motion passed with all in favor except Dr. Manohar who was opposed, Mr. Hebb who abstained and Ms. Warner who recused herself.

During the above discussion Dr. Bridburg reported that on or about the end of December 2005 he received, by U. S. mail, an envelope sent to him by respondent. Dr. Bridburg stated he did not open the envelope. Dr. Bridburg commented that whereas he feels it was inappropriate for Dr. Gupta to attempt communicate with him, this fact did not influence his decision in this matter. Attorney Keefe expressed his exception to Dr. Bridburg raising this issue.

III. <u>INFORMATION UPDATES</u>

A. <u>Department of Public Health</u> None

B. <u>Connecticut State Medical Society</u>

Michele Norbeck reported that discussions have been held between representatives of the Medical Society, the Department of Public Health, the Assistant Attorney General and Dr. O'Neill regarding the penalty guidelines. Further discussions are planned.

The Department of Public Health and the Medical Society have also held meetings concerning enhancements to the Physician Health Program (PHP). The department has submitted proposed revisions to the existing protocols for physician impairment matters. The medical society plans to have the proposal reviewed by the PHP, the Physician Health Committee and then the societies leadership. Ms. Norbeck provided the following statistics pertaining to PHP matters:

During the period 1994-2005, the total number of referrals made to the PHP was 249.

- 89 of those cases were closed with the concurrence of the DPH, with no finding of impairment that rendered the individual not able to practice with skill and safety.
- 30 referrals were of non-CT licensed physicians
- A total of 68 cases were referred to DPH; (52 with no ongoing PHP involvement and 16 with ongoing PHP involvement/monitoring.)
- 55 cases were actively being monitored by the PHP at end of 2005
- 3 cases were in evaluation
- 3 cases PHP recommended closure and waiting for DPH response.

Ms. Norbeck also reported that the Medical Society is in support of House Bill 5718 "An Act Concerning a Professional Assistance Program for Health Care Professionals" that has been raised during the current legislative session.

C. <u>Legislative</u>

Karen Buckley-Bates, Department of Public Health Office, Office of Government Relations reported that the Department is tracking a number of proposed bills including changes to physician assistant supervision; hospital acquired infections; podiatric scope of practice, and nurse midwife scope of practice and licensure. Ms. Buckley-Bates commented that the Department is not opposed to the concept of House Bill 5718 but does oppose aspects of the proposed language.

Maritsa Morales, Licensing and Applications Specialist, Department of Public Health presented information for the Board to review to determine if Dr. Iragorri's education and training are equivalent to 2 years of ACGME accredited residency training.

IV. <u>NEW BUSINESS</u>

A. <u>Connecticut State Medical Society – Physician Health Program</u>

Douglas Gibson, MD, Medical Director and Michele Norbeck, Director provided an overview of the Connecticut State Medical Society (CSMS) Physician Health Program (PHP). It was explained how referrals to the PHP are received and the process by which candidates are initially interviewed and referred for evaluation. A CSMS committee then reviews the evaluator's treatment/monitoring recommendations. The current protocol between the CSMS and the Department of Public Health and Confidential Consent Orders were also discussed, including the process that is followed for practitioners who are in violation of confidential orders.

Dr. Gibson stated that the CSMS is currently holding informational meetings about the PHP at Connecticut Hospitals. He commented that as of April 18, only four physicians have been referred to the PHP during 2006. There have been more referrals from other professions such as dentists, nurses, veterinarians and physician assistants.

House Bill 5718, which would establish a program for impaired health care professionals, was mentioned with reference to ongoing discussions raised by the Department of Public Health concerning the proposed legislation.

B. <u>Proposed Memorandum of Decision – Christian Ertl. MD - Petition No. 2003-1030-001-244</u> Dr. Goldenberg and Ms. Doremus provided a synopsis of the hearing panel's findings and recommendations for dismissal of this case.

Dr. Bridburg made a motion seconded by Dr. Manohar to adopt the decision as written. The motion passed with all in favor except Ms. Noel who recused herself. Dr. O'Neill signed the decision.

The Board noted a recent pattern of dismissal in cases involving medical practice. It has been found during hearings that Department of Public Health (DPH) experts have not been credible and/or that the DPH did not have all necessary information/records at the time of consultant review. Stanley Peck, Section Chief, Legal Office, commented that the Department is taking steps to resolve these issues.

Ms. Norbeck announced that she is retiring and that this would be the last meeting she will attend on behalf of the Medical Society. Dr. O'Neill expressed the Board's thanks for Ms. Norbeck's many years of service to the Medical Society and the Physician Health Program.

IV. <u>NEW BUSINESS</u>

A. <u>An Act Concerning Patient Protection and Health Care Practitioner Security Fund</u> Stanley Peck, Section Chief, Legal Office, Department of Public Health (DPH) provided an overview of legislation proposed by the DPH which would establish a confidential program for impaired health care practitioners licensed by the department; provide funding for DPH consultants; and provide funding to the DPH for medical record management in situations in which a practitioner has abandoned a practice. Mr. Peck stated that this legislation would result in a \$10.00 surcharge added to annual license renewals with the monies deposited in a designated fund.

Dr. O'Neill stated that at the January 2007 meeting, the Connecticut State Medical Society will make a presentation concerning similar legislation it is proposing for the 2007 legislative session.

B. <u>Memorandum of Decision Suvarna Shah, MD – Petition No. 2004-0517-001-105</u>

Mr. Hebb, a hearing panelist in this matter, provided a synopsis of the hearing panel's findings and recommendation for license revocation.

Dr. Manohar made a motion, seconded by Dr. Bridburg, to adopt the proposed Memorandum of Decision.

The motion passed unanimously. Dr. O'Neill signed the Order.

C. <u>Memorandum of Decision Christian Ertl, MD – Petition No. 2004-1103-001-251</u> Mr. Hebb, a hearing panelist in this matter, provided a synopsis of the hearing panel's findings and recommendation for dismissal.

Dr. Wolf made a motion, seconded by Dr. Hanks, to adopt the proposed Memorandum of Decision. The motion passed unanimously. Dr. O'Neill signed the Order.

D. Charles Jones, MD - Petition Nos. 2004-0917-001-221 2006-0111-001-010 2006-0401-001-069 2006-0407-001-068 Department of Public Health Motion to Consolidate

Respondent's Objection and Motion for Mistrial

Assistant Attorney General Thomas Ring was present to provide counsel to the Board. Staff Attorney David Tilles was present on behalf of the Department of Public Health. Attorney Elliot Pollack was present on behalf of Dr. Jones.

Oral argument was heard from Attorneys Tilles and Pollack regarding the Department's Motion to Consolidate. Following argument Dr. Fuller and Ms. Doremus, hearing panelists in Petition No. 2004-0917-001-221, expressed their opinions regarding the motion. Dr. Fuller was opposed and Ms. Doremus was in favor of consolidating.

Dr. Fuller made a motion, seconded by Dr. Hanks, to deny the motion to consolidate. The motion failed. Dr. Fuller, Dr. Hanks, Dr. Wolf, Dr. Bridburg and Mr. Hebb voted in favor of denying the motion to consolidate. Dr. O'Neill, Dr. Goldenberg, Ms. Doremus, Ms. Nole Ms. Stankaitis, Ms. Loving and Dr. Manohar were opposed.

Dr. O'Neill made a motion, seconded by Dr. Manohar, to grant the motion to consolidate. The motion passed. Dr. O'Neill, Dr. Goldenberg, Ms. Doremus, Ms. Nole Ms. Stankaitis, Ms. Loving and Dr. Manohar voted in favor of granting the motion to consolidate. Dr. Fuller, Dr. Hanks, Dr. Wolf, Dr. Bridburg and Mr. Hebb were opposed

Oral argument was heard from Attorneys Pollack and Tilles regarding respondent's Motion for Mistrial. It is respondent's claim that the issuance of a new Statement of Charges constitutes an exparte communication.

Dr. Fuller made a motion, seconded by Dr. Bridburg, to deny respondent's motion for mistrial. The motion to deny passed unanimously.

V. <u>OLDBUSINESS</u>

<u>Joel Singer, MD – Petition No. 2005-0104-001-005 - DPH Motion to Withdraw Statement of Charges</u> Assistant Attorney General Thomas Ring was present to provide counsel to the Board. Attorney Mary Alice Moore Leonhardt was present on behalf of Dr. Singer. Staff Attorney David Tilles was present on behalf of the Department of Public Health. Attorney Tilles explained that the Department has revaluated its position after contacting a new consultant who is preparing an opinion for the Department. Mr. Tilles stated that based on conversation s with the new consultant the Department is prepared to pursue this matter and will amending the current Statement of Charges. Mr. Tilles orally moved to withdraw the Department's Motion to Withdraw Statement of Charges. Mr. Hebb made a motion, seconded by Dr. Wolf, granting the Department's oral motion withdrawing its Motion to Withdraw Statement of Charges. Mr. Hebb's motion passed unanimously. Prior to this meeting respondent filed a Motion to Dismiss the Statement of Charges. Argument was heard from Attorneys Leonhardt and Tilles regarding the motion to dismiss. Dr. Wolf made a motion, seconded by Dr. Bridburg, to deny respondent's motion to dismiss. The motion to deny passed with all in favor except Dr. Fuller who abstained.

VI. <u>LEGAL OFFICE BUSINESS</u>

A. <u>Edward. Watson, MD – Petition No. 2005-0505-001-121</u>

Matthew Antonetti, Principal Attorney, Department of Public Health presented a Consent Order in the matter of Edward Watson, MD. Attorney Eugene Cooney was present on behalf of Dr. Watson. Dr. Hanks made a motion, seconded by Dr. Manohar, to approve the Consent Order. The motion passed unanimously. Dr. O'Neill signed the Order.

VII. <u>ADJOURNMENT</u>

As there was no further business, the meeting was adjourned at 3:15 p.m.
