B. <u>Hyperbaric Oxygen Therapy</u>

Jennifer Filippone, Section Chief, Practitioner Licensing and Investigations reported that it has come to the Department of Public Health's attention that some natureopathic physicians in Connecticut may be performing hyperbaric oxygen therapy. Ms. Filippone indicated that for naturopathic physicians to be allowed to perform this task in Connecticut in accordance with Connecticut General Statutes, Section 20-34, a three-step process must be followed to add this procedure to the naturopathic physicians; this task must recognized by the Council on Naturopathic Medical Education; and there must be approval from the Commissioner of the Department of Public Health. Ms. Filippone stated that a review of Board minutes and department files does not indicate that this three-step was followed despite a 1998 letter written by former chairman Robert Murphy, ND.

This matter will be discussed further at the next Board meeting.
