#### Practical Examination

#### **Continuing Education**

Mr. Carragher reported that at this time continuing education requirements are still suspended as part of the license renewal requirements put in place due to the COVID pandemic. It is anticipated that any restrictions will be removed soon.

#### Investigations

Mr. Kardys reported that there is currently one investigation of an optical establishment being conducted by DPH.

### III. Open Forum

Proposed Optical Shop Legislation

There was discussion regarding proposed legislation SB 329 - AN ACT CONCERNING THE RETAIL OPERATION OF OPTICAL ESTABLISHMENTS, OFFICES AND STORES.

Ms. Rivard and Mr. Mead as well as attendees indicated their opposition to this legislation in that it would pose a danger to public health and safety. It was encouraged that testimony in opposition to this proposed legislation be sent to the General Assembly's Public Health Committee.
