### I. MINUTES

# II. CONTINUING EDUCATION UPDATE

Stephen Carragher, Health Program Manager, Department of Public Health, Office of Practitioner Licensing and certification discussed that due to the CIVOD-19 pandemic the Commissioner of Public Health has been authorized to waive licensing, renewal, and inspection. The renewal policy states that is active on or after March 30, 2020, will not expire during the COVID-19 civil preparedness emergency. Licensees will be able to renew their license at any time now and during a six-month period following the date of the resumption of the normal renewal requirements.

In addition, Governor Lamont issued Executive Order 7DD suspending the continuing education requirements for optometrists. Licensees with expiration dates between March 10, 2020 and February 28, 2021 are not required to complete the continuing education required for license renewal.
