Dr. Lefland made a motion, seconded by Ms. Barrett, that the Connecticut Board of Examiners for Optometrists, cannot and will not support a change to the one year expiration date for a contact lens prescription. The Standard of Care has been and continues to be to evaluate all contact lens wearers on a yearly basis. The one year contact lens expiration date ensures that a CL patient visits his/her eye care provider annually to confirm that the contact lenses are not causing medical complications or injury to the eyes.

Yearly examination also allows the practitioner to reinforce proper care and wearing schedules and to discuss new modalities and options that may be appropriate as the patient's age or visual situation changes.

The Board therefore firmly opposes any changes to Section 1, Section 19a-908 of the CT General Statutes as proposed in LCO 154.

B. MEMORANDUM OF DECISION

Ross Zeldes, OD – Petition No. 2021-220

The Board reviewed the Memorandum of Decision in the referenced matter. Dr. Lefland made a motion seconded Ms. Barrett to adopt the decision which imposes license suspension for six months with concurrent probation for 2 and one half years.
