Mr. Carragher stated the Department of Public Health may accept license of any state board of podiatry examiners or duly authorized licensing agency of any state in the United States or in the District of Columbia, if the department finds that such applicant has been graduated from a chiropody or podiatry school or college recognized by the Connecticut Board of Examiners in Podiatry at the time of his graduation from such school or college and that such state board or licensing agency maintains standards for licensure determined by the department to be equal to or higher than those of Connecticut.

B. Public Act 2018-168 (Sections 69 -71)

The Board reviewed sections 69 – 71 of Public Act 2018-168. These sections make changes to Chapter 375 – PODIATRY of the Connecticut General Statutes.
