Mr. Bernhard made a motion, seconded by Dr. Londono, that respondent's license be placed on probation for a period of eighteen months during which time respondent must engage the services of a license veterinarian as a practice supervisor. The practice supervisor must submit evaluation reports to the Department of Public Health on a monthly basis for the first six months of the probationary period, quarterly for the remainder. In addition, Respondent's practice is permanently restricted such that he is prohibited from administering rabies vaccinations to any animal and that he is prohibited from delegating the rabies vaccination of any animal which is contradictory to the statutes, regulations or the standard of care for such vaccinations. The motion passed unanimously.
