- 3) Project Stratford Health Department
 - Andrea Boissevain discussed a project with the group. The Stratford Health Department will be hosting a SCSU undergraduate public health student.
 The intern will complete a 270 hour internship.
 - The project the intern will be working on will be to develop a widget which
 will measure outdoor air quality. The widget will be posted on various
 town websites and residents will have access to the widget. An example: if
 a resident has asthma, they can visit the website and view the widget on
 any day to determine if the outdoor air quality is such that it may affect
 their asthma more on that day.
 - The intern will develop the widget, develop a communication plan and offer a pre/post survey to measure the knowledge/behavior modifications.

• Carolyn Wysocki mentioned that there is proposed legislative language on identifying quality of air affects for activities like wood burning smoke. There are several partners supporting this: ECHO, ALANE and DEEP.
