Andrea: requested \$50,000 from for lead abatement from CDBG received \$20,000; to assist low and moderate income people. Will prioritize families referred because of a lead-poisoned child

Krista – Lead updates:

- Data matching with lead data and HUD address data, partnership is working well
- Recently provided New Haven Housing Authority a training
- Commissioner's Semi-Annual need to see if new Commissioner is amendable to letting us use the June meeting for lead or if we may need to wait for the next one
- Kim is working with CTCHN to post lead information on medical provider and patient portal & will start talks with arranging Medicaid reimbursement for lead case management and inspection work
- Working with Southwest AHEC to develop a training curriculum for community health workers
