SHIP Policy Agenda Laurie Ann	15 min	<ul> <li>Topics for final consideration at Advisory Council Meeting on 11/19/2019</li> <li>Expand on recommendation made at Summit about trauma screening</li> <li>It was noted that establishing a trauma screening billing code would need to be taken up with the American Medical Association (AMA). The challenge with establishing a code is being able to quantify the code and understand it from a billing perspective. It can remain on the policy agenda even though it is not actionable due to lack of sponsorship. It is an issue that people should be aware of.</li> <li>Additional items to add to SHIP Policy Agenda:</li> <li>Opioids: The team wanted to consider the possibility of requiring that naloxone be made available next to automated external defibrillators.</li> <li>Marijuana: The team is interested in focusing on education and prevention</li> </ul>

SHIP 2.0 Laurie Ann	20 min	Overview of where we are in the process:  a) SHA Public Comment  SHIP partners were invited to comment on draft chapters of the State Health Assessment (SHA). All comments will be distributed to DPH Team Leads to consider for final versions of the SHA.  b) Framework Matrix – inclusion process  SHIP 2.0 will be organized around the social determinants of health (SDoH). During the SHIP Summit, attendees participated in an exercise where they were first asked to prioritize their top five most important/relevant health indicators that would have the most impact on improving the health of CT residents. Secondly, participants were asked to identify all of the SDOH that contributed to, or most impacted their identified top five health indicators. During the final step of the exercise, participants were asked to write their top five health indicators on post-it notes and place them on SDOH flip charts posted around the room. Housing,
