SUECT: Nursing Home Staff Testing Care Partner Assignments

The attached Nursing Home "Care Partner" assignments have been finalized. Please be aware that changes to the assignments would create challenges to the process and would negatively influence the testing strategies that have been developed.

Transition Period. The state's weekly testing mandate became effective on June 14, 2020. DPH expects that nursing homes will make a good faith effort to begin weekly testing through the Care Partners as soon as possible and is not expecting strict compliance with the executive order while Care Partner assignments and initial scheduling is underway.

Transitioning to Care Partners. In the absence of a Care Partner assignment, some facilities have been testing directly through laboratories that recently conducted the Point Prevalence Survey (PPS) or have been working with Physician One. Beginning the week of June 22, 2020, all nursing homes that have been working directly with one of the state-contracted labs or Physician One should begin working with their Care Partner to transition their testing schedule. Nursing facilities who have been working with Physician One and have been assigned Physician One as their Care Partner should continue to work with Physician One.

Nursing Home Staff and Resident Testing: Summary of State Support for Initial Implementation



June 17, 2020

On June 1, 2020, Governor Lamont issued Executive Order 7UU which, in part, mandates weekly COVID-19 testing for all nursing home facility staff and residents beginning June 14, 2020, and continuing for the duration of the public health and civil preparedness emergency. To support the implementation of this Executive Order, the state has contracted with several organizations (Nursing Home Testing Contractors) to provide resident and staff testing.

As this plan continues to evolve, some of the details contained in this document may change. This includes matters such as the number of contractors being retained to conduct the testing, the duration of the time the state will be leading and funding testing efforts in nursing homes, and the budget and funding sources available for this purpose. Should there be any updates or changes to any of these substantive details, DPH will inform stakeholders such as legislators, municipal leaders, local health directors, the long-term care industry, labor, residents and families, and many others as soon as possible.

Staff Testing: Except where there is coverage under Medicare Part B or Medicare Advantage plans, the state will cover the cost of all nursing home staff testing provided by these contracted organizations during the Initial Implementation Period ending August 31, 2020. No bills will be sent to nursing facility employees.

Resident Testing – Medicaid: During the Initial Implementation Period ending August 31, 2020, the state will pay the cost of testing for all nursing home residents covered by Medicaid.

Resident Testing – Non-Medicaid: Nursing Home Testing Contractors (NHTCs) will collect resident insurance information and bill testing to insurers, including Medicare Part B and Medicare Advantage plans, directly. During the Initial Implementation Period ending August 31, 2020, the state will pay the cost of resident testing that is not reimbursable through a nursing home resident’s insurer.

Start Date of Initial Implementation Period – June 14, 2020	NHTCs will begin reaching out to nursing homes to develop testing schedule; testing to begin no later than the week of June 14, 2020
End Date of Initial Implementation Period – August 31, 2020	The state-funded testing for staff and residents will end on August 31, 2020; nursing homes are required to test staff weekly or until testing identifies no new cases of COVID-19 among staff or residents over at least 14 days since the most recent positive result while the Executive Order remains in effect
