As Connecticut prepares for statewide testing and with nursing home residents a high priority, it is important that data be collected to inform future decision making. It is essential as we move forward that we get a clear understanding with regards to volume of testing, laboratory capabilities, relationships that congregate settings have with laboratories, and challenges to testing that facilities may have.

Our records show that your facility currently collects and/or tests COVID-19 patient samples. I am writing to ask for your assistance with increasing capacity in the state-wide COVID-19 testing network.

Demand for COVID-19 Testing is expected to increase significantly as our state reopens during 2020. The Connecticut Department of Public Health (DPH) and partners are working to remove testing capacity constraints and meet our future demand.

To do this effectively, our Department needs a live view of capacity in Connecticut. Specifically:

- Current capacity samples/tests collected in last 24 hours
- Current utilization maximum number of samples/tests which *could* have been collected in last 24 hours, had demand been greater
- Capacity constraints view on which factors limit current capacity, and on-hand supplies of key constraints; labor, PPE, consumables, storage space, delivery and other constraints
- Existing relationships facilities with whom your facility currently collaborates; populations your facility is currently testing such as asymptomatic in-patients

The DPH has developed a short survey, which can be accessed through a web link. Because of the criticality of this effort, from May 8th 2020 - all CT facilities processing COVID-19 samples or tests are required to complete this survey daily. We ask that this survey is completed before 10 am using information from the previous working day.
