SUBJECT: Order of Production of Records

Connecticut General Statutes §19a-14(a)(10) authorize the Connecticut Department of Public Health (DPH) to order the production of records related to DPH regulated professions and the Department's duties with regards to boards and commissions.

Sec. 19a-14(a)(10) *Conduct any necessary review, inspection or investigation regarding qualifications of applicants for licenses or certificates, possible violations of statutes or regulations, and disciplinary matters. In connection with any investigation, the Commissioner of Public Health or the commissioner's authorized agent may administer oaths, issue subpoenas, compel testimony and order the production of books, records and documents. If any person refuses to appear, to testify or to produce any book, record or document when so ordered, a judge of the Superior Court may make such order as may be appropriate to aid in the enforcement of this section;*

The attached Order of Production of Records is sent to you in accordance with §19a-14(a)(10) of the General Statutes.

Facilities are required to respond only if it possesses records responsive to the Order of Production.

By authority of the State of Connecticut, pursuant to §19a-14(a)(10) of the General Statutes, you are hereby commanded to produce records before the Commissioner of the Department of Public Health or his agent on or before the sixth day of October 2021. You are to produce for inspection:

Any exemption form signed by Sue McIntosh, MD related to vaccine requirements, the wearing of facial masks, and/or COVID testing issued to any “covered LTC worker” as defined in Governor Lamont’s Executive Order 13F who provides services at your facility. A covered LTC worker includes employees, consultants, contractors including persons who provide services to the long-term care facility under a contract entered into by the facility, volunteers, caregivers who provide care and services to residents on behalf of the facility, and students in the facility’s nurse aide training programs or from affiliated academic institutions. Covered LTC worker does not include visitors of a patient or resident.

The requested records shall be sent to the attention of Christian D. Andresen by 1) secure email to dph.fliscomplaint@ct.gov, secure fax to 860-730-8390, or by mail to Christian D. Andresen 410 Capitol Avenue MS#12APP Hartford, CT 06134.

The requested information is what is minimally necessary to achieve the purpose of the disclosure, and you may rely upon this representation in releasing the requested information, pursuant to §164.514(d)(iii)(A) of the HIPAA Privacy regulations.
