- 1. The total maximum amount payable under this contract is increased by \$176,366 to \$1,019,807.27 from \$843,441.27 to to add funding for the fifth year of the federal award for the Rewards to Quit (RTQ) program.
- 2. Item numbered two (2) of Amendment Two (A2) and Amendment Three (A3) is hereby revised by replacing "The combined budget for years 1 through 4," and the chart labeled "The combined budget for years 1 through 5,", as follows:
