Section 2 - Responses:

Questions submitted by interested bidders and the Department's official responses follow. These responses shall clarify the requirements of the RFP. In the event of an inconsistency between information provided in the RFP and information in these responses, the information in these responses shall control.

1. Question: The RFP states that "the Department anticipates awarding one or more resultant contracts as a result of this procurement." Will there be potential for negotiation of award amounts and/or revision of service levels if DSS would like to award more than one contract to serve different areas of the state, different target populations, etc., or is a submitted bid amount set in stone?

<u>Response</u>: Yes. The Department reserves the right to negotiate separately any services in any manner needed to serve the best interest of the State.

2. <u>Question</u>: Will proposals submitted by coalitions or collaboratives be prioritized over proposals submitted by individual organizations?

Response: No.

- 3. Question: If our agency already receives funding from the Department of Social Services (DSS) for a financial literacy program, can we apply for this new funding to serve a specific population that is currently not targeted by our existing program? How might this affect our core program funding from DSS?
 - Response: Yes. Bidders that already receive funding from the Department can apply for this new funding to serve a specific population that is currently not targeted by its existing program. Announcement of awards for contract negotiation will not affect other funding from the Department.
- 4. Question: The RFP says on Page 25, "If the bidder has been a State contractor within the last five years, the bidder must include a State of Connecticut Reference." Our primary financial literacy program funder has been DSS. Can a DSS representative who is not directly connected to this procurement be used as a reference for the agency and/or proposed staff members, as required by the RFP?
 - <u>Response</u>: Yes. A Department representative who is not directly connected to this procurement can be used as a reference.
- 5. Question: On Page 20, you ask for "percentage of time spent on this contract for each responsible director." Does this refer to the agency Board of Directors (as the next question clearly does)? If our Board of Directors does not participate in direct services, should we indicate such?
 - <u>Response</u>: "Percentage of time spent on this contract for each responsible director" does refer to the agency Board of Directors. If the bidder's Board of Directors does not participate in direct services, the bidder must indicate this as their response.
- 6. <u>Question</u>: How does the "Ownership Disclosure" section on Pages 20-21 apply to a private non-profit or a coalition? These questions seem relevant to forprofit companies with owners/stockholders only.
 - <u>Response</u>: The Ownership Disclosure section does not apply to a private nonprofit or a coalition. If the bidder is a private nonprofit or a coalition, the bidder must indicate this as their response.

7. Must the signed release requested on Page 25 be on a separate sheet? If so, does it count toward the page limit for Section B?

<u>Response</u>: The signed release requested on Page 25 must be submitted as a separate sheet and is not included in the page limitation of this section.

8. <u>Question</u>: Should the designated Program Manager be a full-time position or is a half-time dedicated staff sufficient?

<u>Response</u>: Bidders must propose the best staffing configuration for their proposed services.

9. Question: Per the request to describe how the contractor will engage and partner with other organizations (Page 29), are letters of support or memoranda of agreement required or preferred, or will narrative description and contact information be sufficient? If letters/memoranda are required, would they count toward the page limit?

<u>Response</u>: No. Letters of support or memoranda of agreement are not required or preferred. Bidders must provide only the information requested.

10. Question: For the business cost section, should the business-cost narrative and line-item budget be for the full four years of the contract period (and if this is the case, should the budget be cumulative or should separate budgets be presented for each year), or is a one-year annualized budget sufficient if we do not expect significant changes to the project and/or its costs from year to year?

<u>Response</u>: Bidders must provide a line-item budget that presents overall costs for the Financial Literacy Initiative. One budget that presents each year of the four-year contract period is required. The Department will not provide a specific budget format to be used.

11. <u>Question</u>: Are there any required budget forms, or is any budget format OK as long as the budget conforms to the statewide cost standards?

Response: See response to Item #10.

12. <u>Question</u>: Are any matching funds required, or would they be considered an advantage?

<u>Response</u>: No. Proposals do not require matching funds. The Department will not prioritize proposals that present matching funds over those that do not.

13. <u>Question:</u> Please clarify whether organizations may participate on more than one application submitted in response to the Financial Literacy Initiative RFP. Is it permitted for an organization, for instance, to submit an independent application and to participate in proposals submitted on behalf of one or more collaboratives or agencies?

Response: No.

14. <u>Question</u>: Is the State of Connecticut open to proposed partnerships with financial institutions (such as a local bank, i.e. Webster Bank)?

Response: The Department expects the participation of financial institutions in the Financial Literacy Initiative. However, the Department will not fund any projects in which dollars are awarded to financial institutions. The participation of financial institutions is preferred to be within the realm of the financial institution's charitable, volunteer, community partnership, or community service work.

15. <u>Question</u>: Our focus in the non-English speaking population is Hispanic. Are there other groups that are very high priority for the State of Connecticut?

Response: The Department has not established priorities for any particular limited-English-proficient population.

16. Question: The funds have already been allocated to serve low-income persons (67 percent) and older persons (33 percent). What happens if there is an overlap in the initiatives that might serve both targets? Is this fund allocation flexible?

Response: There is no flexibility in the allocation of funding.

17. <u>Question</u>: In the implementation phase, are there any restrictions regarding the sporadic use of public property (i.e., churches, parks, etc.)?

<u>Response:</u> Bidders must propose creative and innovative service delivery methods including the specific locations and properties used.

Request for Proposals

The State of Connecticut Department of Social Services (Department) is requesting proposals from nonprofit organizations, entities, coalitions, and/or collaborations able to reach <u>and</u> serve one or both of two target populations, low-income persons and/or older adults, to improve their financial literacy. Bidders must demonstrate experience of at least two years providing financial literacy services. Bidders must identify their proposed target populations and geographic service regions. Geographic service regions may be cities/towns, regions, or the entire State of Connecticut. <u>Services must address the needs of limited-English-proficient persons within the proposed target populations</u>.

The resultant contract period is anticipated to begin on <u>April 1, 2008</u> and end on <u>March 31, 2012</u>. The total funding available through this procurement shall not exceed \$1,275,000. The Department anticipates awarding one or more resultant contracts as a result of this procurement.

Interested bidders <u>must</u> submit a mandatory Letter of Intent to the Department no later than 3:00 p.m. local time on <u>November 28, 2007</u>. Proposals <u>must</u> be received at the Department no later than 3:00 p.m. local time on <u>December 28, 2007</u>. Proposals received after the stated due date and time may be accepted by the Department as a clerical function but will <u>not</u> be evaluated. Those proposals that are not evaluated shall be retained for thirty days after the resultant contracts are executed, after which the proposals will be destroyed. <u>All proposals must be in sealed envelopes or sealed boxes clearly identified as "Financial Literacy Initiative RFP."</u>

The following acronyms, abbreviations, and definitions apply to this procurement:

- 1. <u>Asset</u> An item of value owned, such as money, a home, or investments
- 2. Child Tax Credit As defined by the Internal Revenue Service, a tax credit of \$1,000 available on a taxpayer's tax return for each qualifying child of a taxpayer under age seventeen (a qualifying child is a taxpayer's child, stepchild, grandchild, great grandchild, or eligible foster child that the taxpayer claims as a dependent on his or her tax return)
- 3. <u>Commissioner</u> The Commissioner of the State of Connecticut Department of Social Services, as defined in Connecticut General Statutes (C.G.S.) §17b-3
- 4. Department State of Connecticut Department of Social Services
- 5. <u>Earned Income Tax Credit (EITC)</u> A Federal income tax credit for low-income working individuals and families
- 6. <u>Financial literacy</u> Knowledge of personal finances that is sufficient to enable a person to manage savings, investments, and checking accounts, to develop and maintain a household budget, to manage personal debt, to understand consumer credit and finance, to manage personal credit options, and to understand and select among short-term and long-term investment options
- 7. Fraud Deception deliberately practiced to secure unfair or unlawful gain
- 8. <u>Limited-English-proficient persons</u> Persons who do not speak English as their primary language and who have a limited ability to read, speak, write, or understand English (these persons may be entitled to language assistance with respect to a particular type of service, benefit, or encounter)

SECTION I - OVERVIEW OF THE DEPARTMENT AND THE INITIATIVE

A. PURPOSE OF THIS REQUEST FOR PROPOSALS

This Request for Proposals (RFP) presents an exceptional opportunity for nonprofit organizations, entities, coalitions, and/or collaborations with experience and knowledge of financial literacy services. The State of Connecticut Department of Social Services (Department) is requesting proposals from organizations able to reach <u>and</u> serve one or both of two target populations, low-income persons and/or older adults, to improve their financial literacy. Bidders must demonstrate experience of at least two years providing financial literacy services. This procurement is for new services.

B. OVERVIEW OF THE DEPARTMENT OF SOCIAL SERVICES

The Department provides a broad range of services to older adults, individuals with disabilities, families, and individuals who need assistance in maintaining or achieving their full potential for self-direction, self-reliance, and independent living. It administers more than ninety legislatively-authorized programs and approximately one-third of the State budget. By statute, it is the State agency responsible for administering human service programs sponsored by Federal legislation including the Rehabilitation Act, the Food Stamp Act, the Older Americans Act, and the Social Security Act. The Department is also designated as a public housing agency for administering the Section 8 Program under the Federal Housing Act.

The Department is headed by the Commissioner of Social Services and there are Deputy Commissioners for Administration and Programs. There is a Regional Administrator responsible for each of the Department's three geographic service regions. By statute, there is a Statewide Advisory Council to the Commissioner of Social Services and each geographic service region must have a Regional Advisory Council.

The Department administers most of its programs at offices located throughout the State. Within the Department, the Bureau of Rehabilitation Services provides vocational rehabilitation services for eligible individuals with physical and mental disabilities throughout the State. For the other programs, services are available at offices located in the three geographic service regions, with central office support located in Hartford. In addition, many services funded by the Department are available through community-based agencies. The Department has out-stationed employees at participating hospitals and nursing facilities to expedite Medicaid applications and funds Healthy Start sites, which can accept applications for Medicaid for pregnant

women and young children. Many of the services provided by the Department are available via mail or telephone.

There are four entities attached to the Department for administrative purposes only. They are the Commission on Aging, the Commission on Deaf and Hearing-impaired, the Board of Education and Services for the Blind, and the Child Day Care Council.

C. OVERVIEW OF THE FINANCIAL LITERACY INITIATIVE

Financial literacy is the knowledge of personal finances that is sufficient to enable a person to manage savings, investments, and checking accounts, to develop and maintain a household budget, to manage personal debt, to understand consumer credit and finance, to manage personal credit options, and to understand and select among short-term and long-term investment options. People are financially literate when they understand money, income and taxes, budgeting, banking, saving, investing, credit, insurance and retirement planning, and managing money for economic self-sufficiency. Many low-income persons and older adults lack basic skills in the management of personal financial affairs. Many are unable to balance a checkbook and lack the insight into the basic principles involved with earning, spending, saving, and investing. Many people fail in the management of their first consumer credit experience, establish bad financial management habits, enter into financially-destructive transactions, and become victims of fraud.

The Department is committed to promoting financial literacy in Connecticut including, but not limited to, knowledge of banking, investing, saving, and handling of personal finances, through service provision, materials, and programs to low-income persons and/or older adults including those low-income persons and/or older adults who have limited-English-proficiency. Successful proposals shall include a service plan that demonstrates an understanding of the target populations. To this end, this RFP was developed to achieve the following objectives:

- Improve the financial literacy of low-income persons and/or older adults
- Increase the ability of low-income persons and/or older adults to compare costs and budget, prioritize, and purchase what they can afford
- Increase the number of low-income persons and/or older adults who have banking relationships with financial institutions

- Increase the ability of low-income persons and/or older adults to make informed judgments and to take effective action regarding their current and future use and management of assets
- Increase the ability of low-income persons and/or older adults to build assets
- Increase the ability of low-income persons and/or older adults to prepare for and respond to financial emergencies
- Increase the ability of low-income persons and/or older adults to recognize and avoid predatory lending practices
- Increase the knowledge of low-income persons and/or older adults regarding local, State, and Federal tax responsibilities

Through this RFP, the Department seeks nonprofit organizations, entities, coalitions, and/or collaborations to design, implement, and administer activities to promote financial literacy. As some target populations may not be best served by mainstream activities, the Department is seeking creative and innovative proposals that target those in need of financial literacy services and propose effective activities to reach the target populations. Bidders must identify the proposed target populations and geographic service regions they plan to serve. Geographic service regions may be cities/towns, regions, or the entire State of Connecticut. Services must address the needs of limited-English-proficient persons within the proposed target populations.

Successful proposals will include a variety of efforts to reach and serve the target populations. Proposed services may include, but are not limited to:

- Financial literacy education
- Education on opening bank accounts and establishing banking relationships with financial institutions
- Planning and organizing local asset-building campaigns and coalitions
- Education on Earned Income Tax Credit (EITC), Child Tax Credit, and tax-filing assistance
- Education on Individual Development Account (IDAs) programs

- Money management and credit repair counseling
- Education on recognition and avoidance of abusive/predatory lending practices, financial scams, fraud, and consumer fraud
- Education on first-time homeownership
- Information on reverse mortgages

Funds will be allocated in the following manner:

- 67 percent or \$854,250 for financial literacy services for low-income persons including limited-English-proficient persons
- 33 percent or \$420,750 for financial literacy services for older adults including limited-English-proficient persons

<u>Services must address the needs of limited-English-proficient persons within</u> the proposed target populations.

No charge to participating low-income persons and/or older adults for services - Resultant contractors are prohibited from charging participating low-income persons and/or older adults any fees for Financial Literacy Initiative services.

C. MANDATORY LETTER OF INTENT (LOI)

Interested <u>BIDDERS SHALL</u> submit a mandatory nonbinding Letter of Intent (LOI) to the Issuing Office to advise the Department of their intent to submit a proposal in response to this RFP. The LOI <u>must</u> be received by the Issuing Office no later than 3:00 p.m. local time on November 28, 2007.

The LOI may be faxed or e-mailed to the Issuing Office. The LOI <u>must</u> identify the contact person including name, telephone number, fax number, and e-

mail address. It is the bidder's responsibility to confirm the Issuing Office's receipt of an LOI.

Failure to submit an LOI in accordance with the requirements set forth herein shall disqualify a bidder from further consideration.

To ensure a fair, open, and competitive process, the Department will not disclose who has submitted LOIs.

D. **BIDDER'S QUESTIONS**

Interested bidders may submit questions regarding this RFP to the Issuing Office by fax or e-mail directed to the Issuing Office. To be considered, questions regarding this RFP must be received by the Issuing Office no later than 3:00 p.m. local time on November 28, 2007. The early submission of questions is encouraged. It is solely the bidder's responsibility to ensure and verify the Department's receipt of questions.

The Issuing Office will respond only to those questions that meet the stated due date and time. Official responses to all questions will be in a Questions/Answers Addendum to this RFP posted on the State Procurement/Contracting Portal at

www.das.state.ct.us/Purchase/Portal/Portal_home.asp. The anticipated posting/release date for the Questions/Answers Addendum is December 5, 2007. It is solely the bidder's responsibility to access the State Procurement/Contracting Portal to obtain any and all Addendums or official announcements pertaining to this RFP. To submit a responsive proposal, THE BIDDER SHALL provide a signed acknowledgment of the receipt of each Addendum posted to the State Procurement/Contracting Portal.

In addition to the questions and answers, the Addendum will specify dates in the Procurement Schedule currently identified as To Be Determined.

E. EVALUATION AND SELECTION

It is the Department's intent to conduct a comprehensive, fair, and impartial evaluation of proposals received in response to this RFP. Only proposals found to be responsive to this RFP will be evaluated and scored. A responsive proposal must comply with all instructions listed in this RFP including the general proposal requirements.

F. CONTRACT EXECUTION

The resultant contract is subject to State contracting procedures. These procedures include approval of the State of Connecticut Attorney General's Office. Note that contracts become executed upon the signature of the Attorney General. No financial commitments can be made until and unless the resultant contracts have been approved by the Attorney General. The Attorney General reviews the resultant contract only after the parties have agreed to the provisions.

G. BIDDER DEBRIEFING

The State will notify all bidders of any award issued by it as a result of this RFP. Unsuccessful bidders may, within thirty days of the signing of the resultant contract, request a meeting for debriefing and discussion of their proposal by contacting the Issuing Office in writing at the address previously provided. Debriefing will not include any comparisons of unsuccessful proposals with other proposals.

H. RIGHTS RESERVED

Upon determination that its best interests would be served, the Department shall have the right to do the following:

- 1. <u>Cancellation</u> Cancel this procurement at any time prior to the contract award
- 2. <u>Amendment of procurement</u> Amend this procurement at any time prior to contract award
- 3. Refusal to accept Refuse to accept or return accepted proposals that do not comply with procurement requirements
- 4. Rejection of incomplete proposal Reject any proposal in which any part of the proposal is incomplete or in which there are significant inconsistencies or inaccuracies (the State reserves the right to reject all proposals)
- 5. <u>Prior contract default</u> Reject the proposal of any bidder in default of any prior contract or for the misrepresentation of material presented

- 6. Receipt of proposals after stated due date and time Reject or refuse to evaluate any proposal that is received after the stated due date and time
- 7. <u>Written clarification</u> Require bidders, at their own expense, to submit written clarification of proposals in a manner or format that the Department may require
- 8. <u>Oral clarification</u> Require bidders, at their own expense, to make oral presentations at a time selected and in a place provided by the Department

The Department may invite bidders, but not necessarily all, to make an oral presentation to assist the Department in its determination of award. The Department further reserves the right to limit the number of bidders invited to make such a presentation and the number of attendees per bidder.

- Onsite visits Make onsite visits to the operational facilities of bidders to further evaluate the bidder's ability to perform the duties required in this RFP
- Allowance of proposal changes Except as may be authorized by the Department, allow no additions or changes to the original proposal after the stated due date and time
- 11. <u>Property of the State</u> Own all proposals submitted in response to this procurement upon receipt by the Department
- 12. <u>Separate service negotiation</u> Negotiate separately any services in any manner needed to serve the best interest of the State
- 13. <u>All or any portion</u> Contract for all or any portion of the Scope of Services or tasks contained in this RFP
- 14. One or more bidders Contract with one or more bidders
- 15. Proposal most advantageous Consider cost and all factors in determining the most advantageous proposal for the Department when awarding a bidder the right to negotiate a contract with the Department (while cost is a factor in determining the bidder to be awarded the right to negotiate a contract with the Department, price alone shall not determine the successful bidders)

- 16. <u>Technical defects</u> Waive technical defects, irregularities, and omissions, if in its judgment the best interest of the Department will be served
- 17. Privileged and confidential information Share the contents of any proposal with any of its designees for purpose of evaluating proposals to make an award (the contents of all meetings including the first, second, and any subsequent meetings and all communications in the course of negotiating and arriving at the resultant contract terms shall be privileged and confidential)
- 18. <u>Best and Final Offers</u> Seek Best and Final Offers (BFO) on price from bidders upon review of the scored criteria (in addition, the Department reserves the right to set parameters on any BFOs it receives)
- 19. <u>Unacceptable proposals</u> Reopen the bidding process if advantageous to the Department

I. PROPOSAL PRESENTATION EXPENSES

The State of Connecticut and the Department assume no liability for payment of expenses incurred by bidders in preparing and submitting proposals in response to this procurement.

J. PROPOSAL DUE DATE AND TIME

The Issuing Office must receive proposals no later than the due date and time specified in the Procurement Schedule. The Department will not consider a postmark date as the basis for meeting the submission due date and time. Bidders shall not interpret or otherwise construe receipt of a proposal after the stated due date and time as acceptance of the proposal, since the actual receipt of the document is a clerical function. The Department suggests the bidder use certified or registered mail to deliver the proposal when the bidder is not able to deliver the proposal by courier or in person. Bidders that are hand-delivering proposals will not be granted access to the building without photo identification and shall allow extra time for security procedures. Bidders must address all RFP communications to the Issuing Office.

K. ACCEPTANCE OF PROPOSAL CONTENTS

If acquisition action ensues, the contents of this RFP and the proposals of the successful bidders will form the basis of contractual obligations in the final contract. The resultant contract will be a performance-based Purchase of

Service (POS) contract (<u>Appendix I</u>) between the successful bidders and the Department. The proposal must include a <u>Signatory Acceptance</u> (<u>Appendix II</u>), without qualification, of all terms and conditions as stated in this RFP and Part II of the Department's POS contract. Successful bidders may suggest alternate language after having accepted without qualification the Mandatory Terms and Conditions as specified in the POS contract. The Department may, after consultation with the State of Connecticut Attorney General's Office and the Office of Policy and Management (OPM), agree to incorporate the alternate language in any resultant contract; however, the Department's decision is final. Any proposal that fails to comply in any way with this requirement may be disqualified as non-responsive. The Department is solely responsible for rendering decisions in matters of interpretation on all terms and conditions.

BIDDER ASSURANCES

- 1. <u>Independent price determination</u> By submission of a proposal and through assurances given in its Transmittal Letter, the bidder certifies that in connection with this procurement the following requirements have been met:
 - a) <u>Costs</u> The costs proposed have been arrived at independently, without consultation, communication, or agreement, for restricting competition, as to any matter relating to such process with any other organization or with any competitor.
 - b) <u>Disclosure</u> Unless otherwise required by law, the costs quoted have not been knowingly disclosed by the bidder on a prior basis directly or indirectly to any other organization or to any competitor.
 - c) <u>Competition</u> No attempt has been made or will be made by the bidder to induce any person or firm to submit or not submit a proposal for restricting competition.
 - d) <u>Prior knowledge</u> The bidder has no prior knowledge of RFP contents prior to actual receipt of this RFP and had no part in RFP development.
 - e) Offer of gratuities The bidder certifies that no elected or appointed official or employee of the State of Connecticut has or will benefit financially or materially from this procurement. Any resultant contract may be terminated by the State if it is

determined that gratuities of any kind were either offered to or received by any of the aforementioned officials or employees from the resultant contractor, the resultant contractor's agent, or the resultant contractor's employees.

- f) <u>Campaign contribution restrictions</u> The bidder certifies receipt of SEEC Form 11 (Appendix X).
- 2. <u>Valid and binding offer</u> The proposal represents a valid and binding offer to provide services in accordance with the terms and provisions described in this RFP and any amendments or attachments hereto.
- 3. <u>Press releases</u> The bidder agrees to obtain prior written consent and approval of the Department for press releases that relate in any manner to this RFP or any resultant contract.
- 4. Restrictions on communications with Department staff The bidder agrees that from the posting/release date of this RFP until the Department makes an award that it shall not communicate with the Department's staff on matters relating to this RFP except as provided herein through the Issuing Office. Any other communication concerning this RFP with any of the Department's staff may, at the decision of the Department, result in disqualification of that bidder's proposal.

M. FREEDOM OF INFORMATION

Due regard will be given to the protection of proprietary information contained in all proposals received; however, bidders shall be aware that all materials associated with this procurement are subject to the terms of the Freedom of Information Act (FOIA), the Privacy Act, and all rules, regulations, and interpretations resulting therefrom. The bidder must provide convincing explanation and rationale to justify each exception from release consistent with C.G.S. §1-210 to claim proprietary exemption.

It will not be sufficient for bidders to merely state generally that the proposal is proprietary in nature and therefore not subject to release to third parties to claim an exemption. Price and cost alone do not meet exemption requirements. The particular pages or sections of the proposal that a bidder believes are proprietary must be specifically identified as such. The rationale and explanation must be stated in terms of the prospective harm to the bidder's competitive position that would result if the identified material were to be released and the reasons why the materials are legally exempt from release pursuant to the above-cited statute.

In any case, the narrative portion of the proposal may not be exempt from release. Between the bidder and the State, the final administrative authority to release or exempt any or all material so identified rests with the State.

N. AFFIRMATIVE ACTION

Regulations of Connecticut State Agencies §46a68j-3(10) requires agencies to consider the following factors when awarding a contract that is subject to contract compliance requirements:

- 1. The bidder's success in implementing an affirmative action plan
- 2. The bidder's success in developing an apprenticeship program complying with C.G.S. §46a-68-1 to 46a-68-17, inclusive
- 3. The bidder's promise to develop and implement a successful affirmative action plan
- 4. The bidder's submission of EEO-1 data indicating that the composition of its workforce is at or near parity when compared to the racial and sexual composition of the workforce in the relevant labor market area
- 5. The bidder's promise to set aside a portion of the resultant contract for legitimate small contractors and minority business enterprises (See C.G.S. §4a-60)

O. RESULTANT CONTRACT PERIOD

The resultant contract period is anticipated to begin on <u>April 1, 2008</u> and end on <u>March 31, 2012</u>. The total funding available through this procurement shall not exceed \$1,275,000. The Department anticipates awarding one or more resultant contracts as a result of this procurement.

SECTION III - GENERAL PROPOSAL REQUIREMENTS AND STRUCTURE

A. GENERAL PROPOSAL REQUIREMENTS

Bidders must adhere to the Department's rules as established in this RFP for proposal consideration, format, and content. The Department requires each bidder, at a minimum, to clearly describe how the specifications in this RFP will be met. Proposals must provide evidence of successful experience or

competence. The proposal structure requirements and the proposal content requirements are listed below. Bidders must respond to each content requirement that begins with **THE BIDDER SHALL**. Proposals must provide evidence of successful experience or competence.

B. INSTRUCTIONS FOR PROPOSAL STRUCTURE

- 1. <u>Delivery Condition</u> An original (clearly marked) and six exact, legible copies of the proposal must be submitted in clearly identified ("Financial Literacy Initiative RFP") sealed envelopes or sealed boxes by the stated due date and time. In addition, one exact <u>electronic copy</u> of the entire proposal in a non-PDF format must be submitted, except for those required documents that cannot be converted into electronic format.
- 2. <u>Proposal Structure</u> The Department has structured the submission requirements into four distinct parts:
 - a) Transmittal Communication, Forms, and Acceptances
 - b) Organizational Capacity and Structure
 - c) Scope of Services
 - d) Business Cost Section
- Proposal Construction
 - a) Binding of Proposals THE BIDDER SHALL submit a proposal in a format that will allow updated pages to be easily incorporated into the original proposal. An original (clearly marked) and six exact, legible copies of the proposal must be submitted in loose leaf or spiral-bound notebooks with the official name of the bidder appearing on the outside front cover of each binder and on each page of the proposal (location is at the bidder's discretion).
 - b) <u>Tab Sheet Dividers</u> A tab sheet keyed to the Table of Contents (TOC) must separate each major part of the proposal. The title of each part must appear on the tab sheet.

- c) <u>Table of Contents (TOC)</u> Each proposal must incorporate a TOC. It is through this TOC that the Department will evaluate conformance to uniform proposal content and format.
- d) <u>Cross-referencing RFP and Proposal</u> Each section of the proposal must cross-reference the appropriate section of this RFP that is being addressed. This will allow the Department to determine uniform compliance with specific RFP requirements.
- e) <u>Page Numbers</u> Each page of each part of the proposal must be numbered consecutively in Arabic numerals from the beginning of the proposal through all appended materials.
- f) Page Format The standard format to be used throughout the proposal is:
 - (1) Text shall be on 8½" x 11" paper, portrait orientation, single-spaced.
 - (2) Pitch shall be a maximum of ten characters per inch.
 - (3) Font shall be either Arial or Times New Roman and a minimum of twelve point.
 - (4) The binding edge margin of all pages shall be a minimum of 1½ inches; all other margins shall be one inch.
 - (5) Graphics may have a landscape orientation, bound along the top (11") side (if oversized, graphics may have a maximum of one fold).
 - (6) Graphics may have a smaller text spacing, pitch, and font size.

SECTION IV - PROPOSAL CONTENTS

A. TRANSMITTAL COMMUNICATION, FORMS, AND ACCEPTANCES

Each proposal must include an original (clearly marked) and six exact copies clearly identified as "Financial Literacy Initiative RFP." One exact electronic copy (floppy or compact disk) must be submitted as well.

- 1. Transmittal Letter To submit a responsive proposal, THE BIDDER

 SHALL submit the original proposal (clearly marked) and all copies with a Transmittal Letter limited to two pages, which addresses each of the bidder assurances in Section II.L of this RFP. The Transmittal Letter must include the bidder's Federal Employer Identification Number, if the bidder is an organization or the bidder's Social Security Number, if the bidder is an individual.
- 2. <u>Table of Contents (TOC)</u> <u>To submit a responsive proposal, **THE**</u> <u>BIDDER SHALL</u> provide a TOC for the entire proposal beginning with the Executive Summary including all appendices.
- 3. Executive Summary To submit a responsive proposal, THE BIDDER

 SHALL provide a high-level summary limited to two pages that summarizes the content of the proposal. The Executive Summary shall include the bidder's demonstrated experience of at least two years providing financial literacy services.
- 4. Addendum Acknowledgements To submit a responsive proposal, THE BIDDER SHALL provide the signed acknowledgement of its receipt of any and all Addendums issued for this RFP.
- 5. Procurement and Contractual Agreements Signatory Acceptance

 (Appendix II) To submit a responsive proposal, THE BIDDER SHALL

 provide a signed Acceptance Statement, without qualification, of all

 Mandatory Terms and Conditions (Appendix I).
- 6. Workforce Analysis Form (Appendix III) To submit a responsive proposal, THE BIDDER SHALL complete the Workforce Analysis Form. This form shall be completed by bidders with Connecticut worksites.
- 7. <u>Notification to Bidders Form (Appendix IV [signed])</u> <u>To submit a responsive proposal, **THE BIDDER SHALL** summarize the bidder's affirmative action plan and the bidder's affirmative action policy</u>

statement. Additionally, to submit a responsive proposal, **THE BIDDER SHALL** address in writing the following five factors, as appropriate, to the bidder's particular situation. These factors are:

- a) <u>Affirmative Action Plan</u> The bidder's success in implementing an Affirmative Action Plan
- b) <u>Development of Affirmative Action Plan</u> The bidder's promise to develop and implement a successful Affirmative Action Plan if no successful Affirmative Action Plan is in place
- c) <u>Apprenticeship Program</u> The bidder's success in developing an apprenticeship program complying with C.G.S. §§46a-68-1 to 46a-68-17, inclusive
- d) <u>EEO-1 Data</u> The bidder's submission of EEO-1 data indicating that the composition of its workforce is at or near parity when compared to the racial and sexual composition of the workforce in the relevant labor market area
- e) <u>Set-aside for Minority Businesses</u> The bidder's promise to setaside a portion of the resultant contract for legitimate minority business enterprises, and to provide the Department Set-aside Reports in a format required by the Department
- 8. <u>Smoking Policy (Appendix V signed Statement, if applicable)</u> If the bidder is an employer subject to the provisions of C.G.S. §31-40q, to submit a responsive proposal, **THE BIDDER SHALL** agree to provide the Department with a copy of its written rules concerning smoking. The Department must receive the rules or a statement that the bidder is not subject to the provisions of C.G.S. §31-40q prior to contract approval.
- 9. Certification Regarding Lobbying (Appendix VI) To submit a responsive proposal, THE BIDDER SHALL provide a signed statement to the effect that no funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a member of Congress, an officer or employee of Congress or an employee of a member of Congress in connection with the awarding of any Federal contract, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.

10. Contract Affidavits/Certifications - Connecticut General Statutes (C.G.S.) §§4-250 through 4-252 require that State contracts with a value of \$50,000 or more be accompanied by a Gift and Campaign Contribution Certification and a Consulting Agreement Affidavit. To submit a responsive proposal, THE BIDDER SHALL provide a completed Gift and Campaign Contribution Certification (Appendix VIII) and a Consulting Agreement Affidavit (Appendix VIII).

If a bidder is exempt from the Contract Affidavit/Certification Requirements, the bidder must indicate this fact on the affidavits/certifications and return the forms with the proposal.

- 11. Affirmation of Receipt of State Ethics Laws Summary (Appendix IX) Pursuant to C.G.S. §§1-101mm and 1-101qq, persons, resultant contractors, subcontractors, consultants, or the duly-authorized representative thereof must affirm receipt of the summary of State ethics laws developed by the State Office of Ethics pursuant to C.G.S. §1-81b and that key employees of such person, resultant contractor, subcontractor, or consultant have read and understand the summary and agree to comply with its provisions. To submit a responsive proposal, THE BIDDER SHALL provide a completed and signed Affirmation of Receipt of State Ethics Laws Summary.
- 12. Notice to Executive Branch State Contractors and Prospective State
 Contractors of Campaign Contribution and Solicitation Ban (Appendix
 X) With regard to a State contract as defined in Public Act 07-1
 having a value in a calendar year of \$50,000 or more or a combination
 or series of such agreements or contracts having a value of \$100,000
 or more, the authorized signatory to this submission in response to the
 State's solicitation expressly acknowledges receipt of the State
 Elections Enforcement Commission's notice advising prospective State
 contractors of State campaign contribution and solicitation prohibitions,
 and will inform its principals of the contents of the notice.

B. ORGANIZATIONAL CAPACITY AND STRUCTURE (MAXIMUM TEN PAGES)

<u>General</u> - Responses to the requirements in this section must describe the background of the bidder and the bidder's qualifications. The responses must also address the details regarding the size and resources of the bidder relevant to the functions to be performed under the resultant contract.

- 1. Organizational Qualifications To submit a responsive proposal, THE BIDDER SHALL summarize its overall qualifications to carry out this Financial Literacy Initiative. This summary shall include experience and success in designing and implementing a financial literacy initiative. If subcontractors are to be used, the summary must also include each subcontractor's qualifications. Bidders must include, at a minimum, details regarding:
 - a) Number of employees
 - b) Technological abilities including, but not limited to, communications, reporting, and data management
 - Experience relevant to the functions to be performed under the resultant contract or recent contracts (within past two years) for financial literacy services

2. Organization -

- a) Governance To submit a responsive proposal, THE BIDDER
 SHALL provide the following information for the bidder as the proposed prime contractor and each proposed subcontractor:
 - (1) The name, work address, and percentage of time spent on the contract for each responsible director
 - (2) The role of the Board of Directors in governance and policy-making
 - (3) A current organizational chart defining levels of ownership, governance, and management
 - (4) A complete description of any and all <u>related-party</u> relationships and transactions (Past exercise of influence or control need not be shown, only the potential or ability to directly or indirectly exercise influence or control. The bidder must fully disclose any anticipated payments to a related party. Such payments are unallowable unless the resultant contractor provides sufficient data to satisfy the Department that the costs are needed and reasonable.)
- b) Ownership Disclosure To submit a responsive proposal, THE BIDDER SHALL provide the following information for the bidder

as the proposed prime contractor and each proposed subcontractor:

- (1) A complete description of percent of ownership by the principals of the company or any other individual or organization that retains 5 percent or more including name and work address
- (2) The relationship of the persons so identified to any other owner or governor as the individual's spouse, child, brother, sister, or parent
- (3) The name of any person with an ownership or controlling interest of 5 percent or more in the bidder, who also has an ownership or control interest of 5 percent or more in any other related entity including subcontracting entity or parent entity or wholly-owned entity (the bidder shall provide the name or names of the other entity)
- (4) The name and address of any person with an ownership or controlling interest in the disclosing entity or an agent or employee of the disclosing entity who has been convicted of a criminal offense related to that person's involvement in any program under Titles XVIII, XIX, XX, or XXI of the Social Security Act, since the inception of such programs
- (5) Whether any person identified in the above subsections has been terminated, suspended, barred, or otherwise excluded from participation, or has voluntarily withdrawn as the result of a settlement agreement, from any program under Titles XVIII, XIX, or XX of the Social Security Act, or has within the last three years been reinstated to participation in any program under Titles XVIII, XIX, XX, or XXI of the Social Security Act, and prior to said reinstatement had been terminated, suspended, barred, or otherwise excluded from participation, or has voluntarily withdrawn as the result of a settlement agreement, in such programs

- (6) A description of the relationship with other entities including:
 - (a) Whether the bidder is an independent entity or a subsidiary or division of another company (if the bidder is not an independent entity, bidders shall describe the organizational linkages and the degree of integration/collaboration between the organizations including any roles of the organization's principals)
 - (b) A description of the relationship of any parent company when the bidder is an affiliate of another organization
- 3. Key Personnel and Staff Resources
 - a) <u>Corporate Project Unit</u> <u>To submit a responsive proposal, **THE**</u> <u>BIDDER SHALL</u>:
 - (1) Provide an organizational chart detailing how the staffing for the proposed Financial Literacy Initiative fits within the bidder's organizational structure
 - (2) Describe how the proposed organizational structure will support the financial literacy services
 - (3) Provide the names and titles of proposed key personnel for the Financial Literacy Initiative and the hours and percentages of time dedicated to the Financial Literacy Initiative
 - (4) Justify its staffing resources to successfully meet its RFP response requirements in light of any other similar obligations for any other entity
 - b) Management Plan To submit a responsive proposal, **THE**BIDDER SHALL describe a management plan for the Financial Literacy Initiative that includes, at a minimum:
 - (1) A description of the duties, authority, and responsibilities of each of the key personnel including the number and type of personnel under their direct supervision

- (2) The names of key personnel who are not full-time staff of the bidder including a complete description of their employment status with the bidder
- (3) The company's organizational structure indicating lines of authority
- (4) A description of any other current or planned contractual obligations that might have an influence on the bidder's ability to perform the work under a resultant contract
- c) <u>Program Manager</u> <u>To submit a responsive proposal, **THE**</u> <u>BIDDER SHALL</u> identify a Program Manager who will be responsible for:
 - (1) Implementing and managing the Financial Literacy Initiative
 - (2) Monitoring and ensuring the performance of duties and obligations under a resultant contract
 - (3) The day-to-day oversight of the Financial Literacy Initiative
 - (4) Attending all Financial Literacy Initiative meetings at the request of the Department
 - (5) Responding to the Department's inquiries and other communications related to implementation, operations, and program management of the activities presented in this RFP
- d) <u>Job descriptions for proposed key positions and resumes for key personnel proposed to fill the key positions To submit a responsive proposal, THE BIDDER SHALL:</u>
 - (1) Describe the contract-related experience, credentials, education and training, and work experience required in job descriptions for proposed key positions and in the resumes for key personnel proposed to fill the key positions and include:
 - (a) Experience with bidder (or bidder's proposed subcontractor)

- (b) Education, experience, and training relevant to financial literacy services
- (c) Names, positions, titles, and telephone numbers of persons able to provide information concerning the individuals' experience and competence (these persons may include supervisors, administrators, and colleagues)

Resumes for key personnel proposed to fill the key positions are <u>limited to two pages</u> per resume. <u>Resumes for key personnel proposed to fill the key positions and job descriptions for proposed key positions are not included in the page limitation of this section.</u>

- e) Job Personnel and Tasks To submit a responsive proposal,
 THE BIDDER SHALL describe the relationship between
 specific personnel for whom resumes have been submitted (or
 job descriptions for proposed key positions) and the specific
 tasks and assignments proposed to accomplish the Scope of
 Services and a justification of the individual's function based on
 the individual's competence including the bidder's:
 - (1) Procedures to secure and retain professional staff to meet the resultant contract requirements
 - (2) Method to evaluate personnel performance

4. Corporate Experience -

- a) Contracts To submit a responsive proposal, THE BIDDER

 SHALL describe its experience and success related to the
 Scope of Services for the Financial Literacy Initiative including
 the following information concerning the bidder's experience,
 whether ongoing or completed:
 - Identify all state agencies and commercial vendors for which the bidder has engaged in financial literacy services or related contract work
 - (ii) Describe its contracts or the work performed in the past two years for those agencies or commercial vendors

- (iii) Provide a signed release allowing the Department to access any evaluative information including, but not limited to, site reviews conducted by any state agency or commercial entity for which the bidder has performed work in the past two years
- (iv) Identify contacts for those projects including name of customer's project officer, title, address, telephone number, fax number, and e-mail address
- Identify the term for the contracts including the contract signing date, the project initiation date, the initial scheduled completion date, and the actual completion date
- (vi) List all sanctions, fines, penalties, or letters of noncompliance issued against the bidder by any of the contracting entities listed above (the list shall describe the circumstance eliciting the sanction or letter of noncompliance and the corrective action or resolution to the sanction, fine, penalty, or letters of noncompliance; if no sanctions, fines, penalties, or letters of noncompliance were issued, a statement that attests that no sanction, penalty, or compliance action has been imposed on the bidder within the two years immediately preceding the date of this RFP must be submitted)
- (vii) Describe how the bidder contributed creativity, innovation, and problem-solving expertise to a collaborative relationship with the governmental entity or commercial entity for selected contracts listed above
- (b) Bidder References To submit a responsive proposal, THE
 BIDDER SHALL provide three specific programmatic
 references for the bidder. References must be individuals able
 to comment on the bidder's ability to perform the services
 specified in this RFP. The contact person must be an individual
 familiar with the organization and its day-to-day performance. If
 the bidder has been a State contractor within the last five years,
 the bidder must include a State of Connecticut reference.
 Bidders are strongly encouraged to contact their references to
 ensure the accuracy of their contact information and their
 willingness and ability to be a reference. References must
 include the organization's name, address, current telephone

number, and name of a specific contact person. The Department expects to use these references in its evaluation process. If the bidder's proposal includes the use of subcontractors for direct service provision, the bidder's proposal must also include three programmatic references for each proposed subcontractor.

(c) Small, Minority, or Women's Business Enterprise - Section 329e of the Connecticut General Statutes (C.G.S.) sets forth the
requirements of each Executive Branch agency relative to the
Connecticut Small Business Set-Aside program. Pursuant to
that statute, 25 percent of the average total of all contracts let
for each of the three previous fiscal years must be set aside.
The Department requires that the resultant contractor make a
good-faith effort to set aside a portion of the resultant contract
for a small, minority, or women's business enterprise as a
subcontractor. Such subcontractors may supply goods or
services. Prospective bidders may obtain a list of firms certified
to participate in the Set-Aside program by contacting the State
of Connecticut Department of Administrative Services at the
DAS Web site at

During the evaluation process, special consideration will be given to those bidders who document their use of a certified small business and/or demonstrate the bidder's commitment to, whenever possible, use a certified small business. To submit a responsive proposal, THE BIDDER SHALL describe its effort to set aside a portion of the resultant contract for a small, minority, or women's business enterprise as a subcontractor.

(d) <u>Department Responsibilities</u> - <u>To submit a responsive proposal</u>, <u>THE BIDDER SHALL</u> propose specific support the bidder requires from the Department to perform the tasks in any resultant contract.

Specific Department responsibilities are:

 Program Management - A Program Manager will be appointed by the Department. This individual will be responsible for monitoring program progress and will have final authority to approve/disapprove program deliverables.

- <u>Staff Coordination</u> The Program Manager will coordinate all needed contacts between the resultant contractor and Department staff.
- Approval of Deliverables The Program Manager will review, evaluate, and approve all deliverables prior to the resultant contractor being released from further responsibility.
- <u>Policy Decisions</u> The Department retains final authority for making policy decisions affecting completion of the Financial Literacy Initiative. In addition, the Department shall:
 - Monitor the resultant contractor's performance and request updates, as appropriate
 - Respond to written requests for policy interpretations
 - Provide technical assistance to the resultant contractor, as needed
 - Allow access to Department automated databases, as available and permitted
 - Allow access to management reports and case files, as appropriate
 - Provide a Program Manager
 - Schedule and hold regular program meetings with the resultant contractor
 - Provide a process for and facilitate open discussions with staff and personnel to gather information regarding recommendations for improvement
 - Provide data as required by the resultant contractor to perform the functions of the Financial Literacy Initiative

(e) Reporting Requirements - Resultant contractors shall be expected to report monthly in a format to be approved by the Department. These reports may include, but not be limited to, qualitative and quantitative measures, narrative reporting of highlights and accomplishments, documentation of any programmatic challenges and corrective action plans, and results of participant satisfaction surveys. The resultant contractor shall be expected to fully cooperate with the data collection and reporting requirements established by the Department and with any Department staff performing contractmonitoring functions. To submit a responsive proposal, THE BIDDER SHALL describe its ability to comply with the above-stated requirements.

C. SCOPE OF SERVICES (MAXIMUM FIFTEEN PAGES)

<u>General</u> - A responsive proposal shall include a work plan that addresses the following requirements.

- 1. Outreach To submit a responsive proposal, THE BIDDER SHALL:
 - a) Describe how participating low-income persons and/or older adults become informed of the Financial Literacy Initiative including plan of marketing, outreach, and referral
 - b) Identify and describe how barriers to program participation, such as transportation, childcare, adequate shelter, clothing, food, disability status, language, and culture, will be recognized and addressed
- 2. <u>Proposed Services</u> <u>To submit a responsive proposal, **THE BIDDER SHALL**:</u>
 - a) Identify the proposed services to be provided proposed services may include, but are not limited to:
 - (i) Financial literacy education
 - (ii) Education on opening bank accounts and establishing relationships with financial institutions
 - (iii) Planning and organizing local asset-building campaigns and coalitions

- (iv) Education on Earned Income Tax Credit (EITC), Child Tax Credit, and tax-filing assistance
- (v) Education on Individual Development Account (IDAs) programs
- (vi) Money management and credit repair counseling
- (vii) Education on recognition and avoidance of abusive/predatory lending practices, financial scams, fraud, and consumer fraud
- (viii) Education on first-time homeownership
- (ix) Information on reverse mortgages
- b) Identify the number of proposed primary beneficiaries and the number of proposed secondary beneficiaries by geographic service region
- c) Describe the service delivery methods, particularly creative and innovative methods (for example, via Internet, classroom, workshops, self-study materials, workplace or school activities, teaching topics and teaching materials used)
- d) Identify the purpose of the Financial Literacy Initiative, whether intervention or prevention, i.e., whether the aim of the Financial Literacy Initiative is to prevent problems with personal finances or to help correct existing problems, or both
- e) Describe how the resultant contractor will engage and partner with other organizations the description must include organization name, address, current telephone number, name of contact person for each partner, and the role of each partner including period of each partner's involvement

- 3. Target Population and Geographic Service Region Bidders must identify the proposed target populations and geographic service regions. Geographic service regions may be cities/towns, regions, or the entire State of Connecticut. Services must address the needs of limited-English-proficient persons within the proposed target populations. To submit a responsive proposal, THE BIDDER SHALL:
 - a) Identify which of the target populations it will serve (low-income persons and/or older adults)
 - b) Identify the geographic service regions it intends to serve
 - c) Describe how the needs of limited-English-proficient persons within each of the proposed target populations will be addressed
- 4. <u>Timeline for Implementation</u> <u>To submit a responsive proposal, THE</u>

 <u>BIDDER SHALL</u> provide a timetable from beginning to end with startup activities, key dates, and key events relative to the Financial
 Literacy Initiative clearly shown for the first year of the project.
- 5. Outcomes To submit a responsive proposal, **THE BIDDER SHALL**:
 - a) Describe what the bidder considers to be the potential benefits to the primary participants of the Financial Literacy Initiative
 - b) Detail who will be the secondary beneficiaries of the Financial Literacy Initiative these may include those persons close to the primary participant and/or businesses or organizations that may benefit
 - c) Describe how the economy of the proposed geographic service regions will be impacted
- 6. Evaluation of Outcomes Resultant contractors will be required to develop Evaluation Plans. To submit a responsive proposal, THE BIDDER SHALL describe how the Evaluation Plan for the Financial Literacy Initiative will be developed. This description must include how participant outcomes will be evaluated, frequency of evaluation, evaluation instruments used, and evaluation and tracking of project progress.

D. BUSINESS COST SECTION

No cost information or other financial information may be included in any other portion of the proposal. Any proposal that fails to adhere to this requirement may be disqualified as non-responsive. Each proposal must include cost information and other financial information in the following order:

- 1. Audited Financial Statements To submit a responsive proposal, THE BIDDER SHALL provide audited financial statements for each of the last two appropriate fiscal years. If audited financial statements for each of the two appropriate fiscal years are not available, the bidder shall provide comparable statements that will document the financial stability of the bidder and include an explanation of the submission of documents other than audited financial statements. Audited Financial Statements do not count toward the total page limit of the proposal.
- Business Cost Narrative (maximum ten pages) To submit a
 responsive proposal, THE BIDDER SHALL describe how funds will be
 spent. The narrative shall describe each budget line item in detail with
 a brief explanation of each staff position including the number of hours
 worked weekly, number of weeks worked yearly, and hourly rates.
- 3. <u>Business Cost Section</u> <u>To submit a responsive proposal, **THE**</u> <u>BIDDER SHALL</u> provide a line-item budget that presents overall costs for the Financial Literacy Initiative.

<u>Cost Standards</u> - Budgetary information included in the bidder's response to this RFQ must comply with the Statewide Cost Standards published by the State of Connecticut Office of Policy and Management. The cost standards are available online at

http://opm.state.ct.us/finance/pos standards/coststandards.htm.

<u>Payment Structure</u> - Resultant contractors shall be paid in accordance with expenditures incurred in accordance with the approved line-item budget. While specific payment terms will be finalized during contract negotiations, it is anticipated that payments will be made quarterly, contingent upon the resultant contractor's timely compliance with the resultant contract terms including, but not limited to, the resultant contractor's submission and Department's acceptance of all required reports and payment requests.

SECTION V - PROPOSAL EVALUATION

A. OVERVIEW OF THE EVALUATION OF PROPOSALS

The Department will conduct a comprehensive, fair, and impartial evaluation of proposals received in response to this RFP. An Evaluation Team has been established to assist the Department in selection of resultant contractors. The Department reserves the right to alter the composition of the Evaluation Team. The Evaluation Team will be responsible for submitting recommendations to the Commissioners. The Commissioner of Social Services will notify the selected bidders that the selected bidders have been awarded the right to negotiate a contract with the Department for the Financial Literacy Initiative.

The evaluation will be conducted in five phases:

- Phase One Evaluation of General Proposal Requirements and Structure
- Phase Two Evaluation of the Organizational Capacity and Structure
- Phase Three Evaluation of the Scope of Services
- Phase Four Evaluation of the Business Cost Section
- Phase Five Ranking of the Proposals

B. PHASE ONE - EVALUATION OF GENERAL PROPOSAL REQUIREMENTS AND STRUCTURE

The purpose of this phase is to determine whether each proposal is sufficiently responsive to the General Proposal Requirements to permit a complete evaluation of the proposal. Proposals must comply with the instructions to bidders contained throughout. Failure to comply with the instructions may deem the proposal non-responsive and subject to rejection without further consideration. The Department reserves the right to waive minor irregularities. The General Proposal Requirements are spelled out above.

C. PHASE TWO - EVALUATION OF THE ORGANIZATIONAL CAPACITY AND STRUCTURE

Only those proposals passing the General Proposal Requirements review will be considered in Phase Two. The Department reserves the right to reject any and all proposals.

The quality of the work plan and the program management will be evaluated including the organization, completeness, and logic of the proposed plan. The evaluation will consider how comprehensive and knowledgeable the bidder is in responding to the functional and technical requirements outlined in this RFP.

The Department will evaluate the experience of proposed key personnel, agency and individual resources, and qualifications and affirmative action achievement (as demonstrated on the Workforce Analysis Form) of the bidder and any subcontractors. The Department will determine to what extent the organization and its key personnel have the ability to work effectively with the Department to successfully develop and implement a Financial Literacy Initiative. The Department will also assess the ability of the bidder to take on the additional workload that would be generated by the resultant contract and the bidder's financial ability to undertake the resultant contract. References will be checked. The Organizational Capacity and Structure section of the proposal will be worth 25 percent of the available points for the entire proposal.

D. PHASE THREE - EVALUATION OF THE SCOPE OF SERVICES

The proposed Scope of Services will be evaluated for its responsiveness to the requirements of this RFP including its organization, appropriateness, completeness, and logic. The evaluation will consider how creative and innovative the bidder is in responding to the functional and technical requirements outlined in this RFP. The Scope of Services section of the proposal will be worth 50 percent of the available points for the entire proposal.

E. PHASE FOUR - EVALUATION OF THE BUSINESS COST SECTION

The Business Cost Section will be evaluated only for bidders who achieve a minimum of 70 percent of the total available points in Phase Two and Phase Three. The Business Cost Section will be worth 25 percent of the available points for the entire proposal. It will be scored for:

- 1. Cost comparison (determined by comparing bid price information)
- Cost reasonableness (determined by examining the Business Narrative and the relationship between the costs, personnel, and the work plan outlined in the proposal)

F. PHASE FIVE - RANKING OF THE PROPOSALS

Upon completion of Phase One and Phase Two, it is possible that Evaluation Team members will interview the finalists. After the Evaluation Team has scored the proposals, the points awarded will be totaled to determine the ranking. Recommendations, along with pertinent supporting materials, will then be conveyed to the Commissioner of Social Services. The Commissioner of Social Services, at his discretion, reserves the right to approve or reject the Evaluation Team's recommendations.

The Contractor agrees to comply with the following mandatory terms and conditions.

A. Client-Related Safeguards

- 1. <u>Inspection of Work Performed</u> The Department or its authorized representative shall at all times have the right to enter into the Contractor's premises, or such other places where duties under the contract are being performed, to inspect, to monitor, or to evaluate the work being performed. The Contractor and all subcontractors must provide all reasonable facilities and assistance for Department representatives. All inspections and evaluations shall be performed in such a manner as will not unduly delay work. The Contractor shall disclose information on clients, applicants and their families as requested unless otherwise prohibited by Federal or state law. Written evaluations pursuant to this section shall be made available to the Contractor.
- Safeguarding Client Information The Department and the Contractor agree to safeguard the use, publication, and disclosure of information on all applicants for and all clients who receive service under this contract with all applicable Federal and state law concerning confidentiality.
- 3. Reporting of Client Abuse or Neglect The Contractor shall comply with all reporting requirements relative to client abuse and neglect, including but not limited to requirements as specified in Connecticut General Statutes (C.G.S.) §§17a-101 through 103, 19a-216, 46b-120 (related to children), C.G.S. §46a-11b (relative to persons with mental retardation), and C.G.S. §17b-407 (relative to elderly persons).

B. Contractor Obligations

- Cost Standards Effective January 1, 2007, the Contractor and funding state agency shall comply with the Cost Standards issued by the State of Connecticut, Office of Policy and Management ("OPM"), as may be amended from time to time. The Cost Standards are published by OPM on the Web at http://www.opm.state.ct.us/finance/pos_standards/coststandards.htm. Such Cost Standards shall apply to:
 - (a) All new Contracts effective on or after January 1, 2007
 - (b) All Contract amendments modifying funding, effective on or after January 1, 2007

(c) All Contracts in effect on or after July 1, 2007

2. Credits and Rights in Data -

- Unless expressly waived in writing by the Department, all (a) documents, reports, and other publications for public distribution during or resulting from the performances of this Contract shall include a statement acknowledging the financial support of the state and the Department and, where applicable, the Federal government. All such publications shall be released in conformance with applicable Federal and state law and all regulations regarding confidentiality. Any liability arising from such a release by the Contractor shall be the sole responsibility of the Contractor and the Contractor shall indemnify the Department, unless the Department or its agents co-authored said publication and said release is done with the prior written approval of the Commissioner of the Department. Any publication shall contain the following statement: "This publication does not express the views of the Department or the State of Connecticut. The views and opinions expressed are those of the authors." The Contractor or any of its agents shall not copyright data and information obtained under the terms and conditions of this contract, unless expressly authorized in writing by the Department. The Department shall have the right to publish, duplicate, use, and disclose all such data in any manner, and may authorize others to do so. The Department may copyright any data without prior notice to the Contractor. The Contractor does not assume any responsibility for the use, publication, or disclosure solely by the Department of such data.
- (b) "Data" shall mean all results, technical information and materials developed and/or obtained in the performance of the services hereunder, including but not limited to all reports, surveys, plans, charts, recordings (video and/or sound), pictures, curricula, public awareness or prevention campaign materials, drawings, analyses, graphic representations, computer programs and printouts, notes and memoranda, and documents, whether finished or unfinished, which result from or are prepared in connection with the services performed hereunder.

- 3. <u>Organizational Information, Conflict of Interest, IRS Form 990</u> Annually during the term of the contract, the Contractor shall submit to the Department the following:
 - (a) A copy of its most recent IRS Form 990 submitted to the Federal Internal Revenue Service, and
 - (b) Its most recent Annual Report as filed with the Office of the Secretary of the State or such other information that the Department deems appropriate with respect to the organization and affiliation of the Contractor and related entities
- 4. <u>Federal Funds</u> The Contractor shall comply with requirements relating to the receipt or use of Federal funds. The Department shall specify all such requirements in Part I of this contract.
- 5. <u>Audit Requirements</u> The Contractor shall provide for an annual financial audit acceptable to the Department for any expenditure of state-awarded funds made by the Contractor. Such audit shall include management letters and audit recommendations. The State Auditors of Public Accounts shall have access to all records and accounts for the fiscal year(s) in which the award was made. The Contractor will comply with Federal and state single audit standards as applicable.
- 6. Prohibited Interest The Contractor warrants that no state appropriated funds have been paid or will be paid by or on behalf of the Contractor to contract with or retain any company or person, other than bona fide employees working solely for the Contractor, to influence or attempt to influence an officer or employee of any state agency in connection with the awarding, extension, continuation, renewal, amendment, or modification of this agreement, or to pay or agree to pay any company or person, other than bona fide employees working solely for the Contractor, any fee, commission, percentage, brokerage fee, gift or any other consideration contingent upon or resulting from the award or making of this Agreement.
- 7. Offer of Gratuities By its agreement to the terms of this contract, the Contractor certifies that no elected or appointed official or employee of the State of Connecticut has or will benefit financially or materially from this contract. The Department may terminate this contract if it is determined that gratuities of any kind were either offered or received by any of the aforementioned officials or employees from the Contractor or its agents or employees.

- 8. Related-party Transactions The Contractor shall report all related-party transactions, as defined in this clause, to the Department on an annual basis in the appropriate fiscal report as specified in Part I of this contract. "Related party" means a person or organization related through marriage, ability to control, ownership, family or business association. Past exercise of influence or control need not be shown, only the potential or ability to directly or indirectly exercise influence or control. "Related-party transactions" between a Contractor, its employees, Board members or members of the Contractor's governing body, and a related party include, but are not limited to:
 - (a) Real estate sales or leases
 - (b) Leases for equipment, vehicles or household furnishings
 - (c) Mortgages, loans and working capital loans
 - (d) Contracts for management, consultant and professional services as well as for materials, supplies and other services purchased by the Contractor
- 9. <u>Lobbying</u> The Contractor agrees to abide by state and Federal lobbying laws, and further specifically agrees not to include in any claim for reimbursement any expenditures associated with activities to influence, directly or indirectly, legislation pending before Congress, or the Connecticut General Assembly or any administrative or regulatory body unless otherwise required by this contract.
- 10. Suspension or Debarment -
 - (a) Signature on Contract certifies the Contractor or any person (including subcontractors) involved in the administration of Federal or State funds:
 - (1) Are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded by any governmental department or agency (Federal, State or local)
 - (2) Within a three-year period preceding this Contract, has not been convicted or had a civil judgment rendered against him/her for commission of fraud or a criminal offense in connection with obtaining, attempting to obtain or performing a public (Federal, State or local)

- transaction or Contract under a public transaction, violation of Federal or State antitrust statutes or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements or receiving stolen property
- (3) Is not presently indicted for or otherwise criminally or civilly charged by a governmental entity (Federal, State or local) with commission of any of the above offenses
- (4) Has not within a three-year period preceding this agreement had one or more public transactions terminated for cause or fault
- (b) Any change in the above status shall be immediately reported to the Department.
- 11. <u>Liaison</u> Each party shall designate a liaison to facilitate a cooperative working relationship between the Contractor and the Department in the performance and administration of this contract.
- 12. Subcontracts - For purposes of this clause, subcontractors shall be defined as providers of direct human services. Vendors of support services, not otherwise known as human service providers or educators, shall not be considered subcontractors, e.g. lawn care, unless such activity is considered part of a training, vocational or educational program. The subcontractor's identity, services to be rendered, and costs shall be detailed in Part I of this contract. Notwithstanding the execution of this contract prior to a specific subcontractor being identified or specific costs being set, no subcontractor may be used or expense under this contract incurred prior to identification of the subcontractor or inclusion of a detailed budget statement as to subcontractor expense, unless expressly provided in Part I of this contract. No subcontractor shall acquire any direct right of payment from the Department by virtue of the provisions of this clause or any other clause of this contract. The use of subcontractors, as defined in this clause, shall not relieve the Contractor of any responsibility or liability under this contract. The Contractor shall make available copies of all subcontracts to the Department upon request.
- 13. <u>Independent Capacity of Contractor</u> The Contractor, its officers, employees, subcontractors, or any other agent of the Contractor in the performance of this contract will act in an independent capacity and not

as officers or employees of the State of Connecticut or of the Department.

14. <u>Indemnification</u> -

- (a) The Contractor shall indemnify, defend and hold harmless the State of Connecticut and its officers, representatives, agents, servants, employees, successors and assigns from and against any and all:
 - Claims arising directly or indirectly, in connection with the contract, including the acts of commission or omission (collectively the "Acts") of the Contractor or Contractor Parties
 - (2) Liabilities, damages, losses, costs and expenses, including but not limited to attorneys' and other professionals' fees, arising, directly or indirectly, in connection with Claims, Acts or the contract. The Contractor shall use counsel reasonably acceptable to the State in carrying out its obligations under this contract. The contractor's obligations under this section to indemnify, defend and hold harmless against claims includes claims concerning confidentiality of any part of or all of the bid or any records, and intellectual property rights, other propriety rights of any person or entity, copyrighted or uncopyrighted compositions, secret processes, patented or unpatented inventions, articles or appliances furnished or used in the performance of the contract.
- (b) The Contractor shall reimburse the State for any and all damages to the real or personal property of the State caused by the Acts of the Contractor or any Contractor Parties. The State shall give the Contractor reasonable notice of any such claims.
- (c) The Contractor's duties under this section shall remain fully in effect and binding in accordance with the terms and conditions of the contract, without being lessened or compromised in any way, even where the Contractor is alleged or is found to have merely contributed in part to the Acts giving rise to the Claims and/or where the State is alleged or is found to have contributed to the Acts giving rise to the Claims.

- (d) The Contractor shall carry and maintain at all times during the term of the contract, and during the time that any provisions survive the term of the contract, sufficient general liability insurance to satisfy its obligations under this contract. The Contractor shall name the State as an additional insured on the policy and shall provide a copy of the policy to the Agency prior to the effective date of the contract. The Contractor shall not begin performance until the delivery of the policy to the Agency.
- (e) The rights provided in this section for the benefit of the State shall encompass the recovery of attorneys' and other professionals' fees expended in pursuing a Claim against a third party.
- (f) This section shall survive the termination, cancellation, or expiration of the Contract, and shall not be limited by reason of any insurance coverage.
- 15. <u>Choice of Law and Choice of Forum, Settlement of Disputes, Office of the Claims Commission -</u>
 - (a) The Contractor agrees to be bound by the laws of the State of Connecticut and the Federal government where applicable, and agrees that this contract shall be construed and interpreted in accordance with Connecticut law and Federal law where applicable.
 - (b) Any dispute concerning the interpretation or application of this contract shall be decided by the Commissioner of the Department or his/her designee whose decision shall be final subject to any rights the Contractor may have pursuant to state law. In appealing a dispute to the commissioner pursuant to this provision, the Contractor shall be afforded an opportunity to be heard and to offer evidence in support of its appeal. Pending final resolution of a dispute, the Contractor and the Department shall proceed diligently with the performance of the contract.
 - (c) The Contractor agrees that the sole and exclusive means for the presentation of any claim against the State arising from this Contract shall be in accordance with Chapter 53 of the Connecticut General Statutes (Claims Against the State) and the Contractor further agrees not to initiate legal proceedings except as authorized by that Chapter in any State or Federal Court in addition to or in lieu of said Chapter 53 proceedings.

- 16. Compliance with Law and Policy Contractor shall comply with all pertinent provisions of local, state, and Federal laws and regulations as well as Departmental policies and procedures applicable to Contractor's programs as specified in this contract. The Department shall notify the Contractor of any applicable new or revised laws, regulations, policies, or procedures, which the Department has responsibility to promulgate or enforce.
- 17. Facility Standards and Licensing Compliance The Contractor will comply with all applicable local, state and Federal licensing, zoning, building, health, fire and safety regulations or ordinances, as well as standards and criteria of pertinent state and Federal authorities. Unless otherwise provided by law, the Contractor is not relieved of compliance while formally contesting the authority to require such standards, regulations, statutes, ordinance, or criteria.
- 18. Reports The Contractor shall provide the Department with such statistical, financial, and programmatic information necessary to monitor and evaluate compliance with the contract. All requests for such information shall comply with all applicable state and Federal confidentiality laws. The Contractor agrees to provide the Department with such reports as the Department requests.
- 19. <u>Delinquent Reports</u> The Contractor will submit required reports by the designated due dates as identified in this agreement. After notice to the Contractor and an opportunity for a meeting with a Department representative, the Department reserves the right to withhold payments for services performed under this Contract if the Department has not received acceptable progress reports, expenditure reports, refunds, and/or audits as required by this agreement or previous agreements for similar or equivalent services the Contractor has entered into with the Department.
- 20. Recordkeeping and Access The Contractor shall maintain books, records, documents, program and individual service records and other evidence of its accounting and billing procedures and practices which sufficiently and properly reflect all direct and indirect costs of any nature incurred in the performance of this contract. These records shall be subject at all reasonable times to monitoring, inspection, review or audit by authorized employees or agents of the state or, where applicable, Federal agencies. The Contractor shall retain all such records concerning this contract for a period of three years after the

completion and submission to the state of the Contractor's annual financial audit.

21. <u>Workforce Analysis</u> - The Contractor shall provide a workforce analysis affirmative action report related to employment practices and procedures.

22. Litigation -

- (a) The Contractor shall provide written notice to the Department of any litigation that relates to the services directly or indirectly financed under this contract or that has the potential to impair the ability of the Contractor to fulfill the terms and conditions of this contract, including but not limited to financial, legal or any other situation which may prevent the Contractor from meeting its obligations under the contract.
- (b) The Contractor shall provide written notice to the Department of any final decision by any tribunal or state or Federal agency or court which is adverse to the Contractor or which results in a settlement, compromise or claim or agreement of any kind for any action or proceeding brought against the Contractor or its employee or agent under the Americans with Disabilities Act of 1990, Executive Orders Nos. 3 & 17 of Governor Thomas J. Meskill and any other provisions of Federal or state law concerning equal employment opportunities or nondiscriminatory practices.
- C. Alterations, Cancellation, and Termination
 - Contract Revisions and Amendments -
 - (a) The Contractor shall submit to the Department in writing any proposed revision to the contract and the Department shall notify the Contractor of receipt of the proposed revision.
 - (b) Contract amendments must be in writing and shall not be effective until executed by both parties to the contract, and, where applicable, approved by the Attorney General.
 - (c) No amendments may be made to a lapsed contract.

2. Contract Reduction -

- (a) The Department reserves the right to reduce the Contracted amount of compensation at any time in the event that:
 - (1) The Governor or the Connecticut General Assembly rescinds, reallocates, or in any way reduces the total amount budgeted for the operation of the Department during the fiscal year for which such funds are withheld or
 - (2) Federal funding reductions result in reallocation of funds within the Department
- (b) The Contractor and the Department agree to negotiate on the implementation of the reduction within thirty days of receipt of formal notification of intent to reduce the contracted amount of compensation from the Department. If agreement on the implementation of the reduction is not reached within 30 calendar days of such formal notification and a contract amendment has not been executed, the Department may terminate the contract sixty days from receipt of such formal notification. The Department will formally notify the Contractor of the termination date.

Default by the Contractor -

- (a) If the Contractor defaults as to, or otherwise fails to comply with, any of the conditions of this contract the Department may:
 - (1) Withhold payments until the default is resolved to the satisfaction of the Department
 - (2) Temporarily or permanently discontinue services under the contract
 - (3) Require that unexpended funds be returned to the Department
 - (4) Assign appropriate state personnel to execute the contract until such time as the contractual defaults have been corrected to the satisfaction of the Department
 - (5) Require that contract funding be used to enter into a subcontract arrangement with a person or persons

- designated by the Department in order to bring the program into contractual compliance
- (6) Terminate this contract
- (7) Take such other actions of any nature whatsoever as may be deemed appropriate for the best interests of the state or the program(s) provided under this contract or both
- (8) Any combination of the above actions
- (b) In addition to the rights and remedies granted to the Department by this contract, the Department shall have all other rights and remedies granted to it by law in the event of breach of or default by the Contractor under the terms of this contract.
- Prior to invoking any of the remedies for default specified in this (c) paragraph except when the Department deems the health or welfare of service recipients is endangered as specified in of this contract or has not met requirements as specified in this contract, the Department shall notify the Contractor in writing of the specific facts and circumstances constituting default or failure to comply with the conditions of this contract and proposed remedies. Within five business days of receipt of this notice, the Contractor shall correct any contractual defaults specified in the notice and submit written documentation of correction to the satisfaction of the Department or request in writing a meeting with the commissioner of the Department or his/her designee. Any such meeting shall be held within five business days of the written request. At the meeting, the Contractor shall be given an opportunity to respond to the Department's notice of default and to present a plan of correction with applicable time frames. Within five business days of such meeting, the commissioner of the Department shall notify the Contractor in writing of his/her response to the information provided including acceptance of the plan of correction and, if the commissioner finds continued contractual default for which a satisfactory plan of corrective action has not been presented, the specific remedy for default the Department intends to invoke. This action of the Commissioner shall be considered final.

- (d) If at any step in this process the Contractor fails to comply with the procedure and, as applicable, the agreed upon plan of correction, the Department may proceed with default remedies.
- 4. <u>Non-enforcement Not to Constitute Waiver</u> -The failure of either party to insist upon strict performance of any terms or conditions of this agreement shall not be deemed a waiver of the term or condition or any remedy that each party has with respect to that term or condition nor shall it preclude a subsequent default by reason of the failure to perform.

5. Cancellation and Recoupment -

- (a) This agreement shall remain in full force and effect for the entire term of the contract period, above, unless either party provides written notice ninety days or more from the date of termination, except that no cancellation by the Contractor may be effective for failure to provide services for the agreed price or rate and cancellation by the Department shall not be effective against services already rendered, so long as the services were rendered in compliance with the contract during the term of the contract.
- (b) In the event the health or welfare of the service recipients is endangered, the Department may cancel the contract and take any immediate action without notice it deems appropriate to protect the health and welfare of service recipients. The Department shall notify the Contractor of the specific reasons for taking such action in writing within five business days of cancellation. Within five business days of receipt of this notice. the Contractor may request in writing a meeting with the commissioner of the Department or his/her designee. Any such meeting shall be held within five business days of the written request. At the meeting, the Contractor shall be given an opportunity to present information on why the Department's actions should be reversed or modified. Within five business days of such meeting, the Commissioner of the Department shall notify the Contractor in writing of his/her decision upholding, reversing, or modifying the action of the Department. This action of the Commissioner shall be considered final.
- (c) The Department reserves the right to cancel the contract without prior notice when the funding for the contract is no longer available.

- (d) The Department reserves the right to recoup any deposits, prior payment, advance payment, or down payment made if the contract is terminated by either party. Allowable costs incurred to date of termination for operation or transition of program(s) under this contract shall not be subject to recoupment. The Contractor agrees to return to the Department any funds not expended in accordance with the terms and conditions of the contract and, if the Contractor fails to do so upon demand, the Department may recoup said funds from any future payments owing under this contract or any other contract between the State and the Contractor.
- 6. Equipment In the event this Contract is terminated or not renewed, the Department reserves the right to recoup any equipment, deposits or down payments made or purchased with start-up funds or other funds specifically designated for such purpose under this Contract. For purposes of this provision, equipment means tangible personal property with a normal useful life of at least one year and a value of at least \$5,000. Equipment shall be considered purchased from Contractor funds and not from Department funds if the equipment is purchased for a program that has other sources of income equal to or greater than the equipment purchase price.
- 7. Transition after Termination or Expiration of Contract - In the event that this contract is terminated for any reason except where the health and welfare of service recipients is endangered or if the Department does not offer the Contractor a new contract for the same or similar service at the contract's expiration, the Contractor will assist in the orderly transfer of clients served under this contract as required by the Department and will assist in the orderly cessation of operations under this contract. Prior to incurring expenses related to the orderly transfer or continuation of services to service recipients beyond the terms of the contract, the Department and the Contractor agree to negotiate a termination amendment to the existing agreement to address current program components and expenses, anticipated expenses necessary for the orderly transfer of service recipients and changes to the current program to address service recipient needs. The Contractual agreement may be amended as necessary to assure transition requirements are met during the term of this contract. If the transition cannot be concluded during this term, the Department and the Contractor may negotiate an amendment to extend the term of the current contract until the transition may be concluded.

8. <u>Program Cancellation</u> - Where applicable, the cancellation or termination of any individual program or services under this Contract will not, in and of itself, in any way affect the status of any other program or service in effect under this Contract.

9. Mergers and Acquisitions -

- (a) Contracts in whole or in part are not transferable or assignable without the prior written agreement of the Department.
- (b) At least ninety days prior to the effective date of any fundamental changes in corporate status, including merger, acquisition, transfer of assets, and any change in fiduciary responsibility, the Contractor shall provide the Department with written notice of such changes.
- (c) The Contractor shall comply with requests for documentation deemed necessary by the Department to determine whether the Department will provide prior written agreement. The Department shall notify the Contractor of such determination not later than forty-five business days from the date the Department receives such requested documentation.

D. Statutory and Regulatory Compliance

- 1. Health Insurance Portability Act of 1996 ("HIPAA") -
 - (a) If the Contactor is a Business Associate under the requirements of the Health Insurance Portability and Accountability Act of 1996 ("HIPAA"), the Contractor must comply with all terms and conditions of this Section of the Contract. If the Contractor is not a Business Associate under HIPAA, this Section of the Contract does not apply to the Contractor for this Contract.
 - (b) The Contractor is required to safeguard the use, publication and disclosure of information on all applicants for, and all clients who receive, services under the Contract in accordance "with all applicable Federal and state law regarding confidentiality, which includes but is not limited to ("HIPAA"), more specifically with the Privacy and Security Rules at 45 CFR Part 160 and Part 164, subparts A, C, and E and

- (c) The State of Connecticut Department named on page 1 of this Contract (hereinafter "Department") is a "covered entity" as that term is defined in 45 CFR §160.103 and
- (d) The Contractor, on behalf of the Department, performs functions that involve the use or disclosure of "individually identifiable health information," as that term is defined in 45 CFR §160.103 and
- (e) The Contractor is a "business associate" of the Department, as that term is defined in 45 CFR §160.103 and
- (f) The Contractor and the Department agree to the following in order to secure compliance with the HIPAA, more specifically with the Privacy and Security Rules at 45 CFR Part 160 and Part 164, subparts A, C, and E
- (g) Definitions
 - (1) "Business Associate" shall mean the Contractor.
 - (2) "Covered Entity" shall mean the Department of the State of Connecticut named on page 1 of this Contract.
 - (3) "Designated Record Set" shall have the same meaning as the term "designated record set" in 45 CFR §164.501.
 - (4) "Individual" shall have the same meaning as the term "individual" in 45 CFR §160.103 and shall include a person who qualifies as a personal representative as defined in 45 CFR §164.502(g).
 - (5) "Privacy Rule" shall mean the Standards for Privacy of Individually Identifiable Health Information at 45 CFR Part 160 and parts 164, subparts A and E.
 - (6) "Protected Health Information" or "PHI" shall have the same meaning as the term "protected health information" in 45 CFR §160.103, limited to information created or received by the Business Associate from or on behalf of the Covered Entity.
 - (7) "Required by Law" shall have the same meaning as the term "required by law" in 45 CFR §164.103.

- (8) "Secretary" shall mean the Secretary of the Department of Health and Human Services or his designee.
- (9) "More stringent" shall have the same meaning as the term "more stringent" in 45 CFR §160.202.
- (10) "This Section of the Contract" refers to the HIPAA Provisions stated herein, in their entirety.
- (11) "Security Incident" shall have the same meaning as the term "security incident" in 45 CFR §164.304.
- (12) "Security Rule" shall mean the Security Standards for the Protection of Electronic Protected Health Information at 45 CFR Part 160 and parts 164, subpart A and C.
- (h) Obligations and Activities of Business Associates -
 - (1) Business Associate agrees not to use or disclose PHI other than as permitted or required by this Section of the Contract or as Required by Law.
 - (2) Business Associate agrees to use appropriate safeguards to prevent use or disclosure of PHI other than as provided for in this Section of the Contract.
 - (3) Business Associate agrees to use administrative, physical, and technical safeguards that reasonably and appropriately protect the confidentiality, integrity, and availability of electronic protected health information that it creates, receives, maintains, or transmits on behalf of the Covered Entity.
 - (4) Business Associate agrees to mitigate, to the extent practicable, any harmful effect that is known to the Business Associate of a use or disclosure of PHI by Business Associate in violation of this Section of the Contract.
 - (5) Business Associate agrees to report to Covered Entity any use or disclosure of PHI not provided for by this Section of the Contract or any security incident of which it becomes aware.

- (6) Business Associate agrees to insure that any agent, including a subcontractor, to whom it provides PHI received from, or created or received by Business Associate, on behalf of the Covered Entity, agrees to the same restrictions and conditions that apply through this Section of the Contract to Business Associate with respect to such information.
- (7) Business Associate agrees to provide access, at the request of the Covered Entity, and in the time and manner agreed to by the parties, to PHI in a Designated Record Set, to Covered Entity or, as directed by Covered Entity, to an Individual in order to meet the requirements under 45 CFR §164.524.
- (8) Business Associate agrees to make any amendments to PHI in a Designated Record Set that the Covered Entity directs or agrees to make PHI available for amendment pursuant to 45 CFR §164.526 at the request of the Covered Entity, and in the time and manner agreed to by the parties.
- (9) Business Associate agrees to make internal practices, books, and records, including policies and procedures and PHI, relating to the use and disclosure of PHI received from, or created or received by, Business Associate on behalf of Covered Entity, available to Covered Entity or to the Secretary in a time and manner agreed to by the parties or designated by the Secretary, for purposes of the Secretary determining Covered Entity's compliance with the Privacy Rule.
- (10) Business Associate agrees to document such disclosures of PHI and information related to such disclosures as would be required for Covered Entity to respond to a request by an Individual for an accounting of disclosures of PHI in accordance with 45 CFR §164.528.
- (11) Business Associate agrees to provide to Covered Entity, in a time and manner agreed to by the parties, information collected in accordance with paragraph I of this Section of the Contract, to permit Covered Entity to

- respond to a request by an Individual for an accounting of disclosures of PHI in accordance with 45 CFR §164.528.
- (12) Business Associate agrees to comply with any state law that is more stringent than the Privacy Rule.
- (i) Permitted Uses and Disclosure by Business Associate -
 - (1) General Use and Disclosure Provisions Except as otherwise limited in this Section of the Contract, Business Associate may use or disclose PHI to perform functions, activities, or services for, or on behalf of, Covered Entity as specified in this Contract, provided that such use or disclosure would not violate the Privacy Rule if done by Covered Entity or the minimum necessary policies and procedures of the Covered Entity.
 - (2) Specific Use and Disclosure Provisions
 - (A) Except as otherwise limited in this Section of the Contract, Business Associate may use PHI for the proper management and administration of Business Associate or to carry out the legal responsibilities of Business Associate.
 - (B) Except as otherwise limited in this Section of the Contract, Business Associate may disclose PHI for the proper management and administration of Business Associate, provided that disclosures are Required by Law, or Business Associate obtains reasonable assurances from the person to whom the information is disclosed that it will remain confidential and used or further disclosed only as Required by Law or for the purpose for which it was disclosed to the person, and the person notifies Business Associate of any instances of which it is aware in which the confidentiality of the information has been breached.
 - (C) Except as otherwise limited in this Section of the Contract, Business Associate may use PHI to provide Data Aggregation services to Covered Entity as permitted by 45 CFR §164.504(e)(2)(i)(B).

(j) Obligations of Covered Entity -

- (1) Covered Entity shall notify Business Associate of any limitations in its notice of privacy practices of Covered Entity, in accordance with 45 CFR §164.520, or to the extent that such limitation may affect Business Associate's use or disclosure of PHI.
- (2) Covered Entity shall notify Business Associate of any changes in, or revocation of, permission by Individual to use or disclose PHI, to the extent that such changes may affect Business Associate's use or disclosure of PHI.
- (3) Covered Entity shall notify Business Associate of any restriction to the use or disclosure of PHI that Covered Entity has agreed to in accordance with 45 CFR §164.522, to the extent that such restriction may affect Business Associate's use or disclosure of PHI.
- (k) Permissible Requests by Covered Entity Covered Entity shall not request Business Associate to use or disclose PHI in any manner that would not be permissible under the Privacy Rule if done by the Covered Entity, except that Business Associate may use and disclose PHI for data aggregation, and management and administrative activities of Business Associate, as permitted under this Section of the Contract.

(I) <u>Term and Termination</u> -

(1) Term - The Term of this Section of the Contract shall be effective as of the date the Contract is effective and shall terminate when all of the PHI provided by Covered Entity to Business Associate, or created or received by Business Associate on behalf of Covered Entity, is destroyed or returned to Covered Entity, or, if it is infeasible to return or destroy PHI, protections are extended to such information, in accordance with the termination provisions in this Section.

- (2) Termination for Cause upon Covered Entity's knowledge of a material breach by Business Associate, Covered Entity shall either:
 - (A) Provide an opportunity for Business Associate to cure the breach or end the violation and terminate the Contract if Business Associate does not cure the breach or end the violation within the time specified by the Covered Entity or
 - (B) Immediately terminate the Contract if Business Associate has breached a material term of this Section of the Contract and cure is not possible or
 - (C) If neither termination nor cure is feasible, Covered Entity shall report the violation to the Secretary
- (3) Effect of Termination
 - (A) Except as provided in (I)(2) above, upon termination of this Contract, for any reason, Business Associate shall return or destroy all PHI received from Covered Entity, or created or received by Business Associate on behalf of Covered Entity. This provision shall apply to PHI that is in the possession of subcontractors or agents of Business Associate. Business Associate shall retain no copies of the PHI.
 - (B) In the event that Business Associate determines that returning or destroying the PHI is infeasible, Business Associate shall provide to Covered Entity notification of the conditions that make return or destruction infeasible. Upon documentation by Business Associate that return of destruction of PHI is infeasible, Business Associate shall extend the protections of this Section of the Contract to such PHI and limit further uses and disclosures of PHI to those purposes that make return or destruction infeasible, for as long as Business Associate maintains such PHI. Infeasibility of the return or destruction of PHI includes, but is not limited to, requirements under state or Federal law that the

Business Associate maintains or preserves the PHI or copies thereof.

(m) <u>Miscellaneous Provisions</u> -

- (1) Regulatory References A reference in this Section of the Contract to a section in the Privacy Rule means the section as in effect or as amended.
- (2) Amendment The Parties agree to take such action as in necessary to amend this Section of the Contract from time to time as is necessary for Covered Entity to comply with requirements of the Privacy Rule and the Health Insurance Portability and Accountability Act of 1996, Pub. L. No. 104-191.
- (3) <u>Survival</u> The respective rights and obligations of Business Associate shall survive the termination of this Contract.
- (4) Effect on Contract Except as specifically required to implement the purposes of this Section of the Contract, all other terms of the Contract shall remain in force and effect.
- (5) Construction This Section of the Contract shall be construed as broadly as necessary to implement and comply with the Privacy Standard. Any ambiguity in this Section of the Contract shall be resolved in favor of a meaning that complies, and is consistent with, the Privacy Standard.
- (6) <u>Disclaimer</u> Covered Entity makes no warranty or representation that compliance with this Section of the Contract will be adequate or satisfactory for Business Associate's own purposes. Covered Entity shall not be liable to Business Associate for any claim, loss or damage related to or arising from the unauthorized use or disclosure of PHI by Business Associate or any of its officers, directors, employees, Contractors or agents, or any third party to whom Business Associate has disclosed PHI pursuant to this Contract. Business Associate is solely responsible for all decisions made, and actions taken, by Business Associate regarding the

- safeguarding, use and disclosure of PHI within its possession, custody, or control.
- (7) Indemnification The Business Associate shall indemnify and hold the Covered Entity harmless from and against all claims, liabilities, judgments, fines, assessments, penalties, awards, or other expenses, of any kind or nature whatsoever, including, without limitation, attorney's fees, expert witness fees, and costs of investigation, litigation or dispute resolution, relating to or arising out of any violation by the Business Associate and its agents, including subcontractors, of any obligation of Business Associate and its agents, including subcontractors, under this Section of the Contract.
- 2. Americans with Disabilities Act of 1990. This clause applies to those Contractors which are or will come to be responsible for compliance with the terms of the Americans with Disabilities Act of 1990 (42 USC §§12101-12189 and §§12201-12213) (Supp. 1993), 47 USCS §§225, 611 (Supp. 1993). During the term of the Contract, the Contractor represents that it is familiar with the terms of this Act and that it is in compliance with the law. The Contractor warrants that it will hold the state harmless from any liability, which may be imposed upon the state as a result of any failure of the Contractor to be in compliance with this Act. As applicable, the Contractor agrees to abide by provisions of §504 of the Federal Rehabilitation Act of 1973, as amended, 29 USC §794 (Supp. 1993), regarding access to programs and facilities by people with disabilities.
- 3. <u>Utilization of Minority Business Enterprises</u> It is the policy of the state that minority business enterprises should have the maximum opportunity to participate in the performance of government Contracts. The Contractor agrees to use best efforts consistent with 45 CFR §§74.160 et seq. (1992) and paragraph 9 of Appendix G thereto for the administration of programs or activities using HHS funds, and §§13a-95a, 4a-60 to 4a-62, 4b-95(b), and 4a-60q of the Connecticut General Statutes to carry out this policy in the award of any subcontracts.
- 4. <u>Priority Hiring</u> Subject to the Contractor's exclusive right to determine the qualifications for all employment positions, the Contractor shall use its best efforts to ensure that it gives priority to hiring welfare recipients who are subject to time-limited welfare and must find employment. The Contractor and the Department will work cooperatively to determine the number and types of positions to which this paragraph shall apply.

The Department of Social Services regional office staff or staff of Department of Social Service Contractors will undertake to counsel and screen an adequate number of appropriate candidates for positions targeted by the Contractor as suitable for individuals in the time limited welfare program. The success of the Contractor's efforts will be considered when awarding and evaluating Contracts.

5. <u>Non-discrimination Regarding Sexual Orientation</u> - Unless otherwise provided by C.G.S. §46a-81p, the Contractor agrees to the following provisions required pursuant to §4a-60a of the Connecticut General Statutes:

(a)

- (1) The Contractor agrees and warrants that in the performance of the Contract such Contractor will not discriminate or permit discrimination against any person or group of persons on the grounds of sexual orientation, in any manner prohibited by the laws of the United States or of the State of Connecticut, and that employees are treated when employed without regard to their sexual orientation
- (2) The Contractor agrees to provide each labor union or representatives of workers with which such Contractor has a collective bargaining agreement or other Contract or understanding and each vendor with which such Contractor has a Contract or understanding a notice to be provided by the commission on human rights and opportunities advising the labor union or workers' representative of the Contractor's commitments under this section, and to post copies of the notice in conspicuous places available to employees and applicants for employment
- (3) The Contractor agrees to comply with each provision of this section and with each regulation or relevant order issued by said commission pursuant to §46a-56 of the Connecticut General Statutes
- (4) The Contractor agrees to provide the commission on human rights and opportunities with such information requested by the commission, and permit access to pertinent books, records and accounts concerning the

- employment practices and procedures of the Contractor which relate to provisions of this section and §46a-56 of the Connecticut General Statutes
- The Contractor shall include the provisions of subsection (a) of (b) this section in every subcontract or purchase order entered into in order to fulfill any obligation of a Contract with the state and such provisions shall be binding on a subcontractor, vendor or manufacturer unless exempted by regulations or orders of the commission. The Contractor shall take such action with respect to any such subcontract or purchase order as the commission may direct as a means of enforcing such provisions including sanctions for noncompliance in accordance with §46a-56 of the Connecticut General Statutes provided, if such Contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction by the commission, the Contractor may request the State of Connecticut to enter into any such litigation or negotiation prior thereto to protect the interests of the state and the state may so enter.
- 6. Nondiscrimination and Affirmative Action Provisions in Contracts of the State and Political Subdivisions Other Than Municipalities The Contractor agrees to comply with provisions of §4a-60 of the Connecticut General Statutes:
 - (a) Every Contract to which the state or any political subdivision of the state other that a municipality is a party shall contain the following provisions:
 - (1) The Contractor agrees and warrants that in the performance of the Contract such Contractor will not discriminate or permit discrimination against any person or group of persons on the grounds of race, color, religious creed, age, marital status, national origin, ancestry, sex, mental retardation or physical disability, including, but not limited to, blindness, unless it is shown by such Contractor that such disability prevents performance of the work involved, in any manner prohibited by the laws of the United States or of the state of Connecticut. The Contractor further agrees to take affirmative action to insure that applicants with job-related qualifications are employed and that employees are treated when employed without regard to their race,

- color, religious creed, age, marital status, national origin, ancestry, sex, mental retardation, or physical disability, including, but not limited to, blindness, unless it is shown by such Contractor that such disability prevents performance of the work involved
- (2) The Contractor agrees, in all solicitations or advertisements for employees placed by or on behalf of the Contractor, to state that is an "affirmative action-equal opportunity employer" in accordance with regulations adopted by the commission
- (3) the Contractor agrees to provide each labor union or representative of workers with which such Contractor has a collective bargaining agreement or other Contract or understanding and each vendor with which such Contractor has a Contract or understanding, a notice to be provided by the commission advising the labor union or workers' representative of the Contractor's commitments under this section, and to post copies of the notice in conspicuous places available to employees and applicants for employment
- (4) The Contractor agrees to comply with each provision of this section and C.G.S. §§46a-68e and 46a-68f and with each regulation or relevant order issued by said commission pursuant to C.G.S. §§46a-56, 46a-68e and 46a-68f
- (5) the Contractor agrees to provide the commission of human rights and opportunities with such information requested by the commission, and permit access to pertinent books, records and accounts, concerning the employment practices and procedures of the Contractor as relate to the provisions of this section and C.G.S. §46a-56. If the Contract is a public works Contract, the Contractor agrees and warrants that he will make good faith efforts to employ minority business enterprises as subcontractors and suppliers of materials on such public works project.
- (b) For the purposes of this section, "minority business enterprise" means any small Contractor or supplier of materials fifty-one per

cent or more of capital stock, if any, or assets of which is owned by a person or persons:

- (1) Who are active in the daily affairs of the enterprise
- (2) Who have the power to direct the management and policies of the enterprise and
- (3) Who are members of a minority, as such term is defined in subsection (a) of C.G.S. §49-60g
- For the purposes of this section, "good faith" means that degree (c) of diligence that a reasonable person would exercise in the performance of legal duties and obligations. "Good faith efforts" shall include, but not be limited to, those reasonable initial efforts necessary to comply with statutory or regulatory requirements and additional or substituted efforts when it is determined that such initial efforts will not be sufficient to comply with such requirements. Determinations of the Contractor's good faith efforts shall include but shall not be limited to the following factors: The Contractor's employment and subcontracting policies, patterns and practices, affirmative action advertising, recruitment and training, technical assistance activities and such other reasonable activities or efforts as the commission may prescribe that are designed to ensure the participation of minority business enterprises in public works projects.
- (d) The Contractor shall develop and maintain adequate documentation, in a manner prescribed by the commission, of its good faith efforts.
- (e) Contractor shall include the provisions of subsection (a) of this section in every subcontract or purchase order entered into in order to fulfill any obligation of a Contract with the state and such provision shall be binding on a subcontractor, vendor or manufacturer unless exempted by regulations or orders of the commission. The Contractor shall take such action with respect to any such subcontract or purchase order as the commission may direct as a means of enforcing such provisions including sanctions for noncompliance in accordance with C.G.S. §46a-56, provided, if such Contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction by the commission, the Contractor may

request the state of Connecticut to enter into such litigation or negotiation prior thereto to protect the interests of the state and the state may so enter.

- 7. Government Function, Freedom of Information If the amount of this Contract exceeds two million five hundred thousand dollars (\$2,500,000), and the Contract is for the performance of a governmental function, as that term is defined in C.G.S. §1-200(11), the Department is entitled to receive a copy of the records and files related to the Contractor's performance of the governmental function, and may be disclosed by the Department pursuant to the Freedom of Information Act.
- 8. Whistleblowing - This Agreement is subject to the provisions of §4-61dd of the Connecticut General Statutes. In accordance with this statute, if an officer, employee or appointing authority of the Contractor takes or threatens to take any personnel action against any employee of the Contractor in retaliation for such employee's disclosure of information to any employee of the Contracting state or quasi-public agency or the Auditors of Public Accounts or the Attorney General under the provisions of subsection (a) of such statute, the Contractor shall be liable for a civil penalty of not more than five thousand dollars for each offense, up to a maximum of twenty per cent of the value of this Agreement. Each violation shall be a separate and distinct offense and in the case of a continuing violation, each calendar day's continuance of the violation shall be deemed to be a separate and distinct offense. The State may request that the Attorney General bring a civil action in the Superior Court for the Judicial District of Hartford to seek imposition and recovery of such civil penalty. In accordance with subsection (f) of such statute, each large state Contractor, as defined in the statute, shall post a notice of the provisions of the statute relating to large state Contractors in a conspicuous place that is readily available for viewing by the employees of the Contractor.
- 9. <u>Campaign Contribution Restrictions</u> On February 8, 2007, Governor Rell signed into law Public Act 07-1, An Act Concerning the State Contractor Contribution Ban and Gifts to State and Quasi-Public Agencies.

For all State contracts as defined in P.A. 07-1 having a value in a calendar year of \$50,000 or more or a combination or series of such agreements or contracts having a value of \$100,000 or more, the authorized signatory to this Agreement expressly acknowledges receipt of the State Elections Enforcement Commission's notice

10. Dangerous instrument means any instrument, article, or substance that, under the circumstances, is capable of causing death or serious physical injury

- Board shall not have any authority to recommend the termination of a Contract for the sale or purchase of a fee simple interest in real property following transfer of title.

Pursuant to this Executive Order, the contractor shall use cleaning and/or sanitizing products having properties that minimize potential impacts on human health and the environment, consistent with maintaining clean and sanitary facilities.

APPENDIX V - SMOKING POLICY

Connecticut General Statutes

Section 31-40q. Smoking in the workplace: Definitions, employers to establish nonsmoking areas, exemptions.

- a) As used in this section:
 - i. "Person" means one or more individuals, partnerships, associations, corporations, limited liability companies, business trusts, legal representatives, or any organized group of persons.
 - ii. "Employer" means a person engaged in business that has employees including the state and any political subdivision thereof.
 - iii. "Employee" means any person engaged in service to an employer in the business of his employer.
 - iv. "Business facility" means a structurally enclosed location or portion thereof at which twenty or more employees perform services for their employer.
 - v. "Smoking" means the burning of a lighted cigar, cigarette, pipe or any other matter or substance that contains tobacco.
- b) Each employer shall establish one or more work areas, sufficient to accommodate nonsmokers who request to utilize such an area, within each business facility under its control, where smoking is prohibited. The employer shall clearly designate the existence and boundaries of each nonsmoking area by posting signs that can be readily seen by employees and visitors. In the areas within the business facility where smoking is permitted, existing physical barriers and ventilation systems shall be used to the extent practicable to minimize the effect of smoking in adjacent nonsmoking areas. Nothing in this section may be construed to prohibit an employer form designating an entire business facility as a nonsmoking area.
- c) The State Labor Commissioner may exempt any employer from the provisions of this section if the Commissioner finds that (1) the employer made a good-faith effort to comply with the provisions of this section and (2) any further requirement to so comply would constitute an unreasonable financial burden on the employer.

APPENDIX X - NOTICE TO EXECUTIVE BRANCH STATE CONTRACTORS AND PROSPECTIVE STATE CONTRACTORS OF CAMPAIGN CONTRIBUTION AND SOLICITATION BAN

SEEC FORM 11

This notice is provided under the authority of Connecticut General Statutes 9-612(g)(2), as amended by P.A. 07-1, and is for informing state contractors and prospective state contractors of the following law (italicized words are defined below):

Campaign Contribution and Solicitation Ban

No state contractor, prospective state contractor, principal of a state contractor or principal of a prospective state contractor, with regard to a state contract or state contract solicitation with or from a State agency in the Executive Branch or a quasipublic agency or a holder, or principal of a holder of a valid prequalification certificate, shall make a contribution to, or solicit contributions on behalf of (i) an exploratory committee or candidate committee established by a candidate for nomination or election to the office of Governor, Lieutenant Governor, Attorney General, State Comptroller, Secretary of the State or State Treasurer, (ii) a political committee authorized to make contributions or expenditures to or for the benefit of such candidates, or (iii) a party committee.

In addition, no holder or principal of a holder of a valid prequalification certificate, shall make a contribution to, or solicit contributions on behalf of (i) an exploratory committee or candidate committee established by a candidate for nomination or election to the office of State senator or State representative, (ii) a political committee authorized to make contributions or expenditures to or for the benefit of such candidates, or (iii) a party committee.

Duty to Inform

State contractors and prospective state contractors are required to inform their principals of the above prohibitions, as applicable, and the possible penalties and other consequences of any violation thereof.

Penalties for Violations

Contributions or solicitations of contributions made in violation of the above prohibitions may result in the following civil and criminal penalties:

Civil penalties

\$2,000 or twice the amount of the prohibited contribution, whichever is greater, against a principal or a contractor. Any state contractor or prospective state contractor, which fails to make reasonable efforts to comply with the provisions

requiring notice to its principals of these prohibitions and the possible consequences of their violations, may also be subject to civil penalties of \$2,000 or twice the amount of the prohibited contributions made by their principals.

Criminal penalties

Any knowing and willful violation of the prohibition is a Class D felony, which may subject the violator to imprisonment of not more than five years, or \$5,000 in fines, or both.

Contract Consequences

Contributions made or solicited in violation of the above prohibitions may result, in the case of a state contractor, in the contract being voided.

Contributions made or solicited in violation of the above prohibitions, in the case of a prospective state contractor, shall result in the contract described in the state contract solicitation not being awarded to the prospective state contractor, unless the State Elections Enforcement Commission determines that mitigating circumstances exist concerning such violation.

The State will not award any other state contract to anyone found in violation of the above prohibitions for a period of one year after the election for which such contribution is made or solicited, unless the State Elections Enforcement Commission determines that mitigating circumstances exist concerning such violation.
