PROCEDURAL BACKGROUND

On 2014, the Department of Social Services (the "Department") sent 2014, the "Appellant") a Notice of Action ("NOA") denying the application for Medicaid Long Term Care Assistance program for (the "Applicant").

On **Example 1** 2015, the Appellant requested an administrative hearing to contest the Department's decision to deny the Applicant's application for Medicaid.

On , 2015, the Office of Legal Counsel, Regulations, and Administrative Hearings ("OLCRAH") issued a notice scheduling the administrative hearing for , 2015.

On 2015, in accordance with sections 17b-60, 17b-61 and 4-176e to 4-189, inclusive, of the Connecticut General Statutes, OLCRAH held an administrative hearing.

The hearing record remained open for the submission of additional evidence. On , 2015, the hearing record closed.

STATEMENT OF THE ISSUE

The issue to be decided is whether the Department's decision to deny the Applicant's application for Medicaid due to failure to submit information needed to establish eligibility was correct.

FINDINGS OF FACT

- 1. On 2014, the Applicant was admitted to Westside Care Center ('the facility'). (Ex. A: Narrative)
- 2. On **Care**, 2014, the Department received an application for Long Term Care Medicaid assistance for the Applicant which listed the Applicant's son as conservator. (Hearing Record)
- 3. On ______, 2014, the Department sent the Applicant's son a W-1348LTC, Verification We Need form, requesting information needed to determine eligibility. The items requested were: the date of the Applicant's divorce, and if the divorce was within the last five years a copy of the divorce decree; verification of any and all assets held from __/2009current, provide statements for __/09, __/10, and __/12 through current or closure, verification that the property located at has been placed on the market for sale, complete the W-1J Annuity form, and proof that an application has been made on the Applicant's behalf for VA financial assistance. The due date for the requested information was ______, 2014. (Hearing Summary, Ex. B: W-1348LTC, _____/14)
- 4. On 2014 the Appellant was appointed Conservator of Person and Estate for the Applicant by the Probate Court. (Ex. H: Fiduciary's Probate Certificate dated (14)
- 5. On 2014 the Department received a fax from the Appellant with her appointment from the Probate Court as the Applicant's Conservator of Person and Estate and a request for additional time to provide the verifications requested. (Hearing Summary, Ex. G: Fax cover sheet, Ex. H: Fiduciary's Probate Certificate dated 2014 (14)
- 6. On ______, 2014, the Department sent the Appellant the same W-1348LTC, Verification We Need form, again requesting information needed to determine eligibility. The items requested were: the date of the Applicant's divorce, and if the divorce was within the last five years a copy of the divorce decree; verification of any and all assets held from ___/2009current, provide statements for ___/09, ___/10, and ___/12 through current or closure, verification that the property located at

has been placed on the market for sale, complete the W-1J Annuity form, and proof that an application has been made on the Applicant's behalf for VA financial assistance. The new due date for the requested information was 24, 2014. (Hearing Summary, Ex. C: W-1348LTC, /14)

- 7. The Appellant did not submit any of the requested verifications to the Department. (Appellant's testimony)
- 8. The Appellant did not make contact with the Department to request assistance in obtaining verifications or to request additional extensions of time to acquire the information requested. (Appellant's testimony)
- On 2014, the Department denied the Appellant's Long Term Care Medicaid Application for the reason, "You did not return all of the required verification we asked for". (Hearing Summary, Ex. E: Notice of Action dated 2014/14)
- 10. At the hearing on **Example**, 2015 the Appellant provided verification from the Connecticut Judicial Branch regarding foreclosure of the property located at **Example**. (Ex. 4: Connecticut Judicial Branch printout)

CONCLUSIONS OF LAW

- 1. Section 17b-2 and § 17b-260 of the Connecticut General Statutes, authorizes the Department of Social Services to administer the Medicaid program pursuant to Title XIX of the Social Security Act.
- Uniform Policy Manual ("UPM") § 1010.05(A)(1) provides that the assistance unit must supply the Department in an accurate and timely manner as defined by the Department, all pertinent information and verification which the Department requires to determine eligibility and calculate the amount of benefits.
- 3. UPM § 1015.10(A) provides that the Department must inform the assistance unit regarding the eligibility requirements of the programs administered by the Department, and regarding the unit's rights and responsibilities.
- 4. The Department correctly sent to the Appellant application requirements lists requesting information needed to establish eligibility.
- 5. UPM § 1505.35(D)(2) provides that the Department determines eligibility within the standard of promptness for the AFDC, AABD, and MA

programs except when verification needed to establish eligibility is delayed and one of the following is true: the client has good cause for not submitting verification by the deadline, or the client has been granted a 10 day extension to submit verification which has not elapsed.

- 6. UPM § 1505.40(B)(5)(a) provides that for delays due to insufficient verification, regardless of the standard of promptness, no eligibility determination is made when there is insufficient verification to determine eligibility when the following has occurred: 1. the Department has requested verification; and 2. at least one item of verification has been submitted by the assistance unit within a time period designated by the Department but more is needed.
- 7. UPM § 1505.40(B)(5)(b) provides that additional 10 day extensions for submitting verification shall be granted as long as after each subsequent request for verification at least one item of verification is submitted by the assistance unit within each extension period.
- 8. The Appellant failed to submit at least one item of verification within the extension period.
- 9. The Department correctly denied the Appellant's application for failure to submit information needed to establish eligibility.

DISCUSSION

After reviewing the evidence and testimony presented, the Department's action to deny the Appellant's request for Medicaid is upheld.

The Appellant failed to provide any of the requested verifications to the Department before the deadline. The Appellant explained her difficulties in obtaining the information requested as she was newly appointed as Conservator for the Applicant and was not familiar with his case. The Appellant did testify that as an attorney she had access to records through the Connecticut Judicial Branch. The Appellant provided for the hearing information regarding the home property in which she obtained through an online search. While many of the verifications requested may have been difficult to obtain the Appellant did have the means to provide some information to the Department in order to continue the application process.

The Appellant did not request any assistance from the Department in obtaining any of the information requested and did not request any further extensions of time on providing that information. The Appellant is encouraged to reapply on behalf of the Applicant with the information provided at the hearing.

DECISION

The Appellant's appeal is **DENIED**.

RIGHT TO REQUEST RECONSIDERATION

The appellant has the right to file a written reconsideration request within **15** days of the mailing date of the decision on the grounds there was an error of fact or law, new evidence has been discovered or other good cause exists. If the request for reconsideration is granted, the appellant will be notified within 25 days of the request date. No response within 25 days means that the request for reconsideration has been denied. The right to request a reconsideration is based on §4-181a (a) of the Connecticut General Statutes.

Reconsideration requests should include <u>specific</u> grounds for the request: for example, indicate <u>what</u> error of fact or law, <u>what</u> new evidence, or <u>what</u> other good cause exists.

RIGHT TO APPEAL

The appellant has the right to appeal this decision to Superior Court within 45 days of the mailing of this decision, or 45 days after the agency denies a petition for reconsideration of this decision, provided that the petition for reconsideration was filed timely with the Department. The right to appeal is based on §4-183 of the Connecticut General Statutes. To appeal, a petition must be filed at Superior Court. A copy of the petition must be served upon the Office of the Attorney General, 55 Elm Street, Hartford, CT 06106 or the Commissioner of the Department of Social Services, 55 Farmington Avenue Hartford, CT 06105. A copy of the petition must also be served on all parties to the hearing.

The 45 day appeal period may be extended in certain instances if there is good cause. The extension request must be filed with the Commissioner of the Department of Social Services in writing no later than 90 days from the mailing of the decision. Good cause circumstances are evaluated by the Commissioner or the Commissioner's designee in accordance with §17b-61 of the Connecticut General Statutes. The Agency's decision to grant an extension is final and is not subject to review or appeal.

The appeal should be filed with the clerk of the Superior Court in the Judicial District of New Britain or the Judicial District in which the appellant resides.
