### PROCEDURAL BACKGROUND

On 2015, BeneCare Dental Plans ("BeneCare") sent (the "Appellant") a notice of action denying a request for prior
authorization of orthodontia for the child's malocclusion did not meet the medical necessity requirement to approve the proposed treatment.
On 2015, the Appellant requested an administrative hearing to contest the Department's denial of prior authorization of orthodontia.
On 2015, the Office of Legal Counsel, Regulations, and Administrative Hearings ("OLCRAH") issued a notice scheduling the administrative hearing for 2016.
The administrative hearing was rescheduled at the Appellant's request. On 2016, OLCRAH issued a notice scheduling the administrative hearing for 2016
On 2016, in accordance with sections 17b-60, 17b-61 and 4-176e to 4-189, inclusive, of the Connecticut General Statutes, OLCRAH held an administrative hearing. The following individuals were present at the hearing:


### **STATEMENT OF THE ISSUE**

The issue is whether BeneCare's denial of prior authorization through the Medicaid program for orthodontic services was in accordance with state law.

	FINDINGS OF FACT
1.	The Appellant is the grandmother of the child, Testimony) . (Appellant's
2.	is 18 years old (D.O.B/1997) and is a participant in the Medicaid program, as administered by the Department. (Appellant Testimony, Hearing Record, Ex. 2: UCONN School of Dental Medicine's Malocclusion Severity Assessment,/15)
3.	Benecare is the Department of Social Services' (the "Department") contractor for reviewing dental provider's requests for prior authorization of orthodontic treatment. (Hearing Record)
4.	UCONN School of Dental Medicine, Farmington, Connecticut, is treating orthodontist (the "treating orthodontist"). (Hearing Record, Exhibit. 1: Prior Authorization Claim Form, [15]
5.	On 2015, the treating orthodontist requested prior authorization to complete orthodontic services for (Exhibit 1)
6.	On 2015, BeneCare received from the treating orthodontist a Preliminary Handicapping Malocclusion Assessment Record with a score of 26 points, Dental models and Panorex Films of mouth. The treating orthodontist found no presence of other severe deviations affecting the mouth and underlying structures but indicated that the patient has severe anterior crowding plus an anterior cross bite. 7.	On 2015, Dr. Geoffrey Drawbridge, DDS, BeneCare's

panoramic radiographs, and arrived at a score of 21 points on a completed

orthodontic dental consultant, independently reviewed



- 8. On 2015, BeneCare denied the treating orthodontist's request for prior authorization for orthodontic services for the reason that the scoring of mouth was less than the 26 points required for coverage and there is no additional substantial information about the presence of severe deviations affecting the mouth and underlying structures if left untreated would cause irreversible damage to the teeth and underlying structures. (Exhibit. 4: Notice of Action for Denied Services or Goods, 2017)
- 9. On administrative hearing. (Exhibit. 5: Appeal and Administrative Hearing Request Form, 15)
- 10.On 2015, Dr. Robert Gange, DDS, the Department's dental consultant, reviewed models and panoramic radiographs and arrived at a score of 15 points on a completed Preliminary Handicapping Malocclusion Assessment Record. There was no presence of severe deviations affecting the mouth and underlying structures. (Exhibit 8: Preliminary Handicapping Malocclusion Assessment Record, 25)
- 11. On 2016, BeneCare notified the Appellant that orthodontic treatment is not medically necessary for Carbon (Exhibit 9: Letter Regarding Orthodontic Services, 716)
- 12. has a cross bite and some crowding of his anterior teeth. (Exhibit 2, Exhibit 3, Exhibit 8)
- has some difficulty chewing his food properly but no problems swallowing his food. (Appellant's Testimony)
- 14. does not have any infection or pain of the mouth. (Appellant's Testimony)
- 15. receives regular dental care and is in good general health. (Appellant's Testimony)
- 16. has been treated for esophageal reflux and arthritis. (Appellant's Testimony)
- does not receive speech therapy services. (Appellant's Testimony)

18. does not receive counseling services from a licensed psychiatrist or licensed psychologist for issues related to his malocclusion. (Appellant's Testimony)

#### **CONCLUSIONS OF LAW**

- State statute provides that the Department may make such regulations as are necessary to administer the medical assistance program. [Conn. Gen. Stat. §17b-262]
- State regulations provide that orthodontic services for services provided for individuals less than 21 years of age will be paid for when provided by a qualified dentist and deemed medically necessary as described in these regulations. [Conn. Agencies Regs. §17-134d-35(a)]
- 3. State statute provides (a) For purposes of the administration of the medical assistance programs by the Department of Social Services, "medically necessary" and "medical necessity" mean those health services required to prevent, identify, diagnose, treat, rehabilitate or ameliorate an individual's medical condition, including mental illness, or its effects, in order to attain or maintain the individual's achievable health and independent functioning provided such services are: (1) Consistent with generally-accepted standards of medical practice that are defined as standards that are based on (A) credible scientific evidence published in peer-reviewed medical literature that generally recognized by the relevant medical community, recommendations of a physician-specialty society, (C) the views of physicians practicing in relevant clinical areas, and (D) any other relevant factors; (2) clinically appropriate in terms of type, frequency, timing, site, extent and duration and considered effective for the individual's illness, injury or disease: (3) not primarily for the convenience of the individual, the individual's health care provider or other health care providers; (4) not more costly than an alternative service or sequence of services at least as likely to produce equivalent therapeutic or diagnostic results as to the diagnosis or treatment of the individual's illness, injury or disease; and (5) based on an assessment of the individual and his or her medical condition. [Conn. Gen Stat. § 17b-259b]
- 4. Public Act 15-5 (June Sp. Session, Section 390) provides, in relevant part, as follows: The Department of social Services shall cover orthodontic services for a Medicaid recipient under twenty-one years when the Salzmann Handicapping Malocclusion Index Indicates a correctly scored assessment for the Salzmann Handicapping malocclusion Index is less than 26 points, the Department of Social Services shall consider additional substantive information when determining the need for orthodontia services, including (1) documentation of the presences of other severe deviations affecting the oral structures; and (2) the presences of severe mental, emotional or behavioral

problems or disturbances defined in the most current edition of the Diagnostic and Statistical manual of Mental Disorders published by the American Psychiatric Association, that affects the individual's daily functioning

- 5. State regulations provide that the study models submitted for prior authorization must clearly show the occlusal deviations and support the total point score of the preliminary assessment. [Conn. Agencies Regs.§17-134d-35(f)]
- 6. study models submitted for prior authorization do not show severe deviations affecting the mouth and underlying structures; and do not meet the requirement of a 26 point score on the preliminary assessment.
- 7. The Department correctly determined that malocclusion did not meet the criteria for severity, or 26 points, as established in state regulations.
- 8. BeneCare correctly denied the prior authorization request for because he does not meet the medical necessity criteria for orthodontic services, in accordance with state law.

#### **DECISION**

The Appellant's appeal is **DENIED**.

#### RIGHT TO REQUEST RECONSIDERATION

The appellant has the right to file a written reconsideration request within **15** days of the mailing date of the decision on the grounds there was an error of fact or law, new evidence has been discovered or other good cause exists. If the request for reconsideration is granted, the appellant will be notified within 25 days of the request date. No response within 25 days means that the request for reconsideration has been denied. The right to request a reconsideration is based on §4-181a (a) of the Connecticut General Statutes.

Reconsideration requests should include <u>specific</u> grounds for the request: for example, indicate what error of fact or law, what new evidence, or what other good cause exists.

Reconsideration requests should be sent to: Department of Social Services, Director, Office of Administrative Hearings and Appeals, 55 Farmington Avenue Hartford, CT 06105.

#### **RIGHT TO APPEAL**

The appellant has the right to appeal this decision to Superior Court within 45 days of the mailing of this decision, or 45 days after the agency denies a petition for reconsideration of this decision, provided that the petition for reconsideration was filed timely with the Department. The right to appeal is based on §4-183 of the Connecticut General Statutes. To appeal, a petition must be filed at Superior Court. A copy of the petition must be served upon the Office of the Attorney General, 55 Elm Street, Hartford, CT 06106 or the Commissioner of the Department of Social Services, 55 Farmington Avenue Hartford, CT 06105. A copy of the petition must also be served on all parties to the hearing.

The 45 day appeal period may be extended in certain instances if there is good cause. The extension request must be filed with the Commissioner of the Department of Social Services in writing no later than 90 days from the mailing of the decision. Good cause circumstances are evaluated by the Commissioner or the Commissioner's designee in accordance with §17b-61 of the Connecticut General Statutes. The Agency's decision to grant an extension is final and is not subject to review or appeal.

The appeal should be filed with the clerk of the Superior Court in the Judicial District of New Britain or the Judicial District in which the appellant resides.
