#### STATEMENT OF THE ISSUE

The issue to be decided is whether AHCT correctly denied the Appellant's Medicaid/HUSKY A coverage.

#### FINDINGS OF FACT

- 1. The Appellant's household consists of two members that include the Appellant and her minor child. (Exhibit 2: Application # Appellant's Testimony).
- 2. The Appellant files taxes as head of household, her child is tax dependent. (Exhibit 2 and AHCT's summary)
- 3. The Appellant's child is active on Medicaid/Husky A healthcare coverage (Hearing Record, Exhibit 3: Health Care Coverage Renewal AHCT Notice, 16).
- 4. On 2016, the Appellant was granted Transitional Medical Assistance ("TMA") for 12 months, which ended on 2016. (AHCT's Testimony)
- 5. On 2016, the Appellant filed a change reporting application and declared \$29,600 as her yearly income. (Exhibit 2)
- On 2016, AHCT determined that the Appellant no longer qualified for HUSKY A for parents and caretakers healthcare coverage because she was already on Medicaid/Husky A coverage under TMA program. (Hearing Summary and Exhibit 2).
- On 2016, the Appellant spoke with AHCT representative and reported that she works 40 hours a week, @ of \$14.00 an hour, her monthly income equals to \$2,408 (40hours x \$14= \$560 x 4.3). (AHCT Summary and Testimony).
- 5 The monthly Federal Poverty Level ("FPL") for a household of two totaled \$2,069.00 for Medicaid/Husky A for parents and caretakers. The FPL for family of two totaled \$2,683.00 for Medicaid/Husky A for children. (Federal Register)
- 6 The Appellant's child retained eligibility for HUSKY A coverage (Exhibit 3 and AHCT summary).

#### **CONCLUSIONS OF LAW**

- 1. Section 17b-260 of the Connecticut General Statutes ("CGS") provides for acceptance of federal grants for medical assistance. The Commissioner of Social Services is authorized to take advantage of the medical assistance programs provided in Title XIX, entitled "Grants to States for Medical Assistance Programs", contained in the Social Security Amendments of 1965 and may administer the same in accordance with the requirements provided therein, including the waiving, with respect to the amount paid for medical care, of provisions concerning recovery from beneficiaries or their estates, charges and recoveries against legally liable relatives, and liens against property of beneficiaries.
- 2. Section 17b-264 of the CGS provides for the extension of other public assistance provisions. All of the provisions of sections 17b-22, 17b-75 to 17b-77, inclusive, 17b-79 to 17b-83, inclusive, 17b-85 to 17b-103, inclusive, and 17b-600 to 17b-604, inclusive, are extended to the medical assistance program except such provisions as are inconsistent with federal law and regulations governing Title XIX of the Social Security Amendments of 1965 and sections 17b-260 to 17b-262, inclusive, 17b-264 to 17b-285, inclusive, and 17b-357 to 17b-361, inclusive.
- 3. Title 45 of the Code of Federal Regulations ("CFR") § 155.505(c)(1) provides that Exchange eligibility appeals may be conducted by a State Exchange appeals entity or an eligible entity described in paragraph (d) of this section that is designated by the Exchange, if the Exchange establishes an appeals process in accordance with the requirements of this subpart.
- 4. 45 CFR § 155.505(d) provides that appeals process established under this subpart must comply with § 155.110(a).
- 5. 45 CFR § 155.110(a)(2) provides that the State may elect to authorize an Exchange established by the State to enter into an agreement with an eligible entity to carry out one or more responsibilities of the Exchange. Eligible entities are: the State Medicaid agency, or any other State agency that meets the qualification of paragraph (a)(1) of this section.
- 6. 42 CFR § 435.110(b)(c)(2)(i) provides that the agency must provide Medicaid to parents and caretaker relatives whose income is at or below the income standard established by the agency in the State Plan.
- 7. 42 CFR § 435.603 (f) (2)(iii)- pertains to household and provides Basic rule for individuals claimed as a tax dependent. In the case of an individual who expects to be claimed as a tax dependent by another taxpayer for the taxable year in which an initial determination or renewal of eligibility is being made, the household is the household of the taxpayer claiming such individual as a tax

dependent, except that the household must be determined in accordance with paragraph (f)(3) of this section in the case of Individuals under the age specified by the State under paragraph (f)(3)(iv) of this section who expect to be claimed as a tax dependent by a non-custodial parent.

42 CFR § 435.603 (f)(3)(iii)(iv) pertains to the rules for individuals who neither file a tax return nor are claimed as a tax dependent. In the case of individuals who do not expect to file a Federal tax return and do not expect to be claimed as a tax dependent for the taxable year in which an initial determination or renewal of eligibility is being made. Or who are described in paragraph (f)(2)(i), (f)(2)(ii), or (f)(2)(iii) of this section, the household consists of the individual and, if living with the individual –in the case of individuals under the age specified (f)(3)(iv) of this section, the individual's natural, adopted and step parents and natural, adoptive and step siblings under the age specified in (f)(3)(iv) of this section(iv). The age specified in this paragraph is either of the following, as elected by the agency in the State plan—

- (A) Age 19; or
- (B) Age 19 or, in the case of full-time students, age 21
- 8. The Appellant files as Head of Household and claims one tax dependent her child, she has MAGI household of two persons.
- 9. The Appellant's child is tax dependent of the Appellant, child's MAGI household consists of child and the Appellant, he has MAGI household of two persons.
- 10.42 CFR § 435.603(e) provides that MAGI-based income means income calculated using the same financial methodologies used to determine modified adjusted gross income as defined in section 36B(d)(2)(B) of the Code, with the following exceptions-
  - (1) An amount received as a lump sum is counted as income only in the month received.
  - (2) Scholarships, awards, or fellowship grants used for education purposes and not for living expensed are excluded from income.
  - (3) American Indian/Alaska Native exceptions. The following are excluded from income:
    - (i) Distributions from Alaska Native Corporations and Settlement Trusts;
    - (ii) Distributions from any property held in trust, subject to Federal restrictions, located within the most recent boundaries of a prior Federal reservation, or otherwise under the supervision of the Secretary of the Interior;
    - (iii) Distributions and payments from rents, leases, rights of way, royalties, usage rights, or natural resource extraction and harvest from
      - (A) Rights of ownership or possession in any lands described in paragraph (e)(3)(ii) of this section; or

- (B) Federally protected rights regarding off-reservation hunting, fishing, gathering, or usage of natural resources;
- (iv) Distributions resulting from real property ownership interests related to natural resources and improvements
  - (A) Located on or near a reservation or within the most recent boundaries of a prior Federal reservation; or
  - (B) Resulting from the exercise of federally-protected rights relating to such real property ownership interests;
- (v) Payments resulting from ownership interests in or usage rights to items that have unique religious, spiritual, traditional, or cultural significance or rights that support subsistence or a traditional lifestyle according to applicable Tribal Law or custom;
- (vi) Student financial assistance provided under the Bureau of Indian Affairs education programs.
- 11. Title 26 of the Internal Revenue Code ("IRC") section 36B(d)(2)(B) provides that the term "modified adjusted gross income" means adjusted gross income increased by
  - (i) any amount excluded from gross income under section 911,
  - (ii) any amount of interest received or accrued by the taxpayer during the taxable year which is exempt from tax, and
  - (iii) an amount equal to the portion of the taxpayer's social security benefits (as defined in section 86(d)) which is not included in gross income under section 86 for the taxable year.
- 12.42 CFR §435.603(d) provides for the application of the household's modified adjusted gross income ("MAGI"). The household's income is the sum of the MAGI-based income, as defined in paragraph (e) of this section, of every individual included in the individual's household. Effective January 1, 2014, in determining the eligibility of an individual using MAGI-based income, a state must subtract an amount equivalent to 5 percentage points of the Federal Poverty Level for the applicable family size only to determine the eligibility of an individual for medical assistance under the eligibility group with the highest income standard using MAGI-based methodologies in the applicable Title of the Act, but not to determine eligibility for a particular eligibility group.
- 13. Five percent of the FPL for a family of two is \$801.00 ( $\$16,020.00 \times .05$ ) per year which was converted to \$66.75 (\$801.00 / 12) per month.
- 14. The Appellant's household's countable MAGI for a household of two based on the reported income at time of application was \$2,341.25 (\$2408.00 \$66.75) per month.
- 15. Public Act 15-5 June Sp. Session, Section 370 (a) provides in part Except as provided in section 17b-277, as amended by this act, and section 17b-292, as

amended by public act 15-69 and this act, the medical assistance program shall provide coverage to persons under the age of nineteen with household income up to one hundred ninety-six per cent of the federal poverty level without an asset limit and to persons under the age of nineteen, who qualify for coverage under Section 1931 of the Social Security Act, with household income not exceeding one hundred ninety-six per cent of the federal poverty level without an asset limit, and their parents and needy caretaker relatives, who qualify for coverage under Section 1931 of the Social Security Act, with household income not exceeding one hundred fifty per cent of the federal poverty level without an asset limit.

- 16. One hundred fifty percent of the FPL for a household of two is \$2002.50 (\$1335.00 X 1.50) per month.
- 17. One hundred ninety-six percent of the FPL for a household of two is \$2616.60 (\$1335.00 x 1.96).
- 18. The Appellant's countable MAGI household income of \$2341.25 per month exceeds the income threshold for Medicaid/Husky A for Parents and Caretakers for a household of two, \$2002.50.
- 19. The Appellant's child's countable MAGI household income of \$2341.25 per month is under the income threshold for Medicaid for Children for a household of two, \$2616.60
- 20. AHCT was correct to deny Medicaid/Husky A for Parents and caretakers for the Appellant.
- 21. The Department was correct to continue eligibility for the Appellant's child under the Medicaid/HUSKY A for Children.

#### **DISCUSSION**

HUSKY A Medicaid eligibility is based on Modified Adjusted Gross Income. Based on the income reported by the Appellant and calculated by Access Health the Appellant is over income and therefore not eligible for the HUSKY A for parents and caretaker relative.

#### **DECISION**

The Appellant's appeal is **DENIED**.

#### APTC/CSR

#### **Right to Appeal**

For APTC or CSR eligibility determinations, the Appellant has the right to appeal to the United States Department of Health and Human Services (HHS) within 30 days of the date of this decision. To obtain an Appeal Request Form, go to <a href="https://www.healthcare.gov/can-i-appeal-a-marketplace-decision/">https://www.healthcare.gov/can-i-appeal-a-marketplace-decision/</a> or call 1-800-318-2596 (TTY: 1-855-889-4325). HHS will let the Appellant know what it decides within 90 days of the appeal request. There is no right to judicial review of the decision by HHS.

There is no right to request reconsideration for denials or reductions of Advanced Premium Tax Credits (APTC) or Cost Sharing Reduction (CSR).

# MEDICAID AND CHIP Right to Request Reconsideration

For denials or reductions of MAGI Medicaid and CHIP, the appellant has the right to file a written reconsideration request within 15 days of the mailing date of the decision on the grounds there was an error of fact or law, new evidence has been discovered or other good cause exists. If the request for reconsideration is granted, the appellant will be notified within 25 days of the request date. No response within 25 days means that the request for reconsideration has been denied. The right to request a reconsideration is based on §4-181a(a) of the Connecticut General Statutes.

Reconsideration requests should include specific grounds for the request: for example, indicate <u>what</u> error of fact or law, <u>what</u> new evidence, or <u>what</u> other good cause exists.

Reconsideration requests should be sent to: Department of Social Services, Director, Office of Legal Counsel, Regulations, and Administrative Hearings, 55 Farmington Avenue, Hartford, CT 06105-3725.

There is no right to request reconsideration for denials or reductions of Advanced Premium Tax Credits (APTC) or Cost Sharing Reduction (CSR).

# Right to Appeal

For denials, terminations or reductions of MAGI Medicaid and CHIP eligibility, the appellant has the right to appeal this decision to Superior Court within 45 days of the mailing of this decision, or 45 days after the agency denies a petition for reconsideration of this decision, provided that the petition for reconsideration was filed timely with the Department. The right to appeal is based on §4-183 of the Connecticut General Statutes. To appeal, a petition must be filed at Superior Court. A copy of the petition must be served upon the Office of the Attorney General, 55 Elm Street, Hartford, CT 06106 or the Commissioner of the Department of Social Services, 55 Farmington Avenue, Hartford, CT 06105. A copy of the petition must also be served on all parties to the hearing.

The **45** day appeal period may be extended in certain instances if there is good cause. The extension request must be filed with the Commissioner of the Department of Social Services in writing no later than **90** days from the mailing of the decision. Good cause circumstances are evaluated by the Commissioner or his designee in accordance with §17b-61 of the Connecticut General Statutes. The Agency's decision to grant an extension is final and is not subject to review or appeal.

The appeal should be filed with the clerk of the Superior Court in the Judicial District of New Britain or the Judicial District in which the appellant resides.
